- 1. This is to inform you that W.P.No.No. 34241 of 2022 filed by Mahavir Institute of Medical Sciences & another against Union of India & 4 others challenging the action of MARB and NMC issuing impugned proceedings No.M-19011/1/ 2021/NMC/MARB/033710 dt 25-8-2022 and issuance of Impugned notification dated 27-8-2022 by KNRUHS for reallocation of students of 2021-22 batch of the petitioner institution to other colleges and to set-aside the impugned proceedings NO. M-19011/1/2021-NMC/MARB/ also impugned notification dated 27-8-2022.
- 2. Similarly W.P.No.34180 of 2022 filed by TRR Institute of Medical Sciences and another challenging communication of Union of India vide No. V11013/90/2022-ME1 FTS No. 8175852 dated 19-7-2022 rejecting the Second Appeal preferred by the petitioner and to set-aside the same also to set aside the notification dated 27-8-2022 by KNRUHS for reallocation of students of 2021-22 batch of the petitioner institution to other colleges.
- 3. The above two writ petitions came up for hearing on 16-9-2022 and the Hon'ble High Court after hearing the Counsel for the Petitioners and Counsel for the respondents was pleased to dispose of the above two writ petitions by setting aside the impugned orders under challenge with respect the impguned orders passed by MARB, NMC and Union of India and directed the Union of India to consider the matters afresh on par with MNR Medical College which was granted permission for the academic year 2021-22 and 2022-23 within 15 days. The Hon'ble directed the colleges where the students are relocated not to insist for payment of fees till the disposal of the petitioners case by Union of India afresh
