PROSPECTUS FOR ADMISSION INTO POST BASIC B.Sc., NURSING 2 YEARS DEGREE COURSE FOR THE ACADEMIC YEAR 2022-23

1. **REGULATIONS**

- A) These Regulations are applicable for admission in Post BasicB.Sc.,(N) 2 years Degree Course into Competent AuthorityQuota Seats in Government and Private Nursing colleges.
- B) All the Candidates shall fulfill the regulations for admission into Post BasicB.Sc.,(N) 2 years Degree Course for admission into Competent Authority Seats.
- C). The candidates are advised to take a print out of the prospectus / instructions to fill the application form from the website <u>www.knruhs.telangana.gov.in</u> before proceeding to fill the application form.
- D). The Post Basic B.Sc. Nursing Degree Course is 2 years and in Government Colleges is for Women Candidates only. The Seats in Government Colleges are only for Women Government Service Candidates.
- C). The Seat matrix for Competent Authority Quota seats into P.B.B.Sc Nursing 2 YDC Course at Government and Private Colleges for academic year 2022-2023 will be displayed in the KNRUHS website before exercising web options for counseling.
- D). In case any new nursing seats/new colleges are permitted by Authorities for the Academic Year 2021-2022, those seats will also be filled up. NO FURTHER NOTIFICATION WILL BE ISSUED.
- H) In obedience to the orders of Hon'ble High Court, Male candidates are permitted to apply for admission into Nursing colleges only after willingness is issued by Managements of that college to admit Male candidates.

2. ELIGIBILITY

- a. The candidates should be Citizens of India
- b. Only Women Candidates are eligible for admission into Post Basic B.Sc., (N) 2
 Years Course in Government colleges.

c. The candidates have to apply online and upload the original certificates in response to notification to be issued by KNRUHS. The merit rank will be notified afterverification of uploaded certificates by KNR University of Health Sciences, shallbe the basis for selection into Post Basic B.Sc., (n) 2 YDC course into Competent Authority Quota seats.

EDUCATIONAL QUALIFICATIONS:

a. Candidates seeking admission into Post Basic B.Sc.,(Nursing) Course should have passed Intermediate Examination.

0r

Any other equivalent examination (10+2pattern) recognized by the University in Telangana or Board of Intermediate Education Telangana or NIOS, TOSS –Indian Nursing Council Regulations.

Note: The Intermediate (TOSS) Candidates who have qualified in the year 2021 shall be treated as having minimum required percentage of marks at Intermediate level as prescribed by concerned authorities/Deemed to be Universities/other Private Universities recognized by UGC. vide reference: G.O.Ms.No.17 Dated:29.10.2020 and G.O.Ms.No.19 Dated:29.06.2021

&

b. Should have passed **General Nursing and Midwifery** from an institution recognized by the Govt. of Telangana or Nursing Council of India and shall be registered with the State Nursing Council. (Eligibility Criteria is as per G.O.Ms.No.269, HM & FW (K2) Dept., Dt. 30-11-2009 as amended in G.O.Ms.No.194, HM & FW (K2) Dept., Dt.07-07-2011, G.O.Ms.No.40, HM &FW (K2) Dept., Dt: 18-02-2012 and orders issued by Government of Telangana from time to time.

c. Government Service Candidates: Only Female candidates who have completed 2 years of regular service as a staff nurse in Medical and Health Department/Telangana Vaidya Vidhana Parishad as on **31.07.2022** are eligible. Service certificate as a staff nurse should be enclosed issued by the respective employer (DPH/DME/Commissioner, VVP etc.) and must be a regular employee. Service Certificate, regularization orders as staff nurse should been closed. d. Age: Candidate should have completed 21 years of age and should not be more than 45 years of age as on 31st December, 2022. In case of SC/ST/BC Candidates the maximum age shall be relaxed by 3 years.

Note:

- Candidates born on or after 02-01-2002 are not eligible as they do not complete 21 years of age.
- 2. Candidates born on or before **31-12-1977** are not eligible as they are over aged and in case of SC/ST/BC candidates born on or before 31-12-1974 are not eligible.
- 3. A person born on 1st January of a year will complete one year on 31st December of the same year.
- 4. Age shall be calculated on the basis of date of birth as indicated in the Secondary School Certificate examination or equivalent examination.
- 5. No request for relaxation of age of a candidate shall be entertained.

3. CATEGORIZATION OF SEATS:

- As per G.O.Ms.NO.330, HM&FW (K1) Department, dt.11-11-2011, in Private institutions Sixty percent (60%) of the total number of seats shall be filled as competent authority seats by university.
- 2. Forty percent (40%) seats shall be filled as management seats by the Managements of Private Colleges.
- 3. In respect of the Government colleges 100% Nursing seats shall be Competent authority, will be filled by the University.

4. RESERVATION OF SEATS FOR SCHEDULED CASTES & SCHEDULED TRIBES.

- a. Out of the total seats under Competent Authority Quota 15% are reserved for SC category candidates and 6% are reserved for ST category candidates. If any seat reserved for the Scheduled Tribes is not filled up they will be open to the candidates belonging to Scheduled Castes and Vice-Versa.
- b. If the candidates from Scheduled Castes & Scheduled Tribes are not available these reserved seats shall be converted to open category seats and allotted on the basis of merit.

c. Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to Telangana State for castes which are notified in the list as per the Telangana Government orders will be considered against the reserved seats.

5.RESERVATION FOR BC CANDIDATES:

a) 29% of the total seats under Competent Authority Quota shall be reserved for candidates belonging to Backward Classes and shall be allotted among the five sub-groups of Back Ward Classes as follows:-

BC-A-7%, BC-B-10%, BC-C-1%, BC-D-7% and BC-E-4%.

- b) Candidates who belong to the notified Backward Class castes of the States of Telangana which are listed in the Government orders shall be considered for reservations.
 - i. If eligible candidates belonging to Backward Classes of a particular sub-group are not available, the left over seats can be allotted to the candidates of next subgroup ie., BC A to BC B to BC C to BC D to BC E.
 - ii. If eligible candidates of Back Ward Classes category are not available for the 29% seats reserved for them, the left over seats shall be converted to open category seats and shall be allotted as open category seats on the basis of merit.
- c) While calculating the number of seats in the sub-groups if the total number of seats falls short of or exceeds 29% it shall be limited to 29% by adding or eliminating the candidates on the basis of merit in the sub- groups in which the fractions were rounded to nearest figure.
 - a. **CERTIFICATION OF CASTE**:
 - i. Scheduled Caste, Scheduled Tribe and Backward class candidates shall in support of their claim, have to furnish Permanent caste certificate issued by the competent authority of Government of Telangana.
 - ii. The social status of the candidates who have applied for the seats reserved for Scheduled Castes, Scheduled Tribes and Backward Classes shall be scrutinized as per the rules notified by the concerned department officials of Government of Telangana.

- iii. The decision of the verification officer deputed by the Director / Commissioner of BC Welfare, SC Welfare and ST Welfare from the Government of Telangana is final in all respects.
- iv. Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to Telangana State for castes which are notified as per the Telangana State Government orders will be considered against the reserved seats.

6. **RESERVATION FOR WOMEN CANDIDATES;**

33 1/3% of seats are guaranteed for women candidates in each category i.e., Open category, Scheduled Castes, Scheduled Tribe, Backward Classes Group A, B, C, D and E. This regulation of guarantee shall not be applicable if women candidates selected on merit in each category form 33 1/3% or more of the seats therein. When the number of women candidates falls short of this percentage, it would be made up by replacing the last selected male candidates by women candidates in that category.

7. RESERVATION UNDER PWD CATEGORY:

5% of total seats in each categories shall be reserved for the Persons with disabilities (PWD) i.e., OC, SC, ST, BC-A, BC-B, BC-C, BC-D and BC-E categories as per Government of India guidelines.

The candidate seeking the benefit of reservation should present him/herself before a Medical Board constituted by the University, comprising professors from Government Medical colleges from relevant specialties. The decision of the Medical Board constituted by the University is final.

8. **RESERVATION FOR LOCAL CANDIDATES:**

i) 85% of the seats shall be reserved for local candidates and remaining 15% seats are unreserved seats

1. DEFINITION OF LOCAL AREAS

 a) The part of the state comprising the districts of Adilabad, Hyderabad, (including twin cities), Ranga Reddy, Khammam, Karimnagar, Medak, Mahaboobnagar, Nalgonda, Nizamabad and Warangal shall be regarded as the <u>Osmania University Area</u>.

- b) The part of the State comprising the districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as <u>Andhra</u> <u>University Area.</u>
- c) The part of the State comprising the districts of Anantapur, Kurnool, Chittoor, Cuddapah and Nellore shall be regarded as <u>Sri Venkateswara University Area.</u>

NOTE: Candidates defined under 9. b, c are treated as Non-local candidates.

9.2. DEFINITION OF LOCAL CANDIDATES

- 1. A candidate for admission shall be regarded as a local candidate in relation to a local area.
 - a) If he / she has studied in educational institution or educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he/she appeared or as the case may be, first appeared in the relevant Qualifying Examination.

b) Where during the whole or any part of the four consecutive academic years ending with the academic year in which he/she appeared or as the case may be, first appeared for Intermediate Examination, he/she has not studied in any educational institution, if has resided in the local area for a period of not less than four years immediately preceding the date of commencement of relevant examination in which he/she appeared, or as the case may be, first appeared then he/she becomes a local candidate.

- 2. A candidate for admission to the course who is not regarded as a local candidate under sub regulation 9.2 above in relation to any local area shall
 - a) If he/she has studied in educational institutions in the State for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared or as the case may be ,first appeared for the relevant qualifying examination be regarded as a local candidate in relation to.
 - i) Such local area where he/she has studied for the maximum period out of said period of seven years.
 - ii) Where the periods of his/her equal, such local area where periods study in two or more local areas are he/she has studied last in such equal.

- b) If, during the whole or any part of seven consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in the educational institutions in any local area, but has resided in the State during the whole of the said period of seven years, be regarded as local candidate in relation to
- i) Such local area where he/she has resided for the maximum period out of the said period of seven years.
- ii) Where the periods of his/her residence in two or more local areas are equal such local area where he/she has resided last in such equal periods

3. EXPLANATION - FOR PURPOSE OF THIS SUB REGULATION.

- a) "Educational Institution" means a college, a school imparting education up to and inclusive of tenth class, or other institutions by whatever name called whether managed by Government, Private body, local authority or University and carrying on the activity of imparting education there in whether technical or otherwise and includes a Polytechnic, Industrial training Institute and a Teachers Training Institute but does not include a Tutorial Institution.
- b) Relevant qualifying examination for admission into B.Sc., Nursing 4year's degree course of study means a pass in the examination, which is the minimum educational qualification for admission to such course of study.
 - **Note**: The relevant qualifying examination for admission to B.Sc., Nursing degree course being Intermediate or its equivalent examination, the question whether candidate is a local candidate or not will be determined with reference to the first appearance in the Intermediate examination or equivalent examination even in the case of an applicant is possessing B.Sc or M.Sc. Degree.
- a) In reckoning the consecutive academic years during which a candidate has studied, any period of interruption of his/her study by reason of her failure to pass any examination, and
 - b) Any period of his/her study in a State-wide University or State wide Educational Institution shall be disregarded.

- d) The question whether any candidate for admission to any course of Study has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of her parent or guardian.
- e) While determining the number of seats to be reserved in favour of local candidates under regulation 8(i) any fraction of a seat shall be counted as one Provided there shall be one Unreserved Seat.

If a local candidate in respect of a local area is not available to fill any seat reserved or allocated in favour of a local candidate in respect of that local area, such seat shall be filled in as if it has not been reserved.

- f) Applicants who claim to be local candidates with reference to regulation.
 - 1. Shall produce evidence in the form of study certificate/certificates issued by the Heads of Educational Institution/Institutions concerned, indicating the details of the year or years in which the candidate has studied in educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic years in which he/she appeared or as the case may be, first appeared for the Intermediate examination or its equivalent. Those who do not qualify as local candidates under sub regulation.
 - but claim to qualify by virtue of residence under regulation above shall produce a certificate issued by an officer of the Revenue Department not below the rank of a Mandal Revenue Officer in the form annexed in G.O.Ms.No.628 Education, dated 25th July,1974,(appended to the application)
 - 3. Applicants who claim to be local Candidates under regulation above shall produce evidence in the form of study certificate issued by the heads of the Educational Institution/Institutions concerned indicating the details of the year or years in which the candidate has studied in the respective educational Institutions for a period of not less than seven consecutive academic years ending with the academic year in which he/she appeared, or as the case may be first appeared for the Intermediate Examination or its equivalent. Those who do not qualify as local

candidate under the regulation 9.2.1 but claim to qualify by virtue of residence under regulation 9.2.2 shall produce a certificate of residence issued by an officer of the Revenue Department not below the rank of Mandal Revenue Officer in the form similar to that Annexed to G.O.Ms.No.628, Education, dated 25th July 1974 with necessary modifications (appended to the application).

iii. UNRESERVED SEATS

The following categories of candidates are eligible to apply for admission to the 15% of unreserved seats:

All candidates defined under regulation 9.2

Candidates who have resided in the State for a total period of ten years excluding period of study outside the State or either of whose parents have resided in the State for a period of ten years excluding periods of Employment outside the State (Certificate to the effect from a Revenue Official not below the rank of Mandal Revenue Officer from where the candidate is claiming eligibility should be enclosed).

Candidates who are children of parents who are in the employment of this state or Central Government, Public Sector Corporations, Local Bodies, Universities and other similar quasi-public Institutions within the State. (Certificate from the Head of the Institution/Department should be enclosed).

Candidates who are spouses of those in the employment of this State or Central Government, Public Sector Corporations, Local Bodies, University and Educational Institutions recognized by the Government, a University or other competent authority and similar other quasi Government institutions within the state. (Certificate from the Head of Institution/Department should be enclosed).

- 2. The candidate should fill the online application form available in the Website with the data required for through computer or Laptops. The online application form can

be filled through any computer with internet connection or Laptops.

3. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) and ready to enter his/her correct data and upload the photo, signature and original certificates, after the payment of application fee through Online.

11. MERIT LISTS:

THE PROVISIONAL FINAL MERIT POSITION OF APPLIED CANDIDATES FOR COMPETENT AUTHORITY QUOTA SEATS SHALL BE NOTIFIED AFTER VERIFICATION OF UPLOADED CERTIFICATES.

The Final merit list shall be prepared by the Under Graduate Admission Committee appointed by University subject to these regulations.

The criteria for preparation of merit list (P.B.B.Sc. NURSING COURSE)

- a. In case of equality of marks in GNM, the total percentage of marks secured in intermediate shall be given higher place.
- b. In case of equality of marks in GNM and intermediate, the age shall be taken into consideration and the elder candidate shall be given higher place in the merit list.
- c. The University will release provisional final merit list of eligible candidates for exercising web options after verification of uploaded original certificates by the University and officials of concerned departments.

NOTE: CANDIDATES WHO HAVE APPLIED ONLINE IN RESPONSE TO THIS OFFICE NOTIFICATION FOR DERTERMINING MERIT POSITION FOR COMPETENT AUTHORITY QUOTA SEATS SHALL UPLOAD THE ORIGINAL CERTIFICATES ONLINE ALONG WITH THE APPLICATION. AFTER VERIFICATION OF UPLOADED ONLINE CERTIFICATES PROVISIONAL FINAL MERIT LIST IS NOTIFIED FOR COUNSELING.

12. COUNSELING

i. Provisional Final merit list will be displayed on KNRUHS website after scrutiny of uploaded certificates and application. Verification of uploaded certificates will be done only once for web based counseling irrespective of number of phases of exercising web based options and counselings. Hence, candidates who have applied on-line are advised to upload all original certificates at the time of online registration without fail for scrutiny by concerned Departmental officials. No individual communications will be sent. The notification for schedule for exercising web options will be issued separately on KNRUHS website. Candidates are informed to check the website regularly for notifications.

- ii. On-line application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position.
- iii. The Admission Committee shall have power to review the selection in case of any errors, misrepresentation or glaring injustice and cancel the selection/admission. In all matters relating to selection and admissions, the decision of the Admission Committee shall be final and binding on the candidates and selections cannot be questioned after admissions are closed.

13. PROCEDURE OF SELECTION:

- i. Selection will be made by the Admission Committee appointed by the Vice-Chancellor, KNR University of Health Sciences based on the web-options given by the candidates and their merit.
- Selections shall be made local area wise as per the procedure prescribed in Annexure-III of G.O.P.No.646,Education (W) Dept. dated 10-7-1979, as amended in G.O.Ms.No.42, Higher Education (EC2) Dept., dated18-05-2009.
- iii. The Admission Committee will allot a candidate seats to the Nursing College based on their web-options and merit.
- iv. Selected candidates will receive the allotment message on the registered mobile number after allotment of seat. Candidates are directed to check the website for allotment list after exercising web-options
- v. Selected candidates have to download the allotment order on payment of **University fee of Rs. 6,000/- (Rupees Six thousand only)** besides payment gateway charges through payment gateway and report to the Principal of concerned college along with all Original Certificates and pay the tuition fee as fixed by Government at the college to complete the admission process or fee notified by the Government of Telangana from time to time.

14. ADMISSION RULES

- a. The letter of allotment for admission of selected candidate will have to be downloaded from website after payment of University fee by payment gateway.
- b. The candidate should submit the print-out of the filled-in Online application form, allotment order and original certificates along with (1) set of self attested copies to the Principal of allotted college at the time of joining for final verification by the Admission Committee constituted at each college. The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
- **15.** Selected candidates have to join the college within the specified date by submitting all Original Certificates, Bond, and pay the tuition fee as fixed by the Government to complete the process of admission. If the candidate does not report within the specified time and complete the process as described before the admission will be automatically cancelled.
- **16. COMMENCEMENT OF THE COURSE: The course shall commence as per the schedule notified by Indian Nursing Council.** The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.
- **17. COLLEGE REGULATIONS:** Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Candidates are informed that their correspondence with the university shall be forwarded by the Principal of college with his remarks. (through proper channel) for consideration. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal

18. CLOSURE OF ADMISSIONS:

The admissions shall be closed as per the schedule notified by the University as per INC Regulations.

Any vacancy after the date of closure of admissions shall not be filled. They will not be carried forward to the next year as per the directions of Hon'ble Supreme Court of India.

19. POWERS OF THE PRINCIPAL OF THE INSTITUTION: (COMMON FOR ALL ADMISSIONS UNDER KNRUHS)

Not withstanding anything contained in these Regulations, the Head of the Institution may at anytime, either su-moto or an application made by any person after due and proper enquiry, if satisfied that the candidate has furnished incorrect information or enclosed false certificates or fraudulently obtained admission may for the reasons to be recorded in writing, by order cancel her admission provided that no such admission shall be cancelled without giving a reasonable opportunity for showing cause as to why his/her admission should not be cancelled.

Against any such order of the Head of the Institution, an appeal can be made to the Registrar, KNR University Health Sciences.

20. POWERS OF KNR UNIVERSITY OF HEALTH SCIENCES:

The University may either su-moto or on an application made to University can call for and examine the records relating to any selection or admission or cancellation thereof made by the concerned authority for the purpose of verifying the correctness, legality or proprietary of such selection or admission or cancellation and pass such order in relation there to as KNRUHS deems fit, including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation.

21. UNIVERSITY IS THE FINAL AUTHORITY OF SELECTION PROCEDURE:

All selections made under these regulations shall be subject to such directions or orders as may be made by the University from time to time.

22. REGULATION FOR BREAK-UP STUDY:

If a student absents continuously for a period of 91 days or more and seeks permission to attend the course, his / her application must be in prescribed format by paying requisite fee for readmissions is Rs.7000/- (for Processing Fee : Rs: 2000/-Re-admission /Break of study fee :Rs: 5000/- the fee has to be paid in favour of Registrar, KNR University of Health Sciences payable at Warangal shall be forwarded to the Registrar, KNR University of Health Sciences with the recommendation of the Principal. Regulations for readmission after break of study along with application format and fee payable is available in the University. The candidates are advised to refer the regulations before submitting the application and paying the fee. If they fulfilled the regulatory conditions, they may submit applications through the Principal of the College by paying the fee.

23. TIME FOR COMPLETION OF COURSE:

Candidate should complete the course within the duration equivalent to double the period of course of study .i.e., **4 years for P.B B.Sc 2YDC**.

24. MIGRATION/TRANSFER:

No Transfers during the course period are permitted from one college to another college under any circumstances.

25. Discipline:

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University either before the print or electronic media. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities/ INC/Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.

26. Ragging:

Ragging is prohibited in the Educational Institutions of State of Telangana and students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per law.
