A. **Regulations**:

The following are the Regulations for admission of students into Management Quota (Category -B and Category -C (NRI)) MBBS / BDS Courses in Private Un – Aided Non – Minority/Minority Medical and Non - Minority Dental Colleges including Army Dental College in the state of Telangana for the year 2022-23.

- i) The candidate should have qualified in NEET UG 2022 exam by securing marks of cut off score and above.
- ii) NEET UG 2022 merit ranks shall be the basis for the selection into MBBS and BDS Courses subject to these regulations.
- iii) The number of MBBS/BDS seats for the academic year 2022-2023 will be as permitted by NMC/DCI and notified before counseling. Tuition Fee will be as notified by the State Government
- iv) In case any new MBBS/BDS seats are permitted by MCI/DCI in private Medical and Dental colleges affiliated to the University for the Academic Year 2022-23, those seats also will be filled up. NO FURTHER NOTIFICATION WILL BE ISSUED.
- <u>v)</u> Seats in Army Dental College are reserved for Army wards as per AWES Regulations.
- <u>vi)</u> Seats in Un-aided Minority Medical Colleges are reserved for Muslim Minority Candidates only. In case Muslim Minority Candidates are not available the seats may be filled up with Non- Minority students up to maximum of 30% during Mopup Phase of counseling.
- vii) The seat matrix for Management Quota seats for academic year i.e., 2022- 23 will be displayed in the KNRUHS website before exercising web options for counseling.

- viii) 85% of the seats under Management Quota Category B for MBBS/BDS Courses are reserved for local candidates from Telangana state in accordance with GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022. The remaining 15% of the seats are open to candidates from all over the country along with local candidates.
- <u>ix</u>) Candidates from all over the country are eligible for admission into Management quota seats Category C (NRI) for MBBS/BDS Courses.
- x) Foreign Students / NRI candidates/ OCI card holders are eligible for admission into MBBS and BDS Courses under Management Quota Category C Seats. Candidates should specifically put the option for NRI Category in the on-lineapplication to be considered for NRI / C-Category.

B. Eligibility:

The candidates who fulfill the following criteria are eligible for admission into MBBS/BDS courses.

- i) The candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology)/ Biotechnology and English.
 - a) OC candidates should obtain not less than 50% marks in science subjects.
 - b) BC/SC/ST candidates should obtain not less than 40% marks in science subjects.
- ii) Candidates should have qualified at NEET UG 2022
- iii) The candidates should secure the following cut-off scores in NEET UG-2022 conducted by CBSE, New Delhi for the year 2022-23.

General category (Including EWS)	50 th Percentile	117	Candidates scoring equal to or more than this cut-off score have been declared as qualified.
SC/ST/BC &Persons with disabilities of SC/ST/BC.	40 th Percentile	93	SC/ST/BC candidates scoring equal to or more than this cut-off score have been declared as qualified.
Persons with Disability (OC PWD)	45 th Percentile	105	OC-PWD candidates scoring equal to or more than this cut-off score have been declared as qualified.

Lower percentage / percentile of marks for SC/ST/BC/PWD is only for cutoff score for eligibility.

Candidates have to apply online and upload the original certificates for online verification and for inclusion in merit list for Management Quota seats in colleges affiliated to Kaloji Narayana Rao University of Health Sciences, Telangana, Warangal

- *Candidates who have already applied for Competent Authority Quota Seats in response to this University earlier notification are also eligible to apply for the Management Quota seats, but they have to apply afresh.
- ix) Candidates possessing qualification of the University / Board of an institution outside the Telangana State should submit Eligibility / Equivalence certificate from the Board of Intermediate Education of Telangana, to the effect that the qualification possessed is equivalent to or higher than Intermediate examination conducted by the Board of Intermediate Education of Telangana at the time of admission into the college.
- candidates possessing qualification of the University / Board of an institution outside INDIA should submit Eligibility / Equivalence certificate issued by Association of Indian Universities, New Delhi and Eligibility/ Equivalence certificate issued from the Board of Intermediate Education of Telangana to the effect that the qualification possessed is equivalent to or higher than Intermediate examination conducted by the Board of Intermediate Education of Telangana at the time of admission into the college.

C. AGE:

The candidate should have completed 17 years of age as on 31-12-2022. The candidates who do not complete 17 years as on 31-12-2022 are not eligible to apply. The candidates born on or after 02-01-2006 are not eligible for admission into MBBS/BDS Courses.

D. NRI Quota eligibility:

i) Admission to NRI seats will be made on the basis of NEET-UG-2022 ranks of candidates eligible for NRI quota and registered online.

- ii) NRI Financially supporting the candidate must be a blood relative such as Father/ Mother/ Brother/Sister/ Uncle/ Aunt only and should submit a declaration to that effect.
- <u>iii)</u> Candidate opting for NRI seat must furnish the photocopies of following supporting documents.
 - 1 NRI status certificate of the financial supporter issued by embassy of respective country under their seal.
 - 2) Copy of NRI Bank account pass book of the financial supporter.
 - 3) Copy of Pass port of NRI financial supporter.
 - Note: a) If, enough number of NRI candidates are not available, the left over seats of NRI Category may be filled-up with willing candidates of Management Quota merit list during the final phase of counseling. Candidates are informed that the same fee of NRI category is applicable for these seats.
 - b) If a candidate is found to have submitted false information or concealed any relevant information regarding this matter, such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be taken by the University.
- iv) OCI/PIO candidate, shall upload citizenship card as proof.

Note:

- i. If a candidate is found to have submitted false information or concealed any relevant information regarding this matter, such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be taken by the University/respective institution. Legal issues if any shall be under the High Court of Judicature at Hyderabad for the State of Telangana.
- ii. The registration fee and processing fee once paid will not be refunded or adjusted to a future date. Therefore candidates are advised to check eligibility conditions thoroughly before applying for determining merit.
- iii. Candidate should clearly specify in the on-line application whether he is opting for B-Category or C- Category (NRI) or both B & C Categories of Management Quota.

- **iv.** The Original Certificates submitted by the admitted candidates who withdraw from the Course, before the second phase of counseling will be returned without penalty.
- v. Candidates are informed that as per Hon'ble Supreme Court orders and MCC/DGHS, Ministry of Health Government of India notice no. U-12021/01/2022-MEC, dated. 12.07.2022 and in accordance with GO.Ms.No. 109 HM & FW Department, dated. 22.08.2022, admitted candidates are not permitted to withdraw from the course after second phase of counseling. Candidates are also informed that admitted candidates who have joined upto round 2 shall not be eligible for further rounds of All India Quota, Management Quota and State Quota.
- vi. Vacant seats after each round of counseling will be filled up in subsequent rounds of counseling. The date and time of Counseling will be notified by the on KNR UHS web- site.

E. ONLINE APPLICATIONS:

a) The on-line application form for determining merit position in respective categories for Management Quota seats using NEET UG – 2022 scores will be available on the website https://tspvtmedadm.tsche.in/ from 10.00 AM on 20-10-2022 to 5.00 PM on 27-10-2022.

Note: The candidates are advised to take a print out of the Prospectus / Instructions to fill the application from the website http://www.knruhs.telangana.gov.in or https://tspvtmedadm.tsche.in/ before proceeding to fill the application form.

b) The candidate should fill the online application form available in the Website and upload all necessary certificates with the data required for through Computer. The online application form can be filled through any computer with Internet connection. The candidate is advised to fill the online application form after going

through the Prospectus by keeping all the Certificates, scanned Photo and Signature in the jpg/.gif format separately (as shown below) (step-1) and ready to enter his/her correct data and upload the certificates, photo and signature after the payment of application fee through Online.

F. Registration and Processing Fee:

Registration and Processing fee Rs. 6300/- (Rupees Six Thousand Three hundreds only) **Bank transaction charges extra shall be paid online through Debit card / Credit card or Net Banking.**

** **Registration and Processing fee once paid will not be refunded or adjusted to a further date. The candidates are advised to download and read the Prospectus of the course to verify for eligibility under local/non local category

- (i) Equivalency Certificate from Board of intermediate education government of Telangana (If Passed qualifying exam other than AP/TS/CBSC/ICSE).
- (j) The fee can be paid through Debit card / Credit card or Net Banking.
- (k) The fee paid by the applicants is not refundable and not adjusted to a future date under any circumstances

H. Penal action:

i. Candidates will not be permitted to withdraw from the course after the second phase of counseling. Candidates who have joined the course are not permitted to withdraw from the course after second phase of counseling. If Candidates want to discontinue the course after second phase of counseling they have to pay discontinuation fee of Rs. 20,00,000/- (Rupees twenty Lakhs only) to the University and will also be debarred for three years from admissions in to the same course under KNRUHS.

I. MERIT LISTS:

The provisional final merit position of the candidates who have applied online in response to the notification issued by KNRUHS for Management Quota seats shall be determined as per NEET-UG-2022 scores and as per their eligibility criteria, applicable reservations, regulations, guidelines viz:

- i As per UG Medical Regulations of MCI/NMC, the candidates who secure minimum of marks at 50th percentile (40th percentile for SC/ST/BC candidates in NEET UG 2022 are eligible for admission into Medical and Dental Courses.
- The University will notify provisional final merit list of eligible candidates for exercising web options after verification of uploaded original certificates by the University and issue schedule for counseling.
- THERE ARE NO RESERVATIONS FOR SC / ST, BC IN ALL THE CATEGORIES OF THE MANAGEMENT QUOTA SEATS.
- 85% OF SEATS IN MANAGEMENT QUOTA B CATEGORY ARE RESERVED FOR LOCAL CANDIDATES OF TELANGANA STATE
- MINORITY MEDICAL COLLEGES SEATS WILL BE FILLED WITH MUSLIM MINORITY CATEGORY CANDIDATES ONLY.
- IN CASE, MUSLIM MINORITY CANDIDATES ARE NOT AVAILABLE TO TAKE THE SEATS, THEY WILL BE ALLOTTED TO NON-MINORITY STUDENTS IN THE LAST PHASE OF COUNSELING

I. <u>Fee Structure</u>:

<u>i)</u> **University Fee:** Allotted candidates have to pay non – refundable University fee through payment gate way for downloading the allotment order, as given below.

<u>ii)</u> <u>Tuition fee</u>: to be paid as notified by the Government of Telangana

Note –1: The candidates selected against Management Quota Category-B & C (NRI Quota) Seats shall pay the tuition fee as notified for Management Quota seat on the day of reporting in the form of Demand Draft in the name of the Principal of the respective college on the day of admission to the college. If the candidate fails to pay the tuition fee within the specified time of joining, the admission will be cancelled automatically.

K. Powers of the Admission Committee:

The Admission Committee shall have the power to revise its decision in any case and to direct the Principal concerned to take further action either to select or to cancel the selection, or to admit or cancel the admission before the closure of admissions. Selections shall not be questioned after closure of admissions.

L. ADMISSION RULES

The letter of allotment for admission of selected candidate will have to be downloaded from website after payment of University fee by payment gateway.

The candidate should submit the print-out of the filled-in Online application form, allotment order and original certificates along with (1) set of self attested copies to the Principal of allotted college at the time of joining for final verification by the Admission Committee constituted at each college.

The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.

Undertaking in the form of Affidavit on Rs. 100 /- Non-Judicial Stamp paper by the Parent and candidate stating that all the certificates including the caste and category certificates are genuine and they are responsible for any further consequences as per law shall be submitted at the time admission. If any discrepancy is noticed, the admission will be cancelled.

Selected candidates have to join the college within the specified date by submitting all Original Certificates, Bonds, and pay the tuition fee as notified by the Government to complete the process of admission. If the candidate does not report at the allotted the college within the specified time and complete the process as described above, the admission will be automatically cancelled.

M. POWERS OF PRINCIPALS:

Not withstanding anything contained in these regulations, the Principals of Medical Colleges in the State may at any time before completion of the Under Graduate course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit a written explanation and or on a personal hearing, order the cancellation of admission to the course, if in his opinion, such candidate had furnished incorrect particulars or false information in the application form or in the documents attached thereto or in the Statements made either before the authority In-charge of admissions or the Principal or any other manner. Against any such order of the Principal, an appeal shall lie to the Registrar, KNR University of Health Sciences, Telangana.

N. COLLEGE REGULATIONS: Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Candidates are informed that their correspondence with the university shall be forwarded by the Principal of college with his remarks. (through proper channel) for consideration. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal.

O. POWERS OF THE KNR UNIVERSITY OF HEALTH SCIENCES: KNR University of Health Sciences, may either suomoto or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation there to as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to showcause against such cancellation. University has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake / false/forged.

P. Discipline:

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University either before the print or electronic media. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities/ NMC/Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.

Q. Ragging:

Ragging is prohibited in the Educational Institutions of State of Telangana and students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per law.

R. Any candidate who has applied online and uploaded certificates for verification and exercises web options for web based counseling is deemed to have read the Prospectus and shall abide by all conditions and clauses of the Prospectus.

Note: All the dates are tentative and the University reserves the right to change them without assigning any reason or advance notice.

S. The Regulations of KNR University of Health Sciences are applicable with regard to break of study, cancellation and re-admission.
