MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2022-23

NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR FIRST PHASE COUNSELING OF MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA IN AFFILIATED GOVERNMENT, PRIVATE UN-AIDED MINORITY/NON- MINORITY MEDICAL COLLEGES.

In continuation to this office notifications dated: 10.10.2022 and 28-10-2022 Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of first phase of web based counseling under Competent Authority Quota (C.Q) for MBBS course including EWS, PWD, CAP categories for 2022-23 in Government, Private un-aided Minority/Non-Minority Medical Colleges in the State of Telangana.

Candidates whose certificates were uploaded at the time of online registration and provisionally verified by staff of concerned departments and whose names are notified as eligible candidates in the provisional final merit list of UG Medical Admissions on the KNRUHS website are eligible to exercise web - options online from computer with internet connection.

All the eligible candidates whose names are displayed in the Provisional final merit list including PWD, CAP categories and EWS quota candidates on KNRUHS website can exercise web options for admission into MBBS seats from <u>6.00 A.M. on</u> <u>30.10.2022 to 2.00P.M. on 01.11.2022</u> through website https://tsmedadm.tsche.in/

Note: NCC certificate verification has not been started by NCC Directorate and priority list has not been submitted. If the priority list is submitted by NCC Directorate before second phase of counseling the NCC quota seats shall be filled up in Second phase of counseling.

For eligibility criteria and regulations refer to notifications dated: 10.10.2022.

UNIVERSITY FEE: Allotted Candidates have to pay University fee of Rs. 12,000/- for MBBS Course through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter.

TUITION FEE: Tuition fee is to be paid at respective Medical colleges. The tuition fee payable as notified by Government of Telangana in GO Ms No:5, HM& FW (C1)Department, .Dated:27. 01.2022 (notified on KNRUHS web site)

NOTE:

- The details of seats available (seat matrix) are placed in the website http://knruhs.telangana.gov.in . Candidates can exercise web options for MBBS seats in all Medical colleges affiliated to KNRUHS through https://tsmedadm.tsche.in/.
- 2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Medical and Family Welfare (C1) Department Dated: 22.09.2022, relevant Hon'ble High Court/Supreme court orders and University regulations,
- 3. Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options for the regulations.
- 4. Competent Authority Quota seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Competent Authority Quota seats in other Medical Colleges.
- 5. IMPORANT NOTE: CANDIDATES ARE INFORMED THAT IF THEY EXERCISE WEB- OPTIONS FOR A SEAT AND ALLOTTED A MBBS SEAT AS PER THEIR CHOICE IN THE WEB- COUNSELING AND IF THEY DO NOT JOIN THE COURSE AT THE ALLOTTED COLLEGE, THEY WILL NOT BE ELIGIBLE FOR EXERCISING WEB- OPTIONS FOR SUBSEQUENT ROUNDS OF COUNSELING.

IMPORTANT INSTRUCTIONS TO THE CANDIDATES:

- Eligible NEET-UG-2022 qualified candidates as per provisional final merit list for Competent Authority Quota can exercise web options for MBBS seats in Medical colleges as per their interest and priority through https://tsmedadm.tsche.in/ from computer with internet connection.
- Candidates are advised to go through the prospectus for the regulations for MBBS course of KNRUHS, available on website before exercising weboptions.
- 3) If a candidate is allotted a seat in MBBS course as per his/her options and does not join the course, they shall not be permitted to exercise web options

- in subsequent phases of counselings and admission to prevent seat blocking.
- 4) Candidates exercising web-options for MBBS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidates eligibility.
- 5) Candidates are advised to exercise web options for MBBS seats in courses and colleges in which they are interested to join and there is no limit to the number of options. Candidates can exercise options for all colleges.
- 6) Candidates in the Provisional final merit list are informed that if they do not exercise web options in the first phase of counseling, they are not eligible to exercise web options in subsequent phases of counseling to prevent seat blocking.
- 7) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read construction to the candidates before giving options)
- 8) Candidates are instructed to take a print out of saved options.
- 9) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also informed to login to check their allotment status on https://tsmedadm.tsche.in/ website after each phase of counseling.
- 10) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using Online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective college on or before the date specified on the allotment letter.
- 11) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and the candidate's options shall not be considered for subsequent phases of counselings and admission to prevent seat blocking.
- 12) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per

University regulations.

13) Selected candidates have to report at the respective colleges before the last date

for joining as specified on the allotment letter, submit all original certificates, the

relevant bonds and pay the tuition fee / college fee to complete the process of

admission. If the candidate does not fulfill the above criteria to complete the

admission process within the specified date, the admission will be cancelled

automatically and the candidate will not be permitted to exercise web options for

subsequent rounds to prevent seat blocking.

14) Original certificates submitted at the time of admissions shall not be

returned to candidate, unless the candidate discontinues the course before

second phase of counseling. If the candidate slides to other college during the

second phase of counseling, the original certificates will be transferred to the

allotted college.

15) Candidates are informed that as per Hon'ble Supreme Court orders and

MCC/DGHS, Ministry of Health Government of India notice no. U-12021/01/

2022-MEC, dated. 12.07.2022 and in accordance with GO.Ms.No. 109 HM & FW

Department, dated. 22.08.2022, admitted candidates are not permitted to

withdraw from the course after second phase of counseling. Candidates are also

informed that admitted candidates who have joined upto round 2 of All India

quota and State Quota shall not be eligible for further rounds of All India Quota

and State counsellings (Competent Authority Quota and Management Quota).

16) Admitted candidates will have to pay discontinuation penalty amount of Rs.20

lakhs as per Government Orders, if they discontinue the course after the second

phase of counseling to get their original certificates back.

17) The University fee once paid shall not be refunded under any circumstances.
