**BDS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2022-23**

**NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR STRAY VACANCY  
PHASE OF COUNSELING**

In continuation to this office notifications dated: 10.10.2022, 23.10.2022, 8-11-2022, 25-11-2022 and 13-12-2022 Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of Stray vacancy phase of web based counseling for vacant seats after Mop-up phase of counseling for BDS course under Competent Authority Quota for 2022-23 in Government, Private Dental Colleges including Army Dental College in the State of Telangana.

**All the eligible candidates whose names are displayed in the Provisional final merit list on KNRUHS website who were not allotted any seats in the previous phases of counseling can exercise web options from 2.00 P.M. on 23.12.2022 to 2.00 P.M. on 24.12.2022 through website <https://tsbdsadm.tsche.in/> from computer with internet connection subject to fulfillment of the following conditions.**

1. Candidates who were allotted seats in the previous phases of counseling and joined the course (CQ and MQ) for MBBS and BDS are not eligible to exercise web options.
2. Candidates who were allotted seats in the previous phases of counseling and have not reported/discontinued the course (CQ) for BDS at the respective college are not eligible for exercising options.
3. Candidates who have not exercised web options in the previous phases of counseling (CQ) for BDS are also not eligible to exercise web options.
4. **Candidates who are admitted in MBBS/BDS courses under All India Quota Counseling as notified by MCC/ Dr.YSRUHS (Dr.NTRUHS) counselings (CQ and MQ) are not eligible to exercise web options.**
5. Candidates who are allotted MBBS/BDS seats in Stray vacancy counseling of All India Quota will not be considered for allotment in Stray vacancy round of KNRUHS (options exercised will not be considered) to prevent seat blocking.
6. If any candidate violates this and the same is noticed by the University at any stage/at a later date, the admission stands cancelled automatically and the candidate is liable for punishment as per law

For eligibility criteria and regulations refer to notifications dated: 10.10.2022.

**UNIVERSITY FEE:** Allotted Candidates have to pay University fee of Rs. 12,000/- for BDS Course through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter.

**TUITION FEE:** Tuition fee is to be paid at respective Dental colleges. The tuition fee payable as notified by Government of Telangana in GO Ms No:5, HM& FW (C1)Department, .Dated:27. 01.2022 (notified on KNRUHS web site)

**CANDIDATES ARE DIRECTED TO NOTE THE TUITION FEE AT ARMY DENTAL COLLEGE IN EXERCISING THE WEB OPTIONS OF THEIR PRIORITY OF DENTAL COLLEGES**

**NOTE:**

1. The details of vacant seats available are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for all vacant BDS seats in all Dental colleges affiliated to KNRUHS through <https://tsmedadm.tsche.in/>.
2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Medical and Family Welfare (C1) Department Dated: 22.09.2022, relevant Hon'ble High Court/Supreme court orders and University regulations,
3. Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options for the regulations.

**IMPORTANT INSTRUCTIONS TO THE CANDIDATES:**

- 1) Eligible NEET-UG-2022 qualified candidates as per provisional final merit list for Competent Authority Quota can exercise web options for vacant BDS seats in Dental colleges as per their interest and priority through through <https://tsbdsadm.tsche.in/> from computer with internet connection.
- 2) Candidates exercising web-options for BDS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for vacant seats in any number of colleges the candidate is interested to join as per candidate's eligibility. If candidates are not interested to join in any college they should not exercise web options for the

same.

- 3) Candidates can exercise web options through a computer either from home / any other place having internet facility. Don't use mobiles and Tab's for exercising web options.
- 4) One time pass word (OTP) will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read construction to the candidates before giving options)
- 5) Candidates are instructed to take a print out of saved options.
- 6) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to login to check their allotment status on <https://tsmedadm.tsche.in/> website after each phase of counseling without fail.
- 7) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using Online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective college on or before the date specified on the allotment letter.
- 8) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission.
- 9) Candidates have to compulsorily join at the allotted college without fail in this phase of counseling. Failure to join the course will be considered as being part of seat blocking and candidate has to pay penalty of Rs. 20 lakhs and also debarred for 3 years for MBBS admission under KNRUHS to prevent seat blocking.
- 10) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 11) The University fee once paid shall not be refunded under any circumstances.
