Application forms online are invited from Indian Citizens, NRI's and Others (PIO, OCI) who have qualified by securing the following cutoff scores or above in NEET-UG-2023 for admission into MBBS/BDS Courses for the academic year 2023-24 under Management Quota i.e. B- Category, C- Category (NRI) in Private Un-aided Non-Minority/Minority Medical Colleges and Private Un-aided Dental Colleges, Army Dental College affiliated to Kaloji Narayana Rao University of Health Sciences, Warangal and Neelima Institute of Medical Sciences(affiliated to Anurag University) in the State of Telangana.

Notification is issued for online registration for web based counseling to determine State Merit position for admission into Management Quota seats only. Provisional Final Merit list will be notified after scrutiny of all uploaded certificates. Total number of seats available under Management Quota for the academic year 2023-24 will be notified on KNRUHS before counseling. Tuition fee payable will be as notified by the Government of Telangana.(G.O.M.S.No.106 HM&FW (C1) Department, Dated: 28-07-2023 and G.O.M.S.No.40 Higher Education (UE) Department, Dated: 20-06-2023).

Provisional Final Merit position of the applied candidates will be prepared based on NEET UG 2023 Score and other eligibility criteria notified here under after verification of uploaded certificates. Final verification of original certificates will be conducted at the time of admission at allotted college by Admission Committee.

I) ELIGIBILITY:

- a) The candidates, who have qualified in NEET UG- 2023 by securing cutoff score and above, have to apply for determining the State Merit position for Management Quota seats subject to the conditions specified in admission Regulations/Prospectus. (Refer Regulations/Prospectus for detailed clarifications).
- b) 85% of the seats under Management Quota B Category for MBBS/BDS Courses in Medical & Dental colleges affiliated to KNRUHS are reserved for local candidates from Telangana state in accordance with GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022. The remaining 15% of the seats are open to candidates from all over the country including local candidates.
- c) 25% of seats under Management Quota B category at Neelima Institute of Medical Sciences are reserved for local candidates from Telangana state.
- d) Candidates from all over the country are eligible for admission into Management quota seats Category C (NRI) for UG Medical and Dental Courses.
- e) Foreign Students / NRI candidates are eligible for admission into MBBS and BDS
 Courses under Management Quota Category C Seats. Candidates should
 specifically put the option for NRI Category in the on-line application to be
 considered for NRI / C-Category.
- f) *Candidates who have already applied for Competent Authority Quota Seats in response to this University earlier notification are also eligible to apply for the Management Quota seats, but they have to apply afresh.
- g) The candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology) / Biotechnology and English
 - i. OC candidates should obtain not less than 50% marks in science subjects.
 - ii. BC/SC/ST candidates should obtain not less than 40% marks in science subjects. (for eligibility criteria only). There are no reservations in Management Quota.

- h) The candidate should have completed 17 years of age as on 31-12-2023. The candidates who do not complete 17 years as on 31-12-2023 are not eligible to apply.
- i) The NEET UG 2023 qualified and eligible candidates as per the concerned regulations who desire to take admission into MBBS/BDS Courses shall apply online and upload all original certificates for determining the Merit position for Telangana State Management Quota seats. The online application can be filled through any computer with internet connection.

(NOTE: PREFERABLY DESKTOP OR LAPTOP)

- II) Registration and Processing Fee for MBBS/BDS courses: The Registration, and Processing fee of Rs.6300/- (Bank transaction charges extra) shall be paid online through Debit card / Credit card or Net Banking.**
 - ** Registration and processing fee once paid will not be refunded or adjusted to a further date.
 - ** NEET-UG-2023 qualified candidates are advised to check their eligibility to apply for determining the Merit position in respective categories by reading Prospectus / Regulations carefully.

- IV) Procedure of filling online application, scanning/uploading of original certificates and online payment for registration

 - 3) Candidates claiming NRI quota should submit the following documents from a Bloodrelative such as Father/Mother/Brother/Sister/Uncle/Aunt only and should submit a declaration to that effect.

VI) MANAGEMENT QUOTA SEATS:

A) The MBBS/BDS seats available under Management Quota in all affiliated colleges will be displayed on KNRUHS website before Counseling.

- **B**) The MBBS seats available under Management Quota in **Neelima Institute of Medical Sciences** will be displayed on KNRUHS website beforeCounseling
- C) BDS seats in Army Dental College are reserved for wards of Army Personnel Only.

Important information for candidates:

- i) Candidates are hereby informed that if they have secured admission in Medical colleges of other states, joined the course and if they are involved in seat blocking under Management Quota in KNRUHS, the University will initiate legal action and also inform the same to National Medical Commission for further course of action.
- ii) On-online application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area or incomplete applications will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2023 Rank
- **iii)** The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct
- **iv**) Candidates eligibility for admission into UG courses for the academic year 2023-2024 will be examined by the University only after scrutiny of application along with all uploaded certificates and provisional final merit list will be notified.
- v) Registration along with uploading of Scanned Original certificates will be done only once irrespective of the number of counselings. No separate notification will be issued for verification of original certificates. Therefore the candidates should register and upload all the mandatory Certificates without fail.
- vi) This notification is for online registration for determining the Merit position using NEET- UG-2023 Rank only for eligible candidates. The schedule for exercising web options for admission to MBBS/BDS courses will be notified separately on University website. Candidates are advised to check the University web-site for notifications, counseling schedule, seat matrix and other details from time to time.
- vii) An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission. Admission will be considered only for candidates, who have secured marks above cutoff score in NEET- UG-2023 exam and based on the merit order as the case may be.
- viii) Scrutiny of uploaded Original Certificates shall be conducted by the University and concerned departmental officials. After scrutiny of application and certificates provisional final merit list will be released. Candidates are advised to refer to KNRUHS website for further details regarding schedule of exercising web options. No individual communication will be sent

ix) Admissions will be in accordance with the Orders issued from time to time by State Government with regard to process of Admissions to Under Graduate Medical Courses for Management quota

and relevant Hon'ble Supreme Court and High Court orders.

x) The procedure for preparation of seat matrix and selection into MBBS/BDS courses in the

Management Quota and seat allocation will be done as the procedure given in G.O.Ms.No. 115

xii) Candidates have to exercise web options for seats in the colleges in which there are interested to

join for MBBS course and BDS course separately. Candidates and parents are informed to

exercise web options very carefully in order of their preference for colleges and also to take a

print out of exercised web options which are uploaded for reference.

xiii) After allotment the candidate should download the allotment order, submit the printout of the

filled-in Online application form, allotment order, Bonds and original certificates along with (1)

set of self attested copies to the Principal of allotted college at the time of joining for final

verification by the admissions committee of allotted college. The Admission Committee is

responsible for scrutiny of the original certificates submitted by the candidate. In case of any

discrepancy, the provisional allotment order for admission will be cancelled.

PROSPECTUS FOR ADMISSION INTO MBBS COURSE FOR MANAGEMENT QUOTA IN UN-AIDED PRIVATE NON-MINORITY/MINORITY MEDICAL COLLEGES AND FOR BDS COURSE IN UN-AIDED NON MINORITY DENTAL COLLEGES INCLUDING ARMY DENTAL COLLEGE IN THE STATE OF TELANGANA FOR 2023-24

A. <u>Regulations:</u>

The following are the Regulations for admission of students into Management Quota (Category -B and Category -C (NRI)) MBBS / BDS Courses in Private Un – Aided Non – Minority/Minority Medical and Non - Minority Dental Colleges including Army Dental College in the state of Telangana for the year 2023-24.

- i) The candidate should have qualified in NEET UG 2023 exam by securing marks of cut off score and above.
- ii) NEET UG 2023 merit ranks shall be the basis for the selection into MBBS and BDS Courses subject to these regulations.
- iii) The number of MBBS/BDS seats for the academic year 2023-2024 will be as permitted by NMC/DCI and notified before counseling.
- <u>iv</u>) Tuition Fee will be as notified by the State Government
- <u>v)</u> In case any new MBBS/BDS seats are permitted by MCI/DCI in Private Medical and Dental colleges affiliated to the University for the Academic Year 2023-24, those seats also will be filled up. NO FURTHER NOTIFICATION WILL BE ISSUED.
- <u>vi)</u> Seats in Army Dental College are reserved for Army wards as per AWES Regulations.
- vii) Seats in Un-aided Minority Medical Colleges are reserved for Muslim Minority Candidates only. In case Muslim Minority Candidates are not available the seats may be filled up with Non- Minority students up to maximum of 30% after Mopup Phase of counseling.
- <u>viii)</u> The seat matrix for Management Quota seats for academic year i.e., 2023- 24 will be displayed in the KNRUHS website before exercising web options for counseling.

- ix) 85% of the seats under Management Quota Category B for MBBS/BDS Courses are reserved for local candidates from Telangana state in accordance with GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022. The remaining 15% of the seats are open to candidates from all over the country along with local candidates.
- <u>x</u>) Candidates from all over the country are eligible for admission into Management Quota Category C (NRI) seats for MBBS/BDS Courses.
- <u>xi)</u> Foreign Students / NRI candidates are eligible for admission into MBBS and BDS Courses under Management Quota Category C Seats. Candidates should specifically put the option for NRI Category in the on-lineapplication to be considered for NRI / C-Category.

B. Eligibility:

The candidates who fulfill the following criteria are eligible for admission into MBBS/BDS courses.

- i) The candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology)/ Biotechnology and English.
 - a) OC candidates should obtain not less than 50% marks in science subjects.
 - b) BC/SC/ST candidates should obtain not less than 40% marks in science subjects.
- ii) Candidates should have qualified at NEET UG 2023
- iii) The candidates should secure the following cut-off scores or above in NEET UG-2023

Candidates have to apply online and upload the original certificates for online verification and for inclusion in merit list for Management Quota seats in Private Medical/ Dental Colleges affiliated to Kaloji Narayana Rao University of Health Sciences, Telangana, Warangal

- *Candidates who have already applied for Competent Authority

 Quota Seats in response to this University earlier notification are
 also eligible to apply for the Management Quota seats, but they
 have to apply afresh.
- ix) Candidates possessing qualification of the University / Board of an institution outside the Telangana State should submit Eligibility / Equivalence certificate from the Board of Intermediate Education of Telangana, to the effect that the qualification possessed is equivalent to or higher than Intermediate examination conducted by the Board of Intermediate Education of Telangana in the same subjects as per NMC eligibility criteria at the time of admission into the college.
- candidates possessing qualification of the University / Board of an institution outside INDIA should submit Eligibility / Equivalence certificate issued by Association of Indian Universities, New Delhi and Eligibility/ Equivalence certificate issued from the Board of Intermediate Education of Telangana to the effect that the qualification possessed is equivalent to or higher than Intermediate examination in the same subjects as per NMC eligibility criteria conducted by the Board of Intermediate Education of Telangana at the time of admission into the college.

C. AGE:

The candidate should have completed 17 years of age as on 31-12-2023. The candidates who do not complete 17 years as on 31-12-2023 are not eligible to apply.

- **D.** NRI Quota eligibility :
 - i) Admission to NRI seats will be made on the basis of NEET-UG-2023 ranks of candidates eligible for NRI quota and registered online.
 - NRI Financially supporting the candidate must be a blood relative such as Father/ Mother/ Brother/Sister/ Uncle/ Aunt only and should submit a declaration to that effect.

- <u>iii</u>) Candidate opting for NRI seat must furnish the photocopies of following supporting documents.
 - 1 NRI status certificate of the financial supporter issued by embassy of respective country under their seal.
 - 2) Copy of NRI Bank account pass book of the financial supporter.
 - 3) Copy of Pass port of NRI financial supporter.

Note: a) If, enough number of NRI candidates are not available, the left over seats of NRI Category may be filled-up with willing candidates of Management Quota merit list during the final phase of counseling. Candidates are informed that the same fee of NRI category is applicable for these seats.

Note:

- i. If a candidate is found to have submitted false information or concealed any relevant information regarding this matter, such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be taken by the University/respective institution. Legal issues if any shall be under the High Court of Judicature at Hyderabad for the State of Telangana.
- ii. The registration fee and processing fee once paid will not be refunded or adjusted to a future date. Therefore candidates are advised to check eligibility conditions thoroughly before applying for determining merit.
- iii. Candidate should clearly specify in the on-line application whether he is opting for B-Category or C- Category (NRI) or both B & C Categories of Management Quota.
- **iv.** The Original Certificates submitted by the admitted candidates who withdraw from the course, before the free exit date will be returned without penalty.
- v. Vacant seats after each round of counseling will be filled up in subsequent rounds of counseling. The date and time of Counseling will be notified by the on KNR UHS web- site.

E. ONLINE APPLICATIONS:

K. Powers of the Admission Committee:

L. ADMISSION RULES

Undertaking in the form of Affidavit on Rs. 100 /- Non-Judicial Stamp paper by the Parent and candidate stating that all the certificates including the caste and category certificates are genuine and they are responsible for any further consequences as per law shall be submitted at the time admission. If any discrepancy is noticed, the admission will be cancelled.

Selected candidates have to join the college within the specified date by submitting all Original Certificates, Bonds, and pay the tuition fee as notified by the Government to complete the process of admission. Against any such order of the Principal, an appeal shall lie to the Registrar, KNR University of Health Sciences, Telangana.

N. COLLEGE REGULATIONS: Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Candidates are informed that their correspondence with the university shall be forwarded by the Principal of college with his remarks. (through proper channel) for consideration. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal.

O. SANCTION OF LEAVE BEYOND 3 MONTHS AND TERMINATION OF STUDENTSHIP

- a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals, Clinicals). If a student absents continuously for a period of 91 days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
- b. If the break of study (91 days are more) in more than one spell, the candidate's representation in the prescribed profroma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.
- c. Candidates who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission in to the course and the studentship stands cancel without any further notice.
- d. The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the National Medical Commission from time to time.
- e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course
- P. POWERS OF THE KNR UNIVERSITY OF HEALTH SCIENCES: KNR University of Health Sciences, may either suomoto or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation there to as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to showcause against such cancellation. University has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake / false/forged.

Q. Discipline:

The students shall maintain strict discipline during the period of study/training program. The
