BDS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2023-24

NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR ADDITIONAL MOP-UP PHASE COUNSELING.

In continuation to this office notifications dated: 06.07.2023, 26-07-2023, 02-08-2023, 22-08-2023, 13-09-2023 and 27.09.2023 Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of Additional Mop-up phase of web based counseling for vacant seats after Mop up phase of counseling under Competent Authority Quota (C.Q) for BDS course for 2023-24 in Government, Private Dental Colleges including Army Dental College.

Candidates whose names are notified in the provisional final merit list of MBBS/BDS Admissions on the KNRUHS website are eligible to exercise web - options online from computer with internet connection subject to the following conditions.

- 1. The Candidates who were allotted BDS seats in the previous phases of counseling and have not reported/discontinued the course at the respective college are not eligible for exercising options.
- 2. Candidates who have not exercised web options in the first phase of counseling are not eligible to exercise web options.
- 3. The candidates who were allotted BDS seats in the previous phases of counseling and joined the course and continuing in the course are eligible to exercise web options and are informed to exercise web options.
- 4. Candidates who have joined in MBBS course under KNRUHS, YSRUHS and AIQ are not eligible to exercise web options.
- 5. Candidates who have joined in BDS course in AIQ counseling are not eligible to exercise web options

All the eligible candidates whose names are displayed in the Provisional final merit list **on KNRUHS website can exercise web options for admission into** BDS course from **08.00 A.M. on 07.10.2023 to 02.00 P.M. on 08.10.2023** through website https://tsbdsadm.tsche.in/

For eligibility criteria and regulations refer to notifications dated: 06.07.2023.

UNIVERSITY FEE: Allotted Candidates have to pay University fee of Rs. 12,000/- for BDS Course through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter. Candidates who have paid University fee in the previous phases need not pay again.

TUITION FEE: Tuition fee is payable as notified by Government

 options for BDS seats in all Dental colleges affiliated to KNRUHS through
 https://tsbdsadm.tsche.in/.
- 2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Dental and Family Welfare (C1) Department Dated: 22.09.2022, G.O. Ms. No. 72, Health, Dental and Family Welfare (C1) Department Dated: 03-07-2023, G.O. Ms. No. 75, Health, Dental and Family Welfare (C1) Department Dated: 04-07-2023 and relevant Hon'ble High Court/Supreme court orders and University regulations.
- 3. Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options.

IMPORTANT INSTRUCTIONS TO THE CANDIDATES:

- 1) Eligible NEET-UG-2023 qualified candidates as per provisional final merit list for Competent Authority Quota can exercise web options for BDS seats all Dental colleges affiliated to KNRUHS through https://tsbdsadm.tsche.in/. as per their interest and priority from computer with internet connection.
- 2) Candidates exercising web-options for BDS Course are informed that there is no limit of choices (number) web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidate's eligibility.
- Candidates are advised to exercise web options for BDS seats in all colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in previous phases of counseling to other seats as per their web options in the Mop-up phase of counseling. If candidates are not interested to join in any college they should not exercise web options for the same.
- 4) If a seat is allotted in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the seat allotted in previous phases of counseling will be automatically cancelled and allotted to the other candidate. Therefore the candidates are informed to exercise web options carefully for sliding with awareness of this fact.
- 5) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z.
- 6) Candidates are instructed to take a print out of saved options.
- 7) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also informed to login to check their allotment status through https://tsbdsadm.tsche.in/. website after each phase of counseling.

- 8) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective college on or before the date specified on the allotment letter.
- 9) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically.
- 10) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 11) If the candidate slides to other college during Additional Mop-up phase of counseling in colleges affiliated to KNRUHS, the original certificates will be sent to the college concerned after the closure of admissions. Candidates have to get relieved from previous phase joined college, obtain custodian certificate, collect fees and report to the allotted college before last date of joining.
- **12)** Candidates are informed that as per Hon'ble Supreme Court orders and in accordance with GO.Ms.No. 125 HM & FW Department, dated. 22.09.2023, admitted candidates are not permitted to withdraw from the course after Mop-up phase of counseling.
- 13) Admitted candidates will have to pay discontinuation penalty amount of Rs.20 lakhs as per Government Orders, if they discontinue the course after the Mop up phase of counseling to get their original certificates back. Candidates also will be debarred for 3 years for BDS admission under KNRUHS to prevent seat blocking.

- 14) The University fee once paid shall not be refunded under any circumstances.
