**ADMISSIONS INTO BDS COURSE UNDER MANAGEMENT QUOTA- 2023-24**

**NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR MOP-UP PHASE**

In continuation to this office notifications dated 03.08.2023, 25.08.2023 and 16.09.2023 KNRUHS hereby notifies the conduct of Mop-up phase of web-based counseling for admission into vacant seats of BDS course under Management Quota for 2023-24 after 2<sup>nd</sup> phase of counseling in affiliated Private Dental Colleges including Army College of Dental Sciences affiliated to KNRUHS.

Candidates whose names are notified in the provisional final merit list of MBBS/BDS Admissions under Management Quota notified on the KNRUHS website on 16.09.2023 are eligible to exercise web - options online from computer with internet connection with the following conditions.

1. The Candidates who were allotted seats in the previous phases of counseling and have not reported/discontinued the BDS course at the respective college are not eligible for exercising options.
2. Candidates who have not exercised web options in the first phase of counseling are not eligible to exercise web options.
3. The candidates who were allotted MBBS seats under KNRUHS/YSRUHS and All India Quota are not eligible to exercise web options.
4. Candidates who have joined BDS course under Management Quota in the previous phases and continuing in the course are eligible to exercise web options and are informed to exercise web options.
5. The candidates whose names are notified in the Competent Authority Quota counseling after MOP UP Phase for BDS are not eligible to exercise web options
6. The Candidates whose names are notified on MCC web site as admitted list of candidates after Mop-up phase of counseling are not eligible for exercising options.

## **SCHEDULE OF EXERCISING WEB OPTIONS**

All the eligible candidates whose names are displayed in the Provisional final merit list for Management Quota on KNRUHS website can exercise web options for admission into BDS seats from **08.00 A.M. on 11.10.2023 to 6.00 P.M. on 11.10.2023** through website <https://tspvtmedadm.tsche.in/>.

For eligibility criteria and regulations refer to notifications dated: 03.08.2023.

### **NOTE:**

1. The details of vacant seats available (seat matrix) are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for BDS seats in all Dental Colleges through <https://tspvtmedadm.tsche.in/>.
2. In accordance with the GO.Ms.No. 130 HM&FW (C1) Department, Dated: 27.09.2022 in Management Quota B Category 85% of seats are reserved for local candidates of Telangana State and 15% seats are open to candidates from all over the country. 15% unreserved seats shall be allotted first followed by seats reserved for local candidates.
3. The seats in Army College of Dental Sciences are reserved for the wards of Army personnel as per AWES regulations.
4. The allotment of seats will be made in accordance with the selection procedure notified in Government Orders G.O.Ms.No. 115 & 116 HM&FW (C1) Dept. Dated: 05-07-2017, G.O.Ms.No.117 & 118 HM&FW(C1)Dept. Dated: 20-07-2017, subsequent amendments, G.O.Ms.No.125, 126, 127, HM&FW (C1) , Department, Dated:22-09-2022, GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022, other Government orders, University Regulations and relevant Hon'ble Supreme Court and High Court orders.
5. Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website for Management Quota before exercising web options for the regulations.
6. **Candidates are informed that they will be considered only to the category / categories to which they have registered.(B or B/NRI)**

**UNIVERSITY FEE:** Allotted Candidates have to pay the following University fee through payment gate-way by using online payment method (Debit Card/Credit Card/Internet Banking) and down-load the allotment letter. Candidates who have paid University fee in the previous phases of Management Quota need not pay again

For B- Category :

1) BDS      Rs. 20,000=00

For C-Category ( NRI ):

**TUITION FEE:** Tuition fee is to be paid at respective Dental colleges.

### INSTRUCTIONS TO CANDIDATES

- 1) Eligible NEET-UG-2023 Candidates as per Provisional Final Merit List for Management Quota can exercise web options for Management Quota BDS seats in all Dental colleges as per their interest and priority from computer with internet connection through <https://tspvtmedadm.tsche.in/>
- 2) Candidates exercising web-options for BDS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidates eligibility.
- 3) Candidates are advised to exercise web options for BDS seats in all colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in previous phases of counseling to other seats as per their web options in the Mop up phase of counseling. If candidates are not interested to join in any college they should not exercise web options for the same.
- 4) If a seat is allotted in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the seat allotted in previous phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore the candidates are informed to exercise web options carefully for sliding with awareness of this fact.

- 5) Candidates have to exercise options for B category and if eligible for C (NRI) category in order of their priority for category and college. Allotments will be made according to the order of preference in the web options exercised by the candidate.
- 6) Candidates can exercise options on the web either from home / any other place having internet facility. Candidates are instructed to take a print out of saved options
- 7) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options.
- 8) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also informed to login to check their allotment status on through <https://tspvtmedadm.tsche.in/> website after each phase of counseling.
- 9) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of respective college on or before the date specified on the allotment letter.
- 10) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically.
- 11) If the candidate slides to other college during Mop-up phase of counseling in colleges affiliated to KNRUHS, the original certificates will be sent to the college concerned after the closure of admissions. Candidates have to get relieved from previous phase joined college, obtain custodian certificate, collect fees and report to the allotted college before last date of joining..

- 12) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.
- 13) Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI relative in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at respective colleges.
- 14) **Original certificates submitted at the time of admissions shall not be returned to candidate, unless the candidate discontinues the course before the last date of free exit notified on KNRUHS web site. If the candidate slides to other college during the Mop-up phase of counseling, the original certificates will be transferred to the allotted college.**
- 15) The University fee once paid shall not be refunded under any circumstances.
