KNR UNIVERSITY OF HEALTH SCIENCES, TELANGANA, PROSPECTUS FOR ADMISSION INTO M.D.(HOMOEO) COURSES UNDER MANAGEMENT QUOTA 2023-24

REGULATIONS:

The following are the Regulations for admission into Management Quota seats in Post Graduate Homoeo Degree Courses for the academic year 2023-24 and shall applyto all admissions into all the Un-aided Private Non- Minority Homoeo Medical Colleges affiliated to KNR University of Health Sciences in the State of Telangana.

1. Number of seats under Management Quota:

- 1.1 The number of seats to be available for the academic year 2023-24 in Post Graduate Homoeo Degree courses at Private Un-Aided Homoeo Medical Colleges will be in accordance with the orders of the NCH/GOI/Govt. of Telangana. The seats will filled by KNR University of Health Sciences, Telangana State in accordance with the rules for admission into PG AYUSH courses under Management Quota as notified in G.O.Ms.No.72, HM&FW (E2) Department, Dated:29-06-2022 and University/NCH Regulations .
- 1.2 The seat matrix for Management Quota seats for the academic year 2023-24 will be displayed in the KNRUHS website with the notification for exercising web options for counseling.
- **1.3** In case any new PG Homoeo seats are permitted by NCH/Government of India in colleges affiliated to the KNRUHS for the academic year 2023-24, those seats also will be filled up. No further notification will be issued.
- **1.4 The distribution of Management quota seats as per** G.O.Ms.No.72, HM&FW (E2) Department, Dated:29-06-2022 is as follows
 - a) _50% of seats in each specialty in each college are Management Quota seats.

 The Management Quota Seats are categorized into Management Quota (a) Sub –

 Category MQ1. 25%, Management Quota (b) Sub Category MQ2. 15% NRI

 quota (NRI/NRI Sponsored) (c)Management Quota Sub Category MQ3

 Institutional Preference Quota 10%.

- b) For Management Quota Sub Category MQ1 25%, candidates from all over India are eligible.
- c) For Management Quota Sub Category MQ2 15%, NRI candidates and NRI sponsored candidates are eligible.
- d) For Management Quota Sub Category MQ3 10%, candidates sponsored by the Management's of the Private Un – Aided Non – Minority Homoeo Medical Colleges having Post Graduate Course in the State of Telangana
- e) The Eligibility criteria for NRI (MQ2) Quota is as follows:
 - i) Admission to NRI seats will be made on the basis of AIAPGET 2023 merit ranks of eligible candidates who have applied on-line for NRI seats.
 - ii) NRI Financially supporting the candidate must be a Blood relative such as Father/Mother/Brother/Sister/Uncle/Aunt only and should submit a declaration to that effect.
 - iii) Candidate opting for NRI seat must furnish the photocopies of following supporting documents.
 - 1) NRI Sponsorship certificate (DECLARTION Form)
 - 2) NRI status certificate of the financial supporter issued by embassy of respective country under their seal.
 - 3) Copy of NRI Bank account pass book of the financial supporter.
 - 4) Copy of Pass port of NRI financial supporter
 - 1.5 There are no reservations of SC/ ST, BC, EWS, PWD categories in the Management Quota seats, there are no other reservations.

2. ELIGIBILITY FOR ADMISSION:

Those who have passed the BHMS Degree Examination after undergoing a course of study in Homoeopathy of not less than 5 ½ years duration including the period of compulsory internship; or

- 2.1 Those who passed equivalent Degree Examination included in the 2nd schedule of Homoeopathy Central Council Act 1973.
- 2.2 The candidates should have completed internship by 31-10-2023 or likely to complete and they shall submit a Certificate to that effect issued by the Principal of the college.
- 2.3 Candidates who have appeared AIAPGET 2023 and whose names are included in the merit list of AIAPGET-2023 for Homoeo P.G. are only eligible to apply, subject to fulfillment of regulations.

- 2.4 Candidate should secure the following minimum eligibility percentile or above.
 - a) 50% for General Category (Open) candidates.
 - b) 45% for General Category (Persons with Disabilities (OC-PWD)) candidates.
 - c) 40% for SC, ST and other Backward class including Persons with Disabilities

*Lower percentage / percentile of marks for SC/ST/BC/OBC /PWD is only for eligibility purpose and will not be applicable for reservations as there are no reservations under Management Quota

- 2.5 Candidates who are already admitted and studying M.D. (Homoeo) course shall not be permitted for counseling, until they discontinue the course before submitting the application form and such candidate shall submit the discontinuation certificate issued by the Head of the Institution along with the application.
- 2.6 Candidates who are already holding a Post Graduate Degree in Homoeopathy in a subject shall not be eligible for admission into another P.G. Homoeo Course.

3. APPLICATIONS: -

The online application form will be available on the website http://tsmdayushmq.tsche.in from 10.00 A.M. on 17-10-2023 to 23-10-2023 up to 06.00 PM.

- Note: The candidates are advised to take a print out of the prospectus / instructions to fill the application form from the website http://knruhs.telangana.gov.in before proceeding to fill the application form.
- 3.1The candidate should fill the online application form available in the Website with the data required-for, through internet. The online application form can be filled through any computer with internet connection with internet explorer 11 version (home/internet café/net center). The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the .jpg/.gif format separately (as shown below) (step-
 - 1) and ready to enter his/her correct data and upload the photo and signature after the payment of application fee through Online.


1. Open the website https://tsmdayushmq.tsche.in Home page displayed as follows.

There are 4 steps to register for Application program i.e

- a. Mobile and Email Registration,
- b. Candidate Registration (Payment of fee),
- c. Updating of data
- d. Uploading of Certificates.



2. Click on the Mobile and Email Registration. The candidate should have a valid /working Mobile and Email Id. OTP will be sent to registered Mobile and Email Id at different stages. The candidate should keep the Mobile and Email Id active till completions of the counselling process. The candidate has to enter OTP's received to mobile and Email Id for registration and Verification of Mobile and Email Id.




3. After entering the details click on validate button.




- **4.** If all the details entered are correct and verified with OTP's your system will display a successful message and proceed to registration form

- 3.2 After completing the data entry in all pages of the online application and after submitting the data through online, the candidate should take the print-out of the filled-in online application form. The Candidate should note the Barcode application number which appears on the printout of application for future reference.
- 3.3 The candidate should paste a recent passport size photograph in the space provided in the print out of online application form. The Photo should be attested by Gazetted Officer/ Principal of the College (identical to the photo that used for scanning)
- 3.4 Candidate shall upload all the required Original Certificates at the time of registration

4 Registration and Processing Fee:

The Registration and Processing fee is Rs. 6,000/-(Bank transaction charges extra)

Verification Fee for Equivalency: The candidates who acquired their Under Graduate Degree outside the State of Andhra Pradesh / Telangana or Country/Abroad and got their certificates registered with Council and applying for admission under this University, shall pay a verification fee of Rs.5,000/- for degree certificates acquired Abroad and Rs.3,000/- for the degrees acquired outside the State.

4.1 The candidate <u>shall sign at the declaration</u> area in the print out of the online application form and also put left hand thumb impression at the space provided without fail.

5. VERIFICATION OF UPLOADED ORIGINAL CERTIFICATES:

The University will conduct verification of uploaded Original Certificates and issue notification for exercising web options by the candidates.

6. MERIT LIST:

Merit Position of the candidates who have applied on-line shall be determined based on AIAPGET-2023 (Homoeo) test ranks as per their eligibility.

7. SELECTIONS:

- 7.1 University will conduct verification of original certificates and notify the provisional final merit list on the website. University will issue notification for schedule of exercising one time web options. Candidates are permitted to exercise one time web options only irrespective of number of phases of counseling.
- 7.2 The seats as per the notified seat matrix shall be filled through web based counseling by the Committee for Admissions as per merit from the candidates who have qualified in AIAPGET 2023 exam and applied in response to notification by KNR UHS for Management quota seats (B&C Categories)
- 7.3 The candidates shall submit their web options for subjects and colleges in order of priority and as per their eligibility for MQ1 and MQ2 categories. The selection

- committee will select the candidates as per the eligibility of the candidate for MQ1 and MQ2 categories and as per the priorities exercised by the candidate. The list of provisionally selected candidates will be displayed and the provisional selection intimations will be issued to the selected candidates. If a candidate does not for exercise web-options, he/she will not be considered for selection at the subsequent phases of counseling.
- 7.4 The Selection Committee shall provisionally select the candidates as per these regulations from among the candidates who qualified AIAPGET 2023 as per merit list and as per the priority of web-options exercised by candidates
- 7.5 Candidate after selection has to download the allotment letter, report to the Principal of the allotted college before the last date for joining, pay the fees, submit original certificates and submit the bond to complete the process of admission. In case the candidate does not complete the admission process, his/her selection stands cancelled automatically
 - 7.6 The Selection Committee shall have power to review the provisional selection in case of any errors, misrepresentation, fraud or glaring injustice. In all matters relating to selections and admissions, the decision of the selection committee shall be final and binding on the candidates and selections cannot be questioned after admissions are closed.
 - 7.7 If a candidate after fails to complete the admission procedure his/her selection stands cancelled automatically. If a candidate does not for exercise web-options, he/she will not be considered for selection at the subsequent phases of counseling.
 - 7.8 Vacant seats after first round of counseling will be filled up in subsequent phases of counseling by the committee as per one time web-options exercise by the candidate and allotment list shall be notified on KNR UHS web-site.
 - 7.9 Candidate after admission in to a College can withdraw from the course, before the last date of free exit for Management Quota, AYUSH admissions to be notified by the University on its website without any penalty.

8 REGULATIONS OF ADMISSION AT THE COLLEGE:

- 8.1 The Principal's of Homoeo Medical College, shall constitute an Admission Committee of the college from Professors to verify the correctness of documents. If there is any discrepancy the provisional allotment shall be cancelled and action shall be initiated as per Rules.
- 8.2 Candidates joining courses shall execute a bond on non judicial stamp paper of value of Rs.100/- in the form specified in Annexure-I to ensure completion

- of the prescribed period of training or in default or for any other reason has to pay Rs.1,00,000/- to the Registrar, KNR University of Health Sciences and shall refund the stipend received upto that date to Government.
- 8.3 The Original certificates submitted shall not be returned to the candidates till they complete their course.
- 8.4 Candidates selected to various courses shall be whole time students.

9 UNIVERSITY FEE: Allotted candidates have to pay the following University fee

MQ 1 Management Quota sub category 1: Rs.25,000/-MQ2 (NRI) & MQ3 (Institutional Quota): Rs.40,000/-

10 Tuition Fee

10.1 Tuition Fee: All the candidates selected are required to pay the tuition fee as prescribed by the Government. If any of the candidates who joined in a course is allotted to another course in subsequent counseling, the tuition fee paid by the candidate will be adjusted to the newly selected course and the tuition fee paid already shall not be refunded under any circumstances.

11 ATTENDANCE AND LEAVE:

- 11.1 The post graduate students shall mandatorily complete attendance in all subjects separately for eligibility to appear for the final examination as per NCH regulations.
- 11.2 Leave: The Post Graduates are eligible for 30 days leave in the academic year and they can avail a maximum 10 days at a time. If they avail more than 10 days at a time, the stipend shall be deducted proportionately. The balance of leave in any year shall not be carried forward to the next academic year.
- 11.3 **Maternity leave:** Post Graduate students are eligible for maternity leave as per State Government rules and the period of study shall be extended accordingly.

12 SANCTION OF LEAVE BEYOND (3) MONTHS AND TERMINATION OF STUDENTSHIP:

a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals). If a student absents continuously for a period of (91) days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and be permitted for Readmission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.

- b. If the break of study (91 days or more) is in more than one spell, the candidate's application in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the university.
- c. Candidates, who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission into the course and the studentship stands cancelled without any further notice.
- d. The candidate has to pass within the final examination for award of Degree for the course double the duration of study period for the course or within the maximum period permitted by the Indian Nursing Council from time to time.
- e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course".

13. PRIVATE PRACTICE:

PG students are not permitted to do any private practice or consultation practice and shall not accept any part-time employment during his/her Post Graduation.

14. COLLEGE REGULATIONS:

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University and they shall not make any correspondence with higher authorities directly without prior permission of the Professor of the concerned unit and Principal.

15. STIPENDS:

Stipends may be paid by the Principal as per the orders National Commission for Homoeopathy to the PG students who are regular in attendance and show good progress every month in their academic pursuits. The total period during which the stipends may be paid to the students shall not exceed thirty six months for the course. No candidate will be eligible to draw the stipend for more than 36 months during the entire PG study period.

16. COMMENCEMENT OF THE COURSE:

The course shall normally commence as per the date notified by National Commission for Homoeopathy. The duration of the course shall be calculated from this date of commencement of the course and shall be uniform for all the candidates irrespective of their individual dates of admission.

17. CLOSURE OF ADMISSIONS:

- a) Admissions shall be closed as per the schedule notified by NCISM/NCH.
- b) Any vacancy as on the day of closure of admissions or that arises after closure of

admissions shall not be filled up.

18. <u>DURATION OF COURSE AND MAXIMUM PERIOD FOR COMPLETION OF THE</u> <u>COURSE:</u>

The period of training of Doctor of Medicine in Homoeo shall be of 3 years duration in the subject concerned. Candidate should complete the course within the duration equivalent to double the period of course of study .i.e., 6 years.

19. MEDIUM OF INSTRUCTION:

English shall be the medium of instruction and examination

20. POWERS OF THE PRINCIPAL:

Notwithstanding anything contained in these regulations, the Principal of the College may at any time before completion of the PG course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit written explanation and or a personal hearing, order the cancellation of admission to the PG course if in his opinion such candidates had furnished false or incorrect information in the application form or in the documents attached, certificates enclosed there to or in the statements made either before the authority in charge of admissions or the Principal or in any other fraudulent manner, obtained admission into such course. Against any such order of the Principal an appeal shall lie to the KNR University of Health Sciences, Telangana, Warangal.

21. POWER TO AMEND REGULATIONS AND REVIEW SELECTION OR ADMISSION OF CANDIDATES:

- a) The KNR University of Health Sciences shall have the power to add or to delete or amend or alter these regulations from time to time.
- b) The University may either suomoto or on an application made to them, call for and examine records relating to any selection or admission or cancellation thereof made by the authority in charge of selection or admission for the purpose of satisfying themselves as to the legality or regularity of such selection or admission orders in relation thereto, as they deem fit including cancellation of the selections already published or admissions already made provided that the University may before cancelling such selection or admission give an opportunity to the authority in charge of selection or admission and to the person effected to show cause against such cancellation.

22. FINALITY OF SELECTION:

All selections under these Regulations shall be subject to any general regulations or order that may be made by University from time to time.

23 . MIGRATION /TRANSFER: No Transfers during the course period are permitted from one college to another college and from one course to other after closure of admissions under any circumstances.
