NOTIFICATION FOR EXERCISING ONE TIME WEB OPTIONS FOR ADMISSION INTO MD (HOMEO) COURSES FOR 2023-24 UNDER ALL INDIA QUOTA

In continuation to this office notifications 10-10-2023 and 30-10-2023 Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of counseling for allotment of seats of MD Homeo courses under All India Quota in affiliated Private Homeo Colleges in the state of Telangana.

Candidates who have registered online and whose names are notified in the provisional final merit list for All India Quota on the website of KNRUHS are eligible and directed to exercise one time web-options online from computer with internet connection.

Number of seats available under All India Quota (AIQ) for 2023-24

- **a.** JIMS Homopathic Medical College, Muchinthal (V), Shamshabad (M), RR District (JIMS)
- **b.** MNR Homeo College, Fasalwadi, Sangareddy District (MNR)
- c. Hamsa Homeopathic Medical College, Ksheerasagar(V), Mulugu(M), Siddipet District

All the eligible candidates can exercise one time web options for admission into MD (HOMEO) courses from **09.00 A.M. on 31-10-2023 to 6.00 P.M.**

on 01-11-2023 through Website https://tsmdayushaiq.tsche.in/

IMPORTANT NOTE:

1. Candidates are hereby informed that one time web options only shall be exercised for MD Homeo courses. The weboptions exercised by candidates with regard to order of preference for courses/ colleges is final and the same options will be considered for two phases of allotments.

2. Candidates selected under All India Quota in the counseling conducted by KNRUHS for PG Homeo courses at Private Homeopathic Colleges are permitted to leave /surrender the seat till the last date of free exit to be notified by KNRUHS on website with forfeiture of the University fee. If the candidate cancels the admission/ discontinues the course after the last date for free exit, candidate have to pay a penalty of Rs. 1,00,000/- in addition as per State Government orders and they will not be eligible for MD Homeo admissions under KNRUHS for 3 years.

3. National Commission for Indian System of Medicine & National Commission for Homeopathy, New Delhi Guidelines for allotment of AIQ PG seats in Private ASU & H Institutes for 2023-24 shall be followed

- 4. Undertaking in the form of affidavit shall be submitted at the time of admission by the candidates stating that the submitted Original certificates are genuine and they will be held responsible for any further consequences as per law if any discrepancy noticed.
- 5. UNIVERSITY FEE: Allotted Candidates have to pay University fee of Rs. 15000/-(Rupees Fifteen Thousands only) in the form of DD in favor of Registrar, KNRUHS payable at Warangal and obtain Provisional allotment letter from the Principal of the allotted college.

The University fee once paid shall not be refunded under any circumstances.

Tuition Fee is Rs. 70,000/- per annum as notified in G.O.Ms.No. 184, Health, Medical & Family Welfare (E1) Department Dated: 27-12-2021, issued by Government of Telangana.

Important instructions to candidates:-

- a) Admissions will be in accordance with the Government Orders, NCISM, NCH Regulations and University Regulations.
- b) Candidate can exercise one time web options for MD Homeo Courses in the Colleges as per their priority for the course and college. There is no limit to the number of options.
- c) Candidates are informed that they have to exercise one time web options to the course and colleges in which they are interested to join. If they are not interested to join in course/college, they should not exercise options for the same.
- d) If a candidate is allotted a seat in MD Homeo course as per their one time web options and does not join the course, their one time web options will not be considered for second phase of allotment.
- e) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read instructions to the candidates before exercising web options).
- f) Candidates are instructed to take a print out of saved options.
- g) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also informed to check the KNRUHS website for allotments for first phase, second phase and other notifications.

- h) Candidate after allotment shall report to the Principal of allotted college before the last date for joining and obtain allotment letter on payment of University fee by way of Demand Draft as detailed above.
- i) Candidates shall submit the printout of the filled-in online application form, allotment order, Bonds, original certificates along with (1) set of self attested copies to the Principal of allotted college, pay the tuition fee and college fee to complete the process of admission.
- j) Candidate has to pay the college fee and tuition fee at the time of joining. The Admission Committee of the College is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
- k) If the candidate fails to get admitted after allotment in the 1st phase of counseling, the options of the candidate will not be considered for 2nd phase of allotments.
- I) Candidates are informed that if an admitted candidate (of 1st phase) is allotted a seat in the 2nd phase of allotment as per his/her priority of options, the seat allotted in the 1st phase is automatically cancelled and allotted to the next meritorious candidate. Candidates have to exercise one time web-options accordingly.
- m) If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and the candidates one time web options will not be considered for second phase of allotment.
- n) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- Original certificates will not be returned to candidate, unless the candidate discontinues the course.
