## **PROSPECTUS FOR ADMISSION INTO MBBS & BDS COURSES FOR THE ACADEMIC YEAR 2024-25 UNDER COMPETENT AUTHORITY QUOTA**

### **REGULATIONS**

The following are the Regulations for admission into **MBBS/BDS** Courses in all Medical and Dental Colleges affiliated to KNRUHS for the academic year 2024-25 under Competent Authority Quota i.e., the seats in Government Medical/Dental Colleges (after exclusion of 15 % seats transferred to All India Quota ) and Category 'A' seats in Private Un-aided Non-Minority / Minority Medical Colleges and Private Non-Minority Dental Colleges and Army Dental College.

#### **1. NUMBER OF SEATS UNDER COMPETENT AUTHORITY QUOTA:**

- 1.1** The number of MBBS/BDS seats for the academic year 2024-25 at Government Medical / Dental Colleges and Private Medical / Dental Colleges will be as permitted by NMC/DCI and notified before counseling. Tuition Fee will be as notified by the State Government.
- 1.2** The seat matrix for Competent Authority Quota seats for academic year i.e., 2024-25 will be displayed in the KNRUHS website before exercising web options for counseling.
- 1.3** In case any new MBBS/BDS seats are permitted by NMC/DCI in colleges affiliated to the University for the Academic Year 2024-25, those seats will also be filled up. NO FURTHER NOTIFICATION WILL BE ISSUED.

#### **2. ELIGIBILITY**

The candidates who fulfill the following criteria are eligible for admission into MBBS/BDS courses. They have to apply online and upload the original certificates for online verification and for inclusion in merit list for Competent Authority Quota seats in colleges affiliated to Kaloji Narayana Rao University of Health Sciences, Telangana, Warangal.

a) The candidates should be Indian Nationals/Person of Indian Origin (PIO)/Overseas Citizens of India (OCI) card holder (PIO/OCI status issued before 04-03-2021) and shall fulfill the provisions notified in G.O.Ms.No. 33 dated 19-07-2024, HM&FW dept.

**b) Educational qualifications: In accordance with NMC Regulations**

Candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology) / Biotechnology and English.

- OC candidates including candidates seeking EWS reservation should obtain not less than 50% marks in science subjects.
- BC/SC/ST candidates should obtain not less than 40% marks in science subjects.
- OC PWD candidates should obtain not less than 45% marks in science subjects.

**c) Age:**

Candidate should have completed 17 years of age as on 31-12- 2024. Candidates who do not complete 17 years as on 31-12- 2024 are not eligible for admission.

**2.1.** Candidates shall secure the following of cutoff scores or above in National Eligibility- cum- Entrance Test (NEET) UG -2024.

**2.2 ELIGIBILITY CONDITIONS IN RESPECT OF CANDIDATES WHO ARE DOMICILE OF TELANGANA**

A candidate for admission into MBBS/BDS courses under Competent Authority Quota in Telangana should be Indian Nationals (or) Person of Indian Origin (PIO) Overseas Citizens of India (OCI) card holder (PIO/OCI status issued before 04-03-

2021) and shall fulfill the following provisions (G.O.Ms.No. 33 HM&FW(C1) Dept. Dated: 19-7-2024).

i) If the candidate has studied in an Educational Institutions in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in relevant qualifying examination.

or

ii) Where during the whole or any part of the four consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared for the relevant qualifying examination, he has not studied in Educational Institutions, if he had resided in that local area for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination, in which he appeared or as the case may be first appeared.

iii) Local area herein means the State of Telangana. Further, in case the candidate has not studied in any educational institution and has resided in the local area as stated at (ii) above, to be eligible for admission into Under graduate courses under Competent Authority Quota, the candidate should have appeared for the relevant qualifying examination in the State of Telangana.

### **3. ADMISSIONS :**

**3.1** Admissions shall be in accordance with G.O.Ms.No.114 HM&FW(C1) Dept. Dated: 5-7-2017 subsequent amendments, G.O.Ms.No. 125, HM&FW(C1) Dept., dated: 22.09.2022, G.O.Ms.No.75 HM&FW(C1) Dept. Dated: 4-7-2023, G.O.Ms.No.33 HM&FW(C1) Dept. Dated: 19-7-2024 and relevant Hon'ble Supreme Court/High Court orders.

**IMPORTANT NOTE: Candidates who are domiciles of other States are not eligible.**

**3.2** The verification and registration fee once paid will not be refunded or adjusted to a future date. Therefore candidates are advised to check eligibility

conditions thoroughly before applying for determining state merit position in respective categories for Competent Authority Quota seats using NEET-UG-2024 rank.

#### **4. RESERVATIONS:**

##### **A. RESERVATION FOR SCHEDULED CASTES (S.C.) AND SCHEDULED TRIBES (S.T.):**

15% seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Castes.

10% of seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Tribes as per G.O.Ms.No. 33, Tribal Welfare Department, dated.30.09.2022.

Candidates of the Scheduled Castes and Scheduled Tribes belonging to the State of Telangana for castes which are notified by the Government of Telangana from time to time shall be considered for reservations.

##### **B. RESERVATION FOR BACKWARD CLASSES:**

➤ 29% of the Competent Authority Quota seats for MBBS/ BDS shall be reserved for candidates belonging to Backward Classes as follows:

- BC-A -7%, BC-B-10%, BC-C-1%, BC-D-7% & BC-E\*-4% as per the G.O.Ms.No.1793, Education, dt.23.09.1970 and G.O.Ms.No.23, Backward Classes Welfare (C2), dated. 07.07.2007 and G.O.Ms.No.231, Health Medical and Family Welfare (E1) Department, dated 11.07.2007.and G.O.Ms.NO. 114 HM&FW (C1) Dept. Dated: 05-07-2017 and subsequent amendments.
- Candidates of the Backward Classes belonging to the State of Telangana shall be considered for reservations for BC castes, which are notified by the Telangana Government as Backward classes from time to time.

##### **SOCIAL STATUS CERTIFICATE:**

The candidates belonging to Scheduled Castes, Scheduled Tribes and Backward Classes shall furnish a latest caste certificate in the prescribed proforma issued by Competent Authority in support of their claims. The social status of

Schedule Castes, Scheduled Tribes and Backward Classes candidates shall be scrutinized in terms of G.O.M.s.No.58, SW (J) Dept. Dt. 12-05-1997 and subsequent amendments, Orders of Government of Telangana and orders of Hon'ble High Court.

No candidate seeking reservation for admission under the above categories is eligible under reserved category unless the candidate produces the Integrated Community Certificate prescribed by the Government and issued by the Revenue Authorities in the Government (Vide G.O.Ms.No. 58, Social Welfare (J) Department, dated. 12-05-1997). The castes notified by Government of Telangana for implementation of reservations only will be considered.

**Note :-** The Social Reservation provided for BC's SCs, ST's in the ratio of 29%,15% and 10%respectively shall be vertical reservation.

**MINORITY STATUS CERTIFICATE:**

Candidates belonging to Muslim Minority category should furnish a certificate in support of their claim. Competent Authority Quota seats in Un-aided Private Minority Medical Colleges are reserved for Muslim Minority candidates only.

**C. RESERVATION FOR EWS CATEGORY :**

10% of total seats in Government Medical / Dental Colleges (Seats specifically sanctioned for EWS Reservation implementation by NMC/DCI in 7 Government Medical Colleges and 1 Government Dental College are reserved for economically weaker section (EWS) category candidates who are not covered under the existing scheme of reservation for SC,ST & Socially and Educationally Backward Classes. These reservations will be implemented from specially sanctioned seats for implementation of EWS reservations which are exclusively permitted for implementation of EWS Reservation by National Medical Commission /Medical Council / Dental Council / Ministry of Health Government of India in specified in 7 Government Medical Colleges and 1 Government Dental College (vide GO.Ms. No.47, HM&FW (C1), Department, Dated 21.06.19)

Candidates claiming reservation under EWS Category shall obtain the relevant latest EWS certificate valid for 2024-25 for reservation under economically weaker section issued by Tahsildar, who is the Competent Authority in state of

Telangana for issue of EWS Certificate.

**D. RESERVATION FOR WOMEN CANDIDATES**

33 1/3% of seats are guaranteed for women candidates in each category, This regulation of guarantee shall not be applicable if women candidates are selected on merit in each category for 33 1/3% or more of the seats therein.

**E. HORIZONTAL RESERVATIONS FOR SPECIAL CATEGORIES**

**i. RESERVATIONS UNDER THE CATEGORIES OF CAP / PERSONS WITH DISABILITIES (PWD) AND POLICE MARTYR'S CHILDREN (PMC)**

Seats shall be reserved in each course and in each category for the following to the extent indicated against them:

a. CAP (Army)	:	1 %
b. Persons With Disabilities (PWD)	:	5 %
c. Police Martyrs Children (PMC)	:	0.25%

**ii. PWD RESERVATIONS :**

The guidelines of Government of India and regulations of National Medical Commission/Medical Council of India shall be followed in making admissions of Persons With Disabilities (PWD).

- The candidate seeking admission under PWD reservation should apply under PWD Category in online application.
- The Medical Board shall be constituted by the University as per GO.MS.21, HM&FW (C1), Department, Dated:10-04-2017 to assess the percentage of disability as per Medical Council of India/National Medical Commission regulations. Candidates claiming reservation under PWD quota should present themselves before the Board constituted by University for evaluation of PWD percentage and confirmation of eligibility. The decision of Medical Board specially constituted for this purpose is final and binding on the candidates. The schedule for evaluation by Medical Board will be displayed on KNRUHS website.

**iii. RESERVATIONS FOR ANGLO INDIANS:**

One (1) BDS seat in Government Dental College, Hyderabad, shall be reserved for Anglo Indian candidate from un-reserved seats. The candidates shall produce certificate in support of his / her claim in the prescribed proforma issued by Mandal Revenue Officer subject to scrutiny and conformation by the Secretary, Department of Minority Welfare, Government of Telangana.

**iv. RESERVATION FOR CHILDREN OF EMPLOYEES OF SINGARENI COLLIERIES IN RAMAGUNDAM GOVERNMENT MEDICAL COLLEGE:**

Out of 150 MBBS seats of Ramagundam Government Medical College, 5% of the 127 seats under state quota (after deducting 23 seats of All India Quota) rounded up to Seven (7) seats shall be reserved for children of employees of Singareni Collieries. SC,ST,BC category reservations shall be applicable and allotment will be based on NEET Merit in respective categories. The candidate shall produce a certificate in support of his/her claim from the Managing Director, Singareni Collieries to avail of this reservation".

**v. GRACE MARKS FOR NCC CADETS:**

NCC cadets (who have obtained NCC certificates prior to qualifying exam i.e. intermediate or its equivalent) who have qualified NEET UG and who have applied for admission, shall be provided with grace marks to be added to NEET score as follows:

<b><u>Category</u></b>	<b><u>% of Grace Marks</u></b>
i. Participation in Republic Day Camp (RDC)	: 7%
ii. Participation in Thal Sainik Camp (TSC)/Vayu Sainik Camp (VSC) /Nau Sainik Camp (NSC)	: 5%
iii. NCC 'B' Certificate	: 3%

The Director NCC, Telangana State shall depute officers to the

verification centre as per the requisition from Registrar, KNRUHS, Warangal. The verification officers shall submit candidate wise verified certificates list to Registrar, KNRUHS. The decision of verification officers is final with respect to verification of above certificates. KNRUHS will prepare merit list after addition of grace marks as per the verified data submitted by the Directorate of NCC

#### **5. APPLICATIONS THROUGH ONLINE:**

a. The on-line application form for determining merit position in respective categories for Competent Authority Quota seats using NEET-UG-2024 rank will be available on the website <https://tsmedadm.tsche.in/> from **06.00 AM on 04 -08-2024 upto 6.00 PM. on 13-08-2024.**

**Note:** The candidates are advised to take a print out of the Prospectus / Instructions to fill the application form from the website <http://www.knruhs.telangana.gov.in/> or from <https://tsmedadm.tsche.in/> before proceeding to fill the application form.

b. The candidate should fill the online application form available in the Website with the data required for through computer. The online application form can be filled through any computer with internet connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) (step-1) and ready to enter his/her correct data and upload the photo, signature and original certificates, after the payment of application fee through Online.

- e. The Admission Committee shall have power to review the selection in case of any errors, misrepresentation or glaring injustice and cancel the selection/admission. ## **10. ADMISSION RULES**

- a. The letter of allotment for admission of selected candidate will have to be

- b. Undertaking in the form of Affidavit on Rs. 100 /- Non-Judicial Stamp paper by the Parent and candidate stating that all the certificates including the caste and category certificates are genuine and they are responsible for any further consequences as per law shall be submitted at the time admission. - c. If a student absents continuously for a period of 91 days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
  - b. If the break of study (91 days are more) in more than one spell, the candidate's representation in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.
  - c. Candidates who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission in to the course and the studentship stands cancel without any further notice.
  - d. The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the National Medical Commission from time to time.
  - e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course
15. **College Regulations:** Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Candidates are informed that their correspondence with the university shall be forwarded by the Principal of college with his remarks. (through proper channel) for consideration. **16. CLOSURE OF ADMISSIONS:**

The admissions shall be closed as per the schedule notified by the University as per NMC/DCI Regulations.

**17. COMMENCEMENT OF THE COURSE:** The course shall commence as per the schedule notified by National Medical Commission/Dental Council of India. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.

**18. POWERS OF PRINCIPALS:**

Notwithstanding anything contained in these regulations, the Principals of Medical Colleges in the State may at any time before completion of the Under Graduate course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause **notice to** submit a written explanation and or on a personal hearing, order the cancellation of admission to the course, if in his opinion, such candidate had furnished incorrect particulars or false information in the application form or in the documents attached thereto or in the Statements made either before the authority In-charge of admissions or the Principal or any other manner. Against any such order of the Principal, an appeal shall lie to the Registrar, KNR University of Health Sciences, Telangana.

**19.
