### MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2024-25

#### NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR SECOND PHASE OF COUNSELING

In continuation to this office notifications dated: 03-08-2024, 12-08-2024, 27-08-2024, 21-09-2024, 24-09-2024, 26-09-2024, Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of second phase of web based counseling for vacant seats under Competent Authority Quota (C.Q) for MBBS course including EWS, PWD, PMC, CAP categories for 2024-25 in Government, Private un-aided Minority/Non-Minority Medical Colleges in the State of Telangana.

Candidates whose names are notified as eligible candidates in the provisional final merit list of UG Medical Admissions on the KNRUHS website on 26-09-2024 and addendums are eligible to exercise web - options online from computer with internet connection.

All the eligible candidates whose names are displayed in the Provisional final merit list including PWD, PMC, CAP categories and EWS quota candidates and addendums on KNRUHS website can exercise web options for admission into MBBS seats from **1.00 P.M. on 04.10.2024 to 1.00 P.M. on 06.10.2024** through website **https://tsmedadm.tsche.in/** subject to following conditions:

- The Candidates who were allotted seats in the first phase of counseling and have not reported/discontinued the course after joining at the respective college are not eligible for exercising options.
- 2. Candidates who have not exercised web options in the first phase of counseling are not eligible to exercise web options.
- 3. The candidates who were allotted MBBS seats in the first phase of counseling and joined the course and continuing in the course are eligible to exercise web options and are informed to exercise web options.

For eligibility criteria and regulations refer to notifications dated: 03.08.2024.

UNIVERSITY FEE: Allotted Candidates have to pay University fee of Rs. 12,000/forMBBS Course through payment Gateway by using Online
payment method. (Debit Card/Credit Card/Internet
Banking) and download the allotment letter. Candidates
who have paid University fee in the first phase need not pay
again.

**TUITION FEE:** Tuition fee is to be paid at respective Medical colleges.

The tuition fee payable as notified by Government of Telangana (notified on KNRUHS web site)

#### **NOTE:**

- The details of vacant seats available (seat matrix) are placed in the website <a href="http://knruhs.telangana.gov.in">http://knruhs.telangana.gov.in</a>. Candidates can exercise web options for MBBS seats in all Medical colleges affiliated to KNRUHS through <a href="https://tsmedadm.tsche.in/">https://tsmedadm.tsche.in/</a>.
- 2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Medical and Family Welfare (C1) Department Dated: 22.09.2022, G.O. Ms. No. 75, Health, Medical and Family Welfare (C1) Department Dated: 04-07-2023, G.O. Ms. No. 33, Health, Medical and Family Welfare (C1) Department Dated: 19-07-2024, and relevant Hon'ble High Court/Supreme court orders and University regulations.
- 3. Candidates are informed that if they exercise web- options for a seat and are allotted a MBBS seat as per their choice in the web- counseling and if they do not join the course at the allotted college, they will not be eligible for exercising web- options for subsequent round of counseling.
- **4.** Candidates are informed that the allotments/admissions are subject to Orders of Hon'ble Courts in all pending cases.

## IMPORTANT INSTRUCTIONS TO THE CANDIDATES:

1) Eligible NEET-UG-2024 qualified candidates as per provisional final merit

- list for Competent Authority Quota can exercise web options for vacant MBBS seats in Medical colleges as per their interest and priority through <a href="https://tsmedadm.tsche.in/">https://tsmedadm.tsche.in/</a> from computer with internet connection.
- 2) Candidates are advised to go through the Prospectus for the Regulations for MBBS course and Government Orders on Rules of Admission on KNRUHS website before exercising web-options.
- 3) Competent Authority Quota seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Competent Authority Quota seats in other Medical Colleges.
- 4) If a candidate is allotted a seat in MBBS course as per his/her web-options and does not join the course, they shall not be permitted to exercise web options in subsequent phase of counseling and admission to prevent seat blocking.
- 5) Candidates exercising web-options for MBBS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidate's eligibility. If candidates are not interested to join in any college, they should not exercise weboptions for the same.
- 6) Candidates are advised to exercise web options for MBBS seats in all colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in first phase of counseling to other seats as per their web options in the second phase of counseling
- 7) If a seat is allotted in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the seat allotted in 1st phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore, candidates are informed to exercise web options carefully for sliding with awareness of this fact.
- 8) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read construction to the candidates

before giving options)

- 9) Candidates are instructed to take a print out of saved options.
- 10) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on <a href="https://tsmedadm.tsche.in/">https://tsmedadm.tsche.in/</a> website after each phase of counseling without fail.
- 11) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective college on or before the date specified on the allotment letter.
- 12) Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and the candidates shall not be permitted to exercise web-options for subsequent phase of counseling and admission to prevent seat blocking.
- 13) If the candidate slides to other college during second phase of counseling in colleges affiliated to KNRUHS, the candidates have to get relieved from first phase joined college, collect original certificates, collect fees and report to the Principal of allotted college before last date of joining. Candidates who do not join the course at the allotted college in this phase of counseling are not eligible for further phase of counseling.
- 14) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted Medical College and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 15) NMC has stated that The Government of India will decide and notify the agency and method of counseling of all undergraduate seats. MCC

Information Bulletin for 2024-25 states that in supersession to previous

counselling scheme, it has been decided by the Competent Authority (MoHFW)

that upgradation will be allowed up to Round 3 (Mop Up Round). Hence,

candidates are informed that they will be permitted for upgradation/sliding till

Mop Up phase of Counselling. Admitted candidates shall not be permitted to

discontinue the course after allotment in Mop Up phase of Counselling.

16) In accordance with the above clause for upgradation, admitted candidates upto

second round shall be permitted for upgradation to Mop Up round of

Counselling. Admitted candidates are not permitted to withdraw from the

course after Mop Up phase of counselling. Hence, candidates are advised to

take a calculated decision of continuing in the Mop up phase of Counselling as

they would not be permitted to resign from allotted seat in Mop up phase of

Counselling.

17) Original certificates submitted at the time of admissions shall not be

returned to candidate, unless the candidate discontinues the course before

Mop Up phase of counseling or before the last date for free exit to be

notified by the University.

18) The University fee once paid shall not be refunded under any

circumstances.
