REGULATIONS FOR ADMISSION INTO BAMS / BHMS/ BNYS/BUMS COURSES UNDER COMPETENT AUTHORITY QUOTA FOR THE ACADEMIC YEAR 2024-25

Regulations:

The following are the Regulations for admission into **BAMS / BHMS / BNYS AND BUMS** Courses in all the AYUSH Colleges affiliated to KNRUHS for the academic year 2024-25 under Competent Authority Quota.

I. Number of seats under Competent Authority Quota:

Total number of seats for the academic year 2024-25 in UG AYUSH Courses after exclusion of 15% seats to All India Quota in AYUSH Colleges affiliated to KNR University of Health Sciences, Warangal shall be notified on KNRUHS website before counseling.

- 1. In case any **BAMS / BHMS / BNYS AND BUMS** seats are permitted by NCISM /NCH in colleges affiliated to the University for the Academic Year 2024-25, those seats also will be filled up. NO FURTHER NOTIFICATION WILL BE ISSUED.
- **2. Tuition Fee** will be as notified by the Government of Telangana.
- **3. Age:** The Candidate should have completed 17 years of age as on 31-12-2024. The candidates who do not complete 17 years as on 31-12-2024 are not eligible for admission.

Further, there is no upper age limit for admission to UG-AYUSH courses.

NOTE:

- a) Age shall be calculated on the basis of date of birth as mentioned in the Secondary School Certificate.
 - b) Relaxation of age eligibility criteria of a candidate will not be permitted for under aged candidates.

NOTE: The candidates should secure marks of cutoff scores and above in National Eligibility-cum- Entrance Test NEET UG -2024 for admission into UG AYUSH Courses.

4. Eligibility for admission into BAMS / BHMS / BNYS and BUMS:

In accordance with NCISM Regulations as follows:

a) Qualifications for admission into BAMS / BHMS / BNYS

The candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology) / and English.

- OC candidates including candidates seeking EWS reservation should obtain not less than 50% marks in science subjects.
- BC/SC/ST candidates should obtain not less than 40% marks in science subjects.
- OC PWD candidates should obtain not less than 45% marks in science subjects.

b) Qualifications for admission into BUMS Course as per Regulations of National Commission for Indian System of Medicine (NCISM)

Admissions to Kamil-E-TIB-Wa-Jarahat course: A candidate seeking admission to main Kamil-E-Tib-Wa-Jarahat (Bachelor of Unani Medicine and Surgery – B.U.M.S.) Course must have passed.

- (i) The candidate shall have passed 10+2 or its equivalent examination from any recognized Board with Physics, Chemistry and Biology and shall have obtained a minimum of fifty per cent marks taken together in Physics, Chemistry and Biology in the case of General category and forty per cent. marks in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes: Provided that in respect of persons with disability candidate specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum qualifying marks in the said examinations shall be forty-five per cent. in the case of General category and forty per cent in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.
- (ii) Candidate shall have passed Urdu or Arabic or Persian language as one of the subjects in the 10th Standard or in 12th Standard.
- (iii) Candidate who is not covered under clause (b) shall have to study Urdu language along with Arabic and Mantiq wa Falsafa (Logic and Philosophy) as a subject during the First Professional B.U.M.S. session.
- (iv) The Pre-Tib examination shall be for one-year duration.

5. Eligibility for admission under Competent Authority Quota (as per G.O.Ms.No. 138 HM&FW(C1) Dept. Dated: 04-10-2024):

Nationality & Domicile: A candidate for admission into Undergraduate AYUSH courses under Competent Authority Quota in Telangana should be Indian National/Person of Indian Origin (PIO)/Overseas Citizens of India (OCI) card holder and shall fulfill the following conditions

i) The candidate should have studied in the Educational Institutions in the state of Telangana for a period of not less than four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in the relevant qualifying examination.

or

- ii) Where during; the whole or any part of the four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared for the relevant qualifying examination, he has not studied in Educational Institutions, he should have resided in the state of Telangana for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination, in which he appeared or as the case may be first appeared.
- iii) Further, in case the candidate has not studied in any educational institution and has resided in the state of Telangana as stated at (ii) above, to be eligible for admission into Undergraduate AYUSH courses under Competent Authority Quota, the candidate should have appeared for the relevant qualifying examination in the State of Telangana.

NOTE: Domiciles of other states are not eligible for Competent Authority Quota seats in the state of Telangana.

The verification and registration fee once paid will not be refunded or adjusted to a future date. Therefore, candidates are advised to check eligibility conditions thoroughly before applying on- line for determining state merit position in respective categories for Competent Authority seats.

6. Reservations:

A. Reservation for Scheduled Castes (S.C.) and Scheduled Tribes (S.T.):

15% seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Castes.

10% of seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Tribes as per G.O.Ms.No. 33, Tribal Welfare Department, dated. 30.09.2022

- 6.1 In the event that if any seats reserved for S.T. not being filled up, they will be allotted to the candidates belonging to the Scheduled Castes and vice-versa.
- 6.2 In the event of the candidates from the SC and ST are not being available, these seats shall be allotted to the candidates under open category.
- 6.3 Candidates of the Scheduled Castes and Scheduled Tribes belonging to the State of Telangana for castes which are specified by the Government of Telangana from time to time shall be considered for reservations.

B. Reservation for Backward Classes:

29% of seats under Competent Authority Quota shall be reserved for candidates belonging to Backward Classes as follows:

- BC-A -7%, BC-B-10%, BC-C-1%, BC-D-7% & BC-E-4%
- Candidates of the Backward Classes belonging to the State of Telangana shall be considered for BC reservations for BC castes, which are notified by the Government of Telangana as Backward classes from time to time.
- If qualified candidates belonging to Backward Class of particular group are not available, the left over seats can be adjusted for the candidates of next group. If qualified candidates belonging to Backward Classes are not available to fill up the 29% seats reserved for them, the left over seats shall be treated as Open Category seats and shall be filled up with candidates by merit.

C. Social Status Certificate:

Backward Classes shall furnish a latest certificate in the prescribed proforma issued by competent authority in support of their claims. The social status of Schedule Castes, Scheduled Tribes and Backward Classes candidates shall be Scrutinized in terms of G.O.M.s.No.58, SW (J) Dept. Dt. 12-05-1997 and subsequent amendments and orders of Hon'ble High Court. The candidates are informed that they will not be considered for the caste claimed by them without the prescribed permanent caste certificate issued by the competent authority of Government of Telangana.

No candidate seeking reservation for admission under the above categories be allowed to participate in the Counseling for admission unless candidate produces the Integrated Community Certificate prescribed by the Government and issued by the Revenue Authorities in the Government (Vide G.O.Ms.No. 58, Social Welfare (J) Department, dated. 12-05-1997).

D. Reservation for EWS category:

10% of total seats in specified Government Ayush Colleges (Specified for EWS Reservation implementation) are reserved for Economically Weaker Section (EWS) Category candidates who are not covered under the existing scheme of reservation for SC,ST & Socially and Educationally Backward Classes. These reservations will be implemented from seats sanctioned for implementation of EWS reservations by Ministry of Ayush, Government of India.

Open category candidates claiming reservation under EWS Category shall obtain the relevant EWS certificate for reservation under Economically Weaker Section valid for that year issued by Tahsildars who is the Competent Authority in state of Telangana for issue of EWS Certificate.

7. Reservation for Women Candidates:

33 1/3% of seats shall be reserved for women candidates in each category; This regulation of guarantee shall not be applicable if women candidates are selected on merit in each category from 33 1/3% or more of the seats therein.

8. Special category reservations under the categories of CAP, Persons with Disability (PWD).

Seats shall be reserved in each course and in each category for the following to the extent indicated against them:

A CAP (Army) : 1%

B Persons With Disabilities (PWD) : 5 %

NOTE:

i) Reservation under CAP Category: 1% for children of Ex-Service men & Serving personnel of 3 wings of defense service viz., Army, Navy & Air-Force. The above reservation is applicable to the children of Ex-Service men & Serving personnel of 3 wings of defense service viz., Army, Navy & Air-Force., who are domiciled in Telangana based on the Permanent address / Home town declared by them while joining service and as recorded in their service register. (Vide G.O.M.S.No.166 HM&FW (E2) Dept. Dated: 23-09-2023).

ii) The guidelines of Govt. of India and regulations of NCH, NCISM/NMC shall be observed in making admissions of Persons With Disabilities (PWD) candidates.

The Medical Board constituted by the University as per G. O. Ms. No.166, HM&FW (E2) Dept, Dated: 23.09.2023, will assess the percentage of disability as per Medical Council of India regulations. Candidates claiming reservation under PWD quota should present themselves before the Board constituted by University for evaluation of PWD percentage and confirmation of eligibility. The decision of Medical Board specially constituted for this purpose is final and binding on the candidates. The schedule for evaluation by Medical Board will be displayed on KNRUHS website.

The candidate seeking the benefit of reservation should present him/herself before a Medical Board comprising of at least one Expert/Specialist from the specialty of Orthopedics, Department of Medicine, Neurology, Hematology of the rank of Professor constituted by KNR UHS, Warangal.

The candidate who claim for admission under Persons with Disabilities (PWD) category shall mention in the online application as applying under PWD category and have to appear before Medical Board to be constituted for the purpose by the university as per the schedule to be notified by the university for eligibility under PWD status.

C) Grace Marks for NCC Cadets:

NCC cadets (who have obtained NCC certificates prior to qualifying exam i.e. intermediate or its equivalent) who have qualified NEET UG and who have applied for admission, shall be provided with grace marks to be added to NEET score as follows:

<u>Category</u>

% of Grace Marks

a]. Participation in Republic Day Camp (RDC) : 7%

b]. Participation in Thal Sainik Camp (TSC)/Vayu

Sainik Camp (VSC) / Nau Sainik Camp (NSC) : 5%

c]. NCC 'B' Certificate : 3%

The Director NCC, Telangana State shall depute officers to the verification centre as per the requisition from Registrar, KNRUHS, Warangal. The verification officers shall submit candidate wise verified certificates list to Registrar, KNRUHS.

The decision of verification officers is final with respect to verification of above certificates. KNRUHS will prepare merit list after addition of grace marks as per the verified data submitted by the Directorate of NCC.

9. Online Applications:

9.1. The on-line application form for determining merit position in respective categories for Competent Authority quota seats using NEET UG-2024 scores will be available on the website https://tsbahnu.tsche.in from 8.00 AM on 06-10-2024 upto 6.00 PM. on 13-10-2024.

Note: The candidates are advised to take a print out of the Prospectus / Instructions

with the data required for through computer. The online application form can be filled through any computer with internet connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) (step-1) and ready to enter his/her correct data and upload the necessary certificates, photo and signature after the payment of application fee through Online.




1. Open the website https://tsbahnu.tsche.in Home page displayed as follows.

- 2. Monitor Resolution to be set to maximum, **Best viewed in 1920 X1080 pixels**.





- 11.3 Undertaking in the form of Affidavit on Rs. 20 /- Stamp paper by the Parent and candidate stating that the caste and area mentioned in the certificates are genuine and they will be held responsible for any further consequences as per law, if any discrepancy noticed to be submitted at the time admission.

12. Merit Lists:

- 12.1 The final merit position of the candidates who have applied online in response to the notification issued by KNR University Of Health Sciences for Competent Authority Quota seats into BAMS / BHMS / BNYS and BUMS courses shall be determined by NEET-UG-2024 scores and as per their eligibility criteria, applicable regulations, guidelines and reservation policies viz:
- 12.2 The University will release final merit list of eligible candidates for exercising web options after verification of original certificates by the University and officials of concerned departments.

Note: Candidates who have applied online in response to this office notification for determining merit position for Competent Authority Quota seats shall upload the original certificates online along with the application. Candidates have to submit one set of print out of application form, original certificates and self attested copies of certificates at allotted college at the time of admission for verification. In case of any discrepancy, allotment of admission is cancelled.

13. Counseling

- 13.1 Provisional final merit list will be displayed on KNRUHS website after scrutiny of original certificates and application. Notification for exercising web options will be issued separately on KNRUHS website only. No individual communications will be sent. Candidates are informed to check the website regularly for notifications.
- 13.2 On-line application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET– UG 2024 Rank.

14. Allotment of seats:

Allotment of seats shall be done through web-counseling by the Committee of Admissions appointed by Competent Authority duly considering the web-options of the candidate by merit.

- 15. Selected candidates have to join the college within the specified date by submitting all Original Certificates, Bond, and pay the tuition fee as fixed by the Government to complete the process of admission. If the candidate does not report within the specified time and complete the process as described before the admission will be automatically cancelled.
- **16. University Fee:** Candidates have to pay the University fee of Rs 8,000/- by way of payment gate way and obtain the allotment letter.
- 17. Tuition Fee will be as notified by the Government of Telangana.

18. Discontinuation fee:

Candidates cannot discontinue from the course after notification for final round of web-counseling/notification for last date of free exit or later. Candidates have to pay Bond amount of Rs. 1,00,000/- (Rupees One Lakh only) if they discontinue the course after notification of final round of counseling or later.

- **19. Closure of admissions**: The admission shall be closed as per NCISM/NCH schedule. Any vacancy after closure of admission or that arises after closure of admission shall not be filled.
- **20.** Admitted candidates shall follow the regulations issued by Apex bodies i.e. NCISM, NCH and Ministry of AYUSH from time to time.

21. Powers of the Selection Committee:

The selection committee shall have the powers to revise its decision if any case and to direct the Principal concerned to take further action either to select or to cancel the selection or to admit or cancel the admission before the closure of admissions. Selections shall not be questioned after closure of admissions.

22. Power of the Principal:

Notwithstanding anything contained in the foregoing Regulations the Principal of the College may at any time either suo-moto or an application made by any persons after due and proper enquiry, if satisfied that the candidate has furnished incorrect information or enclosed false certificate, or fraudulently obtained admission may for the reason to be recorded in writing by order cancel his / her admission, provided that no such admission shall be cancelled without giving reasonable opportunity of showing cause as to why his / her admission should not be cancelled.

23. Powers of KNR University of Health Sciences:

KNR University of Health Sciences may either suo-moto or on an application made to them can call for and examine the records relating to any selection or admission or cancellation there off in respect of admission made by concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation there to as they deem-fit including cancellation of the selection already published or admission already made, provided that the University may before cancelling such selection or admission give an opportunity to the authority and to the person affected to show-cause against such cancellation.

To admit any person or retain any student whose conduct is pre-judicial to the interests of the University, or the rights and privileges of other students and teachers.

24. Sanction of leave beyond (3) months and termination of studentship:

a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals). If a student absents continuously for a period of (91) days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and be permitted for Readmission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.

- b. If the break of study (91 days or more) is in more than one spell, the candidate's application in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council.
- c. Candidates, who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission into the course and the studentship stands cancelled without any further notice.
- d. The candidate has to pass within the final examination for award of Degree for the course double the duration of study period for the course or within the maximum period permitted by the NCISM/NCH from time to time.
- e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course".
