### **BDS ADMISSIONS UNDER MANAGEMENT QUOTA 2024-25**

## Notification for exercising web-options for second phase of counseling

In continuation to this office notifications dated: 17-08-2024, 27-09-2024, 29-09-2024, 03-10-2024 and 08-10-2024 KNRUHS hereby notifies the conduct of second phase of web-based counseling for vacant seats after first phase of Counselling for admission into BDS courses under Management Quota for 2024-25 in affiliated Private **Dental** Colleges and **Army College of Dental Sciences** 

Candidates who are notified in the provisional final merit list of MBBS/BDS Admissions under Management Quota on the KNRUHS website on 29-09-2024 are eligible to exercise web - options online from computer with internet connection.

All the eligible candidates whose names are displayed in the Provisional final merit list for Management Quota on KNR UHS website can exercise web options for admission into MBBS/BDS courses from <u>6.00 AM on 14.10.2024 to 3.00 PM on 15.10.2024</u> through <a href="https://tspvtmedadm.tsche.in/">https://tspvtmedadm.tsche.in/</a> as per the candidates registration and eligibility for B & C (NRI) categories subject to following conditions:

- 1. The Candidates who were allotted seats in the first phase of counseling under Management Quota and have not reported/discontinued the BDS course at the respective college are not eligible for exercising options for BDS course.
- **2.** Candidates who have not exercised web options in the first phase of counseling for BDS course under Management Quota are not eligible to exercise web options for that course.
- **3.** Candidates who have joined BDS course under Management Quota in the first phase and continuing in the course are eligible to exercise web options and are informed to exercise web options.

Candidates will have to exercise web options for the BDS seats in order of preference for course and colleges and category (B&C/NRI).

For eligibility criteria and regulations refer to notifications dated: 17.08.2024

#### **UNIVERSITY FEE:**

Allotted Candidates have to pay the following University fee through payment gateway by using online payment method (Debit Card/Credit Card/Internet Banking) and down-load the allotment letter. Candidates who have paid University fee in the first phase need not pay again.

**TUITION FEE:** Tuition fee is to be paid at respective Dental colleges.

The tuition fee payable as notified by Government of Telangana in GO Ms No:106, HM& FW (C1) Department, Dated:28. 07.2023 (notified on KNRUHS web site)

#### **NOTE:**

- 1) The details of vacant seats available (seat matrix) are placed in the website <a href="http://knruhs.telangana.gov.in">http://knruhs.telangana.gov.in</a> Candidates can exercise web options for BDS seats in all Dental Colleges under KNRUHS through <a href="https://tspvtmedadm.tsche.in/">https://tspvtmedadm.tsche.in/</a>
- 2) In accordance with the GO.Ms.No.130 HM&FW (C1) Department, Dated: 27.09.2022 in Management Quota B Category, 85% of seats are reserved for local candidates of Telangana and 15% seats are open to candidates from all over the country. 15% unreserved seats shall be allotted first followed by seats reserved for local candidates in Management Quota B category seats.
- 3) The allotment of seats will be made in accordance with the selection procedure notified in Government Orders G.O.Ms.No. 115 & 116 HM&FW (C1) Dept. Dated: 05-07-2017, G.O.Ms.No.117 & 118 HM&FW(C1)Dept. Dated: 20-07-2017, subsequent amendments, G.O.Ms.No.125, 126, 127, HM&FW (C1), Department, Dated:22-09-2022, GO.Ms.No.130 HM&FW (C1) Department, Dated:27.09.2022, G.O.Ms.No.33 HM&FW (C1) Department (for Local area), Dated: 19.07.2024, other Government orders, University Regulations and relevant Hon'ble Supreme Court and High Court orders.

- 4) Candidates are informed that they will be considered only to the category/categories to which they have registered. (B/NRI)
- 5) Candidates are informed that if they exercise web- options for a seat and allotted a BDS seat as per their choice in the web- counseling and if they do not join the course at the allotted college, they will not be eligible for exercising web- options for subsequent rounds of counseling.

#### **IMPORTANT INSTRUCTIONS TO CANDIDATES:**

- 1) Eligible NEET-UG-2024 Candidates as per Provisional Final Merit List for Management Quota can exercise web options for vacant seats under Management Quota in all Dental colleges as per their interest and priority from computer with internet connection through <a href="https://tspvtmedadm.tsche.in/">https://tspvtmedadm.tsche.in/</a>
- **2)** Candidates are advised to go through the Prospectus for the Regulations for MBBS/BDS courses under Management Quota of KNRUHS, available on website before exercising web options.
- 3) If a candidate is allotted a seat in BDS course as per his/her options and does not join the course, he/she shall not be permitted to exercise web options in subsequent phases of counseling and admission to prevent seat blocking. If candidates are not interested to join in any college they should not exercise web options for the same.
- 4) Candidates are advised to exercise web options for BDS seats in all colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in first phase of counseling to other seats as per their web options in the second phase of counseling.
- a BDS seat as per their choice in the web- counseling and if they do not join the course at the allotted college, they will not be eligible for exercising web-options for subsequent round of counseling.
- 6) If a seat is allotted in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the seat allotted in first phase of counseling will be automatically cancelled and allotted to the other

# candidate. Therefore, candidates are informed to exercise web options carefully for sliding with awareness of this fact.

- 7) Candidates exercising web-options for BDS courses are informed that there is no limit of choices (number) for exercising web-options. Candidates have to exercise web options for any number of courses/colleges the candidate is interested to join as per candidates eligibility (B/C-NRI) in order of preference.
- 8) Candidates have to exercise options for B category and if eligible for C (NRI) in order of their priority for course and college. Allotments will be made according to the order of preference in the web options exercised by the candidate.
- **9)** Allotment of Management Quota seats in Army Dental College is reserved for the wards of Army personnel as per AWES Regulations.
- **10)** Candidates can exercise options on the web either from home / any other place having internet facility. Candidates are instructed to take a print out of saved options.
- **11)** One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options.
- **12)** Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on through <a href="https://tspvtmedadm.tsche.in/">https://tspvtmedadm.tsche.in/</a> website after each phase of counseling without fail.
- 13) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using online payment method (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of respective college on or before the date specified on the allotment letter.
- **14)** Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining,

the admission will be cancelled automatically and the candidate shall not be

permitted to exercise web-options for subsequent phases of counseling and

admission to prevent seat blocking.

**15)** Candidates are hereby informed that final verification of original certificates

will be conducted at the allotted college and in case of any discrepancy, the

provisional allotment will be cancelled and action may be initiated as per

University Regulations.

16) Candidates allotted seat under NRI Quota should produce the relevant

sponsorship letter from NRI relative in Original along with copy of passport/

Residence Proof/Bank Statement or pass book of sponsor for NRI Category at

respective colleges.

**17)** MCC Information Bulletin states that in supersession to previous counseling

scheme, it has been decided by the Competent Authority (MoHFW) that up

gradation will be allowed up to Round 3 (Mop Up Round). Hence, candidates

are informed that they will be permitted for upgradation/sliding till Mop Up

phase of Counselling. Admitted candidates shall not permitted to discontinue

the course after allotment in Mop Up phase of Counselling.

**18)** Candidates are advised to take a calculated decision of continuing in the Mop

up phase of Counselling as they would not be permitted to resign from

allotted seat in Mop up phase of Counselling.

19) Original certificates submitted at the time of admissions shall not be

returned to candidate, unless the candidate discontinues the course.

**20)** The University fee once paid shall not be refunded under any circumstances.
