NOTIFICATION FOR ONLINE REGISTRATION FOR ADMISSIONS INTO B.Sc.(N) 4YDC COURSE UNDER COMPETENT AUTHORITY QUOTA FOR THE ACADEMIC YEAR 2025-26 IN THE STATE OF TELANGANA

Application forms online are invited from TG-EAPCET-2025 qualified eligible candidates for admission into the B.Sc.(N) 4 YDC course for the academic year 2025-26 under Competent Authority Quota into all Government and Private Nursing colleges affiliated to KNR University of Health Sciences, Warangal in the State of Telangana.

Notification is issued for online registration for web-based counseling to determine State Merit position for admission into Competent Authority Quota seats only. Provisional final merit list will be notified after scrutiny of all certificates uploaded at the time of online registration. Total number of seats available under Competent Authority Quota for B.Sc Nursing 4 YDC course for the academic year 2025-26 will be notified before exercising website options for counseling. Tuition fee structure will be as notified by the Government of Telangana.

Schedule for Registration of online application and uploading of original certificates:

Candidates can register on-line and upload scanned certificates from

09.00 A.M. on 16-09-2025 to 30-09-2025 upto 05.00 P.M. on web-site: https://tsparamed.tsche.in

Provisional Final Merit position of the applied candidates will be prepared based on eligibility criteria notified here under after verification of uploaded original certificates.

I. ELIGIBILITY FOR ADMISSION INTO B.SC. (NURSING) 4YDC COURSE:

A. Eligibility as Local Candidate

(as per G.O.Ms.No. 139 HM&FW(C1) Dept. Dated: 04-10-2024):

Nationality & Domicile: A candidate for admission into B.Sc. (Nursing) course under Competent Authority Quota in Telangana should be Indian National/Person of Indian Origin (PIO)/Overseas Citizens of India (OCI) card holder and shall fulfill the following conditions:

i) The candidate should have studied in the Educational Institutions in the state of Telangana for a period of not less than four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in the relevant qualifying examination.

or

- ii) Where during; the whole or any part of the four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared for the relevant qualifying examination, he has not studied in Educational Institutions, he should have resided in the state of Telangana for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination, in which he appeared or as the case may be first appeared.
- iii) Further, in case the candidate has not studied in any educational institution and has resided in the state of Telangana as stated at (ii) above, to be eligible for admission into B.Sc. (Nursing) course under Competent Authority Quota, the candidate should have appeared for the relevant qualifying examination in the State of Telangana.

NOTE: Domiciles of other states are not eligible for Competent Authority Quota seats in the state of Telangana.

B. Candidates seeking admission into B.SC.(NURSING) 4YDC course must have passed

- a) 10+2 Passed @45% aggregate of marks in science (Physics, Chemistry and Biology) and English is compulsory subject.
- b) 10+2 Passed out from recognized board under AISSCE /CBSE/ICSE/SSCE/HSCE/NIOS/TOSS or other equivalent Board with Physics, Chemistry and Biology.
- c) Intermediate Vocational with Bridge Course in Biological and Physical Sciences.
- d) Those who belong to SC, ST and BC are eligible with 40% in the Science Group subjects and English is compulsory subject as per order of the

Secretary Indian Nursing Council, New Delhi vide circular No. F.No. 1-6/2015- INC, Dated: 21-09-2015.

C. Candidates shall secure the following of cutoff scores or above in TG-EAPCET-2025 to be eligible for admissions in accordance with regulations of Indian Nursing Council.

II. AGE:

The minimum age for admission shall be 17 years on 31st December 2025 for BSC Nursing 4YDC. No upper age limit.

- III. Candidates are advised to download and read the prospectus/Regulations of the course available in the website **www.knruhs.telangana.gov.in** before filling the on-line application form and payment of application fee for admission into B.Sc NURSING 4YDC course for the academic year 2025- 26.
- IV. The eligible candidates as per the concerned regulations who desire to take admission for above courses in affiliated colleges shall apply online and upload all original certificates for determining the merit position for Telangana State Competent Authority Quota seats in the website https://tsparamed.tsche.in from 09.00 A.M. on 16-09-2025 to 30-09-2025 upto 05.00 P.M. only. The online application can be filled through any computer with internet connection.

V. REGISTRATION AND VERIFICATION FEE: The registration and verification fee Rs.2,500/- (Bank transaction charges extra) for OC and BC candidates and Rs.2,000/- (Bank transaction charges extra) for SC/ST Candidates for each course. Fee shall be paid online through Debit card / Credit card or Net Banking.**

- ➤ The process of admissions into B.Sc. (Nursing) 4-YDC course will be in accordance with the rules issued from time to time by Indian Nursing Council/Government of Telangana and Rules and Regulations of KNRUHS.
- Candidates need not send the print-out of application to the university
- VI. Merit List: Provisional final merit List for all the above courses will be displayed on the web- site of the KNRUHS after verification of the uploaded Original Certificates.

- **VIII.** Procedure for submission of filled-in online Application form and Original certificates at the time of admission for final verification:
 - a) Visit website through Computer with Internet connection to fill the application form.
 - b) Fill in all the details in the online application form and upload all the documents which are mandatory
 - c) On-line application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position.
 - d) The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
 - e) Candidates may please note that the University will take up the verification of certificates with regard to eligibility conditions i.e., educational qualifications, Local area status, category status by the concerned department officials. If the information furnished by the candidate in the

- application is incorrect, his/her candidature is liable to be cancelled and further action that deemed fit will be taken.
- f) Candidates eligibility for admission into B.Sc(N)4YDC for the academic year 2025-26 will be examined only after scrutiny of application and verification of uploaded Original certificates and provisional final merit list will be notified.
- g) Online Registration along with uploading of Scanned Original certificates will be done only once irrespective of the number of counseling. Online verification of uploaded original certificates also will be done only once. Therefore the candidates should register and upload all the mandatory Certificates without fail.
- h) Scrutiny of application and uploaded Original Certificates will be done and provisional final merit list will be released. Candidates are advised to refer to KNRUHS website for further details regarding schedule of exercising web options. No individual communication will be sent.
- i) Admissions will be in accordance with the Orders issued from time to time by, Government of Telangana, Nursing Council of India, relevant Hon'ble Supreme Court and High Court orders and University regulations.
- j) This notification is for online registration for determining the Merit position only for eligible candidates. The dates for exercising web options for admission to B.Sc(N)4YDC courses will be notified on University website. Candidates are advised to check the University web-site for notifications, counseling schedules, seat matrix and other details from time to time.
- k) An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
- I) After allotment candidate should download the allotment order, submit the print-out of the filled-in Online application form and original certificates along with (1) set of self attested copies to the Principal of allotted college at the time of joining for final Verification by admissions committee of allotted college. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
