NOTIFICATION FOR ADMISSION INTO POST GRADUATE MEDICAL DEGREE/ DIPLOMA COURSES UNDER COMPETENT AUTHORITY QUOTA FOR IN-SERVICE AND NON-SERVICE CANDIDATES FOR THE ACADEMIC YEAR 2025-26

Applications through online are invited from NEET-PG-2025 qualified candidates for admission into the Post Graduate Medical Degree / Diploma courses for the academic year 2025-26 under Competent Authority Quota into Medical Colleges affiliated to KNR University of Health Sciences and NIZAM's Institute of Medical Sciences (NIMS), Hyderabad in the State of Telangana.

Notification is issued for online registration for web-based counseling to determine State Merit position for admission into **Competent Authority Quota** seats only. Provisional and Final Merit list will be notified after scrutiny of all certificates uploaded by the candidates at the time of online registration. Total number of seats available under Competent Authority Quota for the academic year 2025-26 will be notified on KNRUHS website before exercising web options for counseling. Tuition fee payable will be as notified by the Government of Telangana as per the G.O. Ms. No.107, HM&FW(C1) dept. Dated 28-07-2023.

Cut-off score in NEET-PG-2025 Exam for Post Graduate Medical courses:

Schedule of registration of online application and uploading of certificates.

Candidates can register online and upload scanned certificates on website https://tspgmed.tsche.in from 08.00 AM on 01.10.2025 up to 05.00 PM on 08.10.2025.

Provisional and Final Merit position of the applied candidates will be prepared based on NEET- PG-2025 Rank and other eligibility criteria notified hereunder.

1. **ELIGIBILITY**:

A. ELIGIBILITY:

(As per G.O. Ms. No. 148 HM&FW(C1) Dept., dated 28-10-2024)

- i. A Candidate to be eligible for Admission into PG Medical Courses under these Rules should be an Indian National/ Person of Indian Origin/ Overseas Citizen of India card holder and be a local candidate.
- ii. Local candidate means a candidate who has studied in the Educational Institutions in the state of Telangana for a period of not less than four consecutive years ending with the academic year in which he appeared or as the case may be, first appeared in the relevant qualifying examination subject to

Explanation (a): A candidate who is regarded as a local candidate for the purpose of Admission into Undergraduate (MBBS) in the state of Telangana, but has studied in a State wide Institution outside the state of Telangana, shall also be regarded as a Local candidate.

Explanation (b): A candidate, who has secured Admission to the relevant Undergraduate course (MBBS) under Non-Local Quota in the State of Telangana, shall not be regarded as a Local candidate.

- **B.** Candidate should have qualified in NEET-PG-2025 by securing marks of Cut-off score or above as displayed above.
- **C.** Candidate should have passed MBBS/ Equivalent Degree examination from a Medical Institution in Telangana State/ Siddartha Medical College, Vijayawada (State wide institution) recognized by the National Medical Commission.
- **D.** Candidates who hold recognized Under-Graduate Medical Degree should have obtained Permanent Registration from Telangana State Medical Council after completing compulsory rotating internship.
- E. MBBS Graduates should have completed internship on or before 31-07-2025 from recognized Medical Colleges (by MCI/NMC).
- **F.** In case of in-service candidates, Government service rendered shall be calculated as on **31-08-2025**.
- **G.** Candidates from other states are not eligible for Competent Authority Quota seats.

- 2. The NEET-PG-2025 qualified and eligible candidates as per the regulations who desire to take admission into PG Medical Degree/Diploma Courses shall apply online and upload all original certificates for determining the Merit position for Telangana State under Competent Authority Quota using NEET-PG-2025 Ranks in the Website https://tspgmed.tsche.in from 08.00 AM on 01.10.2025 up to 05.00 PM on 08.10.2025 only. The online application can be filled through any computer with internet connection.
- **3. Registration and processing Fee for PG Degree/Diploma courses:** The Registration and processing fee of Rs.10,000/- (Bank transaction charges extra) is for OC & BC candidates and Rs.8000/- (Bank transaction charges extra) for SC/ST candidates. The fee shall be paid online through Debit card / Credit card or Net Banking.**
 - ** Registration and processing fee once paid shall not be refunded or adjusted to a further date.
 - ** Candidates are advised to check their eligibility to apply for determining the Merit position in respective categories by using NEET-PG-2025 Rank by reading Prospectus /Regulations carefully.
- 4. For other details read the Prospectus carefully. The Prospectus of the PG Medical courses under Competent Authority Quota is available on the University Website: http://knruhs.telangana.gov.in & https://tspgmed.tsche.in
- 5. Procedure of filling online application, scanning / uploading of original certificates and online payment for registration.
 - i). The registration and processing fee can be paid through Debit card / Credit card or Net Banking.
 - **ii).** The registration and processing fee paid by the applicants is not refundable under any circumstances.
 - iii). The following documents are mandatory for registration:
 - (a) Passport size photo
 - (b) Admit Card and Rank Card NEET-PG- 2025
 - (c) Original / Provisional Degree Certificate of MBBS course
 - (d) Aadhaar Card

- (e) Study Certificate(s) from 1st MBBS to Final MBBS course.
- (f) Study certificates from 6th class to Intermediate /12th standard.
- (g) Latest Category Certificate in case of BC/SC/ST candidates issued by the Competent Authority of Government of Telangana (If applicable).
- (h) Minority Certificate issued by the Competent Authority of Government of Telangana, if applicable.
- (i) Latest Service Certificate issued by the concerned Head of the Department, if applicable (issued after 01-09-2025 by DME/DH/Director ESI/ Commissioner VVP/ MD Singareni Collieries and other Competent Authority as notified by the Government of Telangana).
- (j) Internship Completion Certificate/ To be completed by 31-07-2025.
- (k) Valid Permanent Medical Registration Certificate issued by Telangana state medical council, Hyderabad.
- (I) Post Graduate Medical Diploma Certificate, if applicable
- (m) Photo Identity proof (Aadhaar).
- iv). Visit website through Computer with Internet connection to fill the application form.
- v). Fill in all the details in the online application form and upload all the documents which are mandatory.
- vi). The candidates who claim for admission under Persons with Disabilities (PWD) category shall mention in the online application as applying under PWD category and have to appear before a Medical Board constituted for the purpose by the University as per the schedule to be notified by the University for Eligibility under PWD status.
- 6. Procedure for submission of filled-in online Application form and Original certificates for PG Medical Courses at the time of joining into the allotted college for final verification:-

The candidate should submit the print-out of the filled-in Online application form and original certificates along with a set of self attested copies to the Principal of allotted medical college at the time of joining for final verification. In case of any discrepancy, the provisional allotment order will be cancelled.

- 7. a) On-line application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications will be rejected automatically.
 - **b)** The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.

- c) Candidates may please note that the University will take up the verification of certificates with regard to eligibility conditions i.e., Educational Qualifications, validity of Registration certificate with Telangana State Medical Council, Internship certificate, Local area status, Category status as per uploaded relevant certificates by the concerned department officials. If the information furnished by the candidate in the application is not correct, his/her candidature is liable to be cancelled and further action that deems fit will be taken.
- **d)** Candidate's eligibility for admission into PG Medical courses for the academic year 2025-26 will be examined by the University only after scrutiny of application along with all copies of required certificates and provisional and final merit list will be notified.
- e) Registration along with uploading of Scanned Original certificates will be done only once irrespective of the number of times of exercising web options / Number of counselings. No separate notification will be issued for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
- f) Scrutiny of uploaded Original Certificates shall be done by the University and concerned departmental officials. After scrutiny of application and certificates, final merit list will be released. Candidates are advised to refer to KNRUHS website for further details regarding schedule of exercising web options from time to time.
- **g)** Admissions will be in accordance with the Orders issued from time to time by State Government with regard to process of Admissions to Post Graduate Medical Courses and relevant Hon'ble Supreme Court and Hon'ble High Court of Telangana orders.
- h) The procedure for preparation of seat matrix and selection into PG broad specialty in the Competent Authority Quota and seat allocation will be done as per the procedure given in G.O.Ms.No.155, HM&FW (C1) Dept, Dated:18-11-2021, G.O.Ms.No.73 HM&FW (C1) Department, Dated:03-07-2023, G.O.Ms.No.148, HM&FW (C1) Dept, Dated: 28-10-2024 and G.O. Ms. No. 10, SCD(POA.A2) Dept., Dated: 14.04.2025 for SC bifurcation, relevant Government orders, subsequent amendments and relevant Hon'ble Supreme Court and Hon'ble High Court of Telangana orders.
- 8. This notification is for determining the State Merit position in respective categories using NEET-PG -2025 Rank only. The dates for exercising web options for admission into PG (MD/MS/Diploma) courses will be notified separately on University website. Candidates are advised to check the University web-site for notifications, schedules and other details from time to time.

- **9.** An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
- **10.** Admission will be considered only for candidates, who have secured marks above cutoff score in NEET-PG-2025 exam and based on the state merit position as the case may be.
