With references to the above, it is hereby informed that the Secretary, National Commission for Indian System of Medicine, New Delhi vide ref.cited stated that the Interim Guidelines on assessment method for granting admission into UG AYUSH Courses for the PWD candidates have been framed and shall be implemented for admissions in the academic year 2025-26.

In compliance of the said guidelines, all the NEET UG-2025 qualified candidates of PWD category who are seeking admission into UG AYUSH courses for the academic year 2025-26 under State Quota in PwBD category are hereby informed to go through the Interim Guidelines on assessment method for granting admission into UG AYUSH courses to PWD candidates for the academic year 2025-26 which is uploaded in the University website and to submit the following documents at the time of physical assessment before the Medical Board constituted by the University. The schedule & venue for physical assessment will be notified in the University website and to follow the same.

- 1. NEET UG 2025 result demonstrating eligibility for the BAMS/BUMS/BHMS/BNYS courses.
- 2. A valid UDID card (Yellow or above) issued by the Department of Empowerment of Persons with Disabilities (DEPwD) (excluding visual disabilities).
- 3. Self-Certified affidavits in the format provided under Schedule -I

4. In addition to the above, a copy of Medical Assessment Report -2025 issued by Medical Board of Medical Counselling Committee (MCC) is also required.

The PWD candidates who do not have UDID card are advised to apply for the same immediately through <a href="https://swavlambancard.gov.in/">https://swavlambancard.gov.in/</a> duly selecting nearest Govt. General Hospital for speedy process for issuance of UDID card.

Further, all the qualified PWD candidates those who have applied are required to attend before the Medical Board as per the schedule to be notified by the University along with above said documents without fail. Failing which the candidates shall not be considered under PWD category.
