Prospectus for Admission into BPT, B.Sc. MLT and B.Sc. Allied Health Sciences **for the academic year 2025-26**

1. REGULATIONS

- A) These Regulations are applicable for admission into Competent Authority Quota seats in Government and Private B.Sc. Allied Health Sciences institutions for the following courses.

1. *BPT (Bachelor of Physiotherapy)*
2. *B.Sc. Medical Lab Technology*
3. *B.Sc. Anesthesia Technology*
4. *B.Sc. Operation Theatre Technology*
5. *B.Sc. Cardiac and Cardio Vascular Technology*
6. *B.Sc. Renal Dialysis Technology*
7. *B.Sc. Optometry.*
8. *B.Sc. Respiratory Therapy Technology*
9. *B.Sc. Neuro Science Technology.*
10. *B.Sc. Critical care Technology*
11. *B.Sc. Radiology and Imaging Technology.*
12. *B.Sc. Audiology and Speech Therapy Technology.*
13. *B.Sc. Medical Records Sciences*
14. *B.Sc. Nuclear Medicine*
15. *B.Sc. Radio Therapy Technology*

Note: If any new college/Institution is permitted for above courses, the same shall be considered for admissions. No fresh registrations shall be done or notifications shall be issued.

- B) All the Candidates shall fulfill the regulations for admission into B.Sc. Allied Health Sciences Degree Courses for admission into Competent Authority Quota Seats.

The candidates are advised to take a print out of the Prospectus / instructions to fill the application form from the website www.knruhs.telangana.gov.in before proceeding to fill the online application form.

- C) The list of colleges and seat matrix for Competent Authority Quota seats into BPT, B.Sc. MLT and B.Sc. Allied Health Sciences Degree Courses at affiliated Colleges for academic year 2025-26 shall be displayed in the KNRUHS website before exercising web options for counseling.

- D) Tuition Fee shall be as notified by the State Government.
- E) In case any new courses/new institutions are permitted by State Government/University for the Academic Year 2025-26, those seats shall also be filled up. NO FURTHER NOTIFICATIONS SHALL BE ISSUED.

2. ELIGIBILITY :

A. Nationality & Domicile :

A candidate for admission into Allied Health Sciences courses under Competent Authority Quota in Telangana should be Indian Nationals/Person of Indian Origin (PIO)/Overseas Citizens of India (OCI) card holder and shall fulfill the following conditions: (G.O.Ms.No. 140 HM&FW(C1) Dept. Dated: 04-10-2024).

i) The candidate should have studied in an Educational Institutions in the state of Telangana for a period of not less than four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in relevant qualifying examination.

or

ii) Where during the whole or any part of the four consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared for the relevant qualifying examination, he has not studied in Educational Institutions, the candidate should have resided in the state of Telangana for a period of not less than four (4) years immediately preceding the date of commencement of the relevant qualifying examination, in which he appeared or as the case may be first appeared.

iii) Further, in case the candidate has not studied in any educational institution and has resided in the state of Telangana as stated at (ii) above, to be eligible for admission into Under graduate Allied Health Sciences courses under Competent Authority Quota, the candidate should have appeared for the relevant qualifying examination in the State of Telangana.

B. EDUCATIONAL QUALIFICATIONS: For B.Sc. Allied Sciences courses

Candidates seeking admission should have passed 2 years Intermediate Examination (10 + 2 pattern) with Botany, Zoology, Physics, Chemistry and English conducted by Board of Intermediate Education, Telangana state.

Or

Any other examination of (10 + 2 pattern) from recognized Board under AISSCE / CBSE/ ICSE / SSCE / HSCE / NIOS / TOSS of other equivalent Board with Biology, Physics and Chemistry recognized as equivalent by Board of Intermediate Education, Telangana state.

Or

Intermediate (10+2) with Bridge course with Biology and Physical Science.

C. AGE: Candidates should have completed the age of 17 years as on 31st December 2025.

i. Age shall be calculated on the basis of date of birth as indicated in the Secondary School Certificate examination or equivalent examination.

ii. No request for relaxation of age of a candidate shall be permitted.

D. DURATION OF THE COURSE –

i. 4 years + 6 months Internship for BPT course

ii. 3 years for B.Sc. MLT course

iii. 4 years including period of compulsory Internship for all Allied and health Sciences courses

E. The candidates have to apply online and upload the original certificates in response to notification issued by KNRUHS. The merit rank notified after verification of certificates by KNR University of Health Sciences, shall be the basis for selection into BPT, B.Sc. MLT and B.Sc. Allied Health Sciences courses into Competent Authority Quota seats.

3. ONLINE APPLICATIONS

The on-line application form for determining merit position for Competent Authority Quota seats shall be available on the website <https://alliedhs.tsche.in> from **8.00 AM on 29-10-2025 upto 05.00 PM. on 08-11-2025.**

Note: The candidates are advised to take a print out of the Prospectus / Instructions to fill the application form from the website <http://www.knruhs.telangana.gov.in/> or from <https://alliedhs.tsche.in> before proceeding to fill the application form.

The candidate should fill the online application form available in the Website with the data required through computer with internet connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the

Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) and ready to enter his/her correct data and upload the photo, signature and original certificates, after the payment of application fee through Online.

Registration and Verification Fee:

- a) The Registration and Verification fee Rs. 2500/- (Bank transaction charges extra) for OC & BC candidates and Rs. 2000/- (Bank transaction charges extra) for SC/ST candidates shall be paid online through payment gateway i.e., Debit card / Credit card or Net Banking.**
- b) ***Registration and Verification fee once paid shall not be refunded or adjusted to a further date.*

The candidates are advised to download and read the Prospectus of the course to verify for eligibility.

4. RESERVATION OF SEATS:

A. RESERVATION OF SEATS FOR SCHEDULED CASTES & SCHEDULED TRIBES.

- I. 15% seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Castes. As per G.O. Ms. No. 10, SCD(POA.A2) Dept., Dated: 14.04.2025 and as per Government orders dated. 16.05.2025, out of 15% of seats reserved for SC, 1% of seats shall be reserved for SC Group I, 9% of seats shall be reserved for SC Group II, 5% of seats shall be reserved for SC Group III. The Rationalization of reservations shall be followed as per the said G.O. and Government orders from the AY 2025-26
- II. 10% of seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Tribes as per G.O.Ms.No. 33, Tribal Welfare Department, dated.30.09.2022.
- III. Candidates of the Scheduled Castes and Scheduled Tribes belonging to the State of Telangana for castes which are notified by the Government of Telangana from time to time shall be considered for reservations.
- IV. If the candidates from Scheduled Castes & Scheduled Tribes are not available these reserved seats shall be converted to open category seats and allotted on the basis of merit.
- V. Reservation for the Scheduled Castes and Scheduled Tribes shall be considered for castes which are notified in the SC/ST caste list as per the Telangana Government orders only.

B. Reservation of seats for BC Candidates:

- i. 29% of the total seats under Competent Authority Quota shall be reserved for candidates belonging to Backward Classes and shall be allotted among the five sub groups of Back Ward Classes as follows:-
BC-A-7%, BC-B-10%, BC-C-1%, BC-D-7% and BC-E-4%.
- ii. Candidates who belong to the notified Backward Class castes of the States of Telangana which are listed in the Telangana State Government orders shall be considered for reservations.
- iii. If eligible candidates belonging to Backward Classes of a particular sub-group are not available, the left over seats can be allotted to the candidates of next sub- group ie., BC A to BC B to BC C to BC D to BC E.
- iv. If eligible candidates of Backward Classes category are not available for the 29% seats reserved for them, the left over seats shall be converted to open category seats and shall be allotted as open category seats on the basis of merit.
- v. While calculating the number of seats in the sub-groups if the total number of seats falls short of or exceeds 29% it shall be limited to 29% by adding or eliminating the candidates on the basis of merit in the sub- groups in which the fractions were rounded to nearest figure.

C. Reservations for EWS Category :

10% of total seats under Competent Authority Quota are reserved for EWS category candidates.

EWS candidates shall submit EWS eligibility certificate valid for the year 2025-26 issued by Competent Authority

D. Reservation for Women Candidates

33 1/3% of seats are guaranteed for women candidates in each category i.e., Open category, EWS, Scheduled Castes, Scheduled Tribe, Backward Classes Group A, B, C, D and E. This regulation of guarantee shall not be applicable if women candidates selected on merit in each category form 33 1/3% or more of the seats therein. When the number of women candidates falls short of this percentage, it would be made up by replacing the last selected male candidates by women candidates in that category.

E. Reservation under Persons with Disabilities (PWD) Category:

5% of total seats in each course and category shall be reserved for the Persons with Disabilities (PWD) i.e., OC, SC, ST, BC-A, BC-B, BC-C, BC-D and BC-E categories as per Government of India guidelines.

The candidate seeking the benefit of reservation should present him/herself before a Medical Board constituted by the University, comprising of Professors from Government Medical Colleges from relevant specialties. The decision of the Medical Board constituted by the University with regard to percentage of Disability is final.

F. Permanent Caste Certificate:

- a) Scheduled Caste, Scheduled Tribe and Backward Class candidates shall in support of their claim, have to furnish Permanent caste certificate issued by the Competent Authority of Government of Telangana.
- b) The social status of the candidates who have applied for the seats reserved for Scheduled Castes, Scheduled Tribes and Backward Classes shall be scrutinized as per the rules notified by the concerned department officials of Government of Telangana.
- c) The decision of the verification officer deputed by the Director/ Commissioner of BC Welfare, SC Welfare and ST Welfare from the Government of Telangana is final in all respects.
- d) Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to Telangana State for castes which are notified as per the Telangana Government orders shall be considered against the reserved seats.

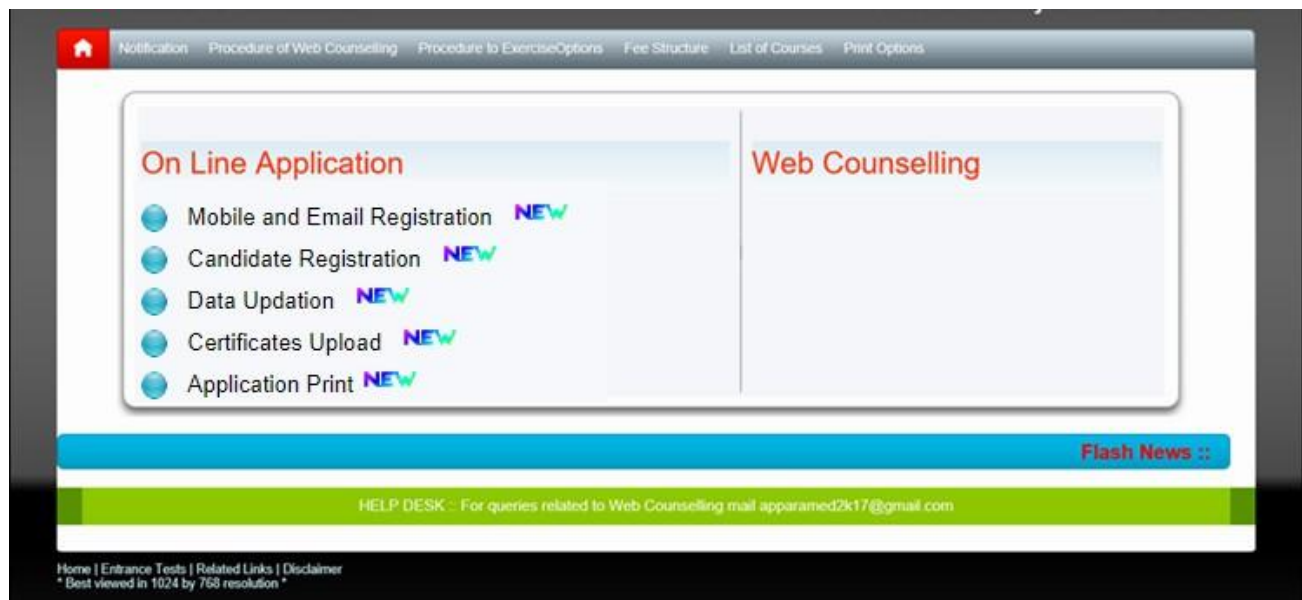

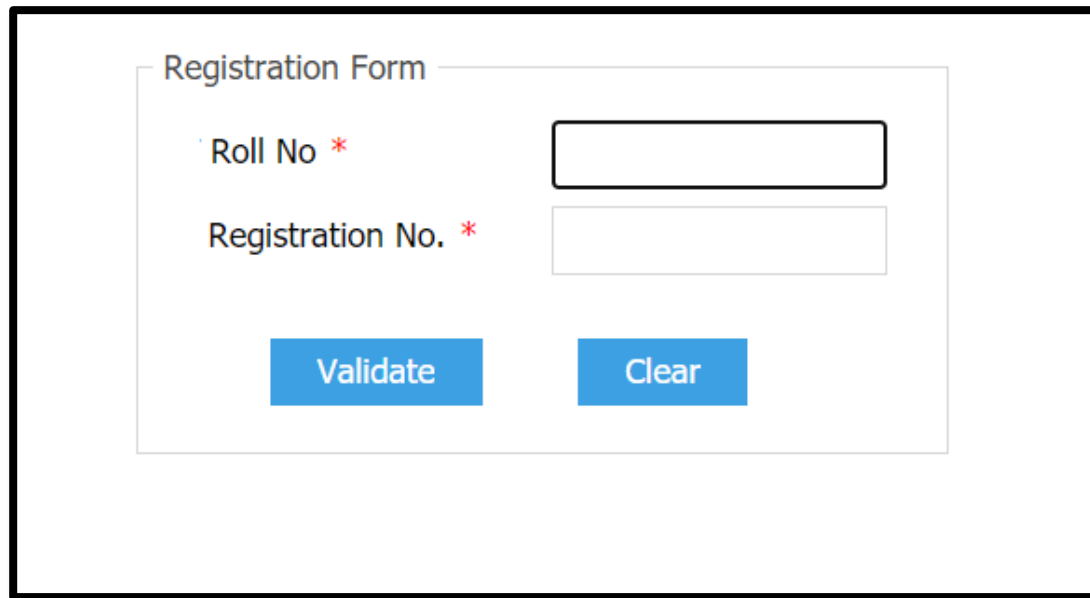

5. MERIT LIST:

The provisional merit list and final merit position of applied candidates for Competent Authority Quota seats shall be notified after verification of uploaded certificates. The provisional merit list and final merit list shall be prepared by the Admission Committee appointed by University subject to these regulations.

The Criteria for preparation of Merit list:

- a. The total percentage of marks obtained in Botany, Zoology, Physics and Chemistry (or optional subjects) in the qualifying examination up to 2 decimal places.
- b. The candidates who qualify under compartmental system shall be placed in the Merit List after the candidates who passed in a single attempt.
- c. In case of equality of marks, age shall be taken into consideration and the older candidates shall be given higher place in the merit list.
- d. In case of equality marks and age, the aggregate percentage of marks in all subjects of qualifying examination upto 2 decimal places shall be considered.
- e. Science marks in the Intermediate or its equivalent examination shall only be taken into account even in case of the candidates possessing higher qualification.

6. PROCEDURE OF SELECTION:

Selection shall be made by the Admission Committee appointed by Vice-Chancellor, KNR University of Health Sciences based on the web-options given by the candidates and their merit.

- a. Selections shall be made as per Government orders on Rules for admissions into Allied Health Sciences courses and University Regulations.
- b. The Admission Committee shall allot seats to candidates in Courses and Colleges based on their priority of web-options and merit.
- c. Selected candidates shall receive the allotment message on the registered mobile number after allotment of a seat. Candidates are directed to login and check their allotment on website after each phase of counseling without fail.
- d. Selected candidates have to download the allotment order on payment of University fee of Rs. 6,000/- (Rupees Six thousand only) besides payment gateway charges through payment gateway. Candidates have to report to the

Principal of concerned college along with all Original Certificates and pay the tuition fee and college fee at the college to complete the admission process.

7. ADMISSION RULES

- a. The Provisional allotment letter for admission of selected candidate shall be downloaded from website after payment of University fee by payment gateway.
- b. The candidate should submit the print-out of the filled-in Online application form, allotment order and original certificates along with (1) set of self attested copies to the Principal of allotted college at the time of joining for final verification by the Admission Committee constituted at each college. The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission shall be cancelled.
- c. Selected candidates have to join the college within the specified date by submitting all Original Certificates, and pay the tuition fee as notified by the Government and college fee to complete the process of admission. If the candidate does not report within the specified time and complete the process as described before the admission shall be automatically cancelled and candidates shall not be eligible for further phases of counseling.

8. COMMENCEMENT OF THE COURSE:

The course shall commence as per the schedule notified by the University. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.

9. DISCONTINUATION RULES:

All the candidates joining the BPT, B.Sc. MLT and B.Sc. Allied Health Sciences courses for the academic year 2025-26 shall execute bond on a non-judicial stamp paper of Rs. 20/- as prescribed in annexure -II to the effect that he/she shall complete the prescribed period of training or in default to pay Rs. 50,000/- (Rupees Fifty Thousand Only) to KNRUHS.

10. COLLEGE REGULATIONS:

Candidates are required to follow the rules and regulations of the college and should also abide by the Regulations of the University. Candidates are informed that their correspondence with the University shall be forwarded by the Principal of college with his remarks (through proper channel) for consideration. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal

11. The admissions shall be closed as per the schedule notified by the University.

12. Any vacancy after the date of closure of admissions shall not be filled. They shall not be carried forward to the next year as per the directions of Hon'ble Supreme Court of India.

13. POWERS OF THE PRINCIPAL OF THE INSTITUTION

Notwithstanding anything contained in these Regulations, the Head of the Institution may at any time, either su-moto or on an application made by any person after due and proper enquiry, if satisfied that the candidate has furnished incorrect information or enclosed false certificates or fraudulently obtained admission may for the reasons to be recorded in writing, by order cancel her admission provided that no such admission shall be cancelled without giving a reasonable opportunity for showing cause as to why his/her admission should not be cancelled. Against any such order of the Head of the Institution, an appeal can be made to the Registrar, KNR University Health Sciences.

14. POWERS OF KNR UNIVERSITY OF HEALTH SCIENCES:

The University may either suo-moto or on an application made to University can call for and examine the records relating to any selection or admission or cancellation thereof made by the concerned authority for the purpose of verifying the correctness, legality or propriety of such selection or admission or cancellation and pass such order in relation thereto as KNRUHS deems fit, including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation.

15. UNIVERSITY IS THE FINAL AUTHORITY OF SELECTION PROCEDURE:

All selections made under these regulations shall be subject to such directions or orders as may be made by the University from time to time.

16. SANCTION OF LEAVE BEYOND (3) MONTHS AND TERMINATION OF STUDENTSHIP:

- a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals). If a student absents continuously for a period of (91) days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and be permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
- b. If the break of study (91 days or more) is in more than one spell, the candidate's application in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the university.
- c. Candidates, who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission into the course and the studentship stands cancelled without any further notice.
- d. The candidate has to pass within the final examination for award of Degree for the course double the duration of study period for the course or within the maximum period permitted by the Statutory Authority/University from time to time.
- e. e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course".

17. TIME FOR COMPLETION OF COURSE: Candidate should complete the course within the duration equivalent to double the period of course of study, failing which the admission shall be cancelled.

18. MIGRATION /TRANSFER:

No Transfers are permitted from one college to another college or from one course to other course under any circumstances.

19. DISCIPLINE:

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University either before the print or electronic media. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities /Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.
