Notification of counseling for second round of spot Admissions into BHMS Course under Management Quota for the academic year 2025-26

In continuation of earlier notifications dated: 04-10-2025, 18-10-2025, 24-10-2025, 29-10-2025, 18-11-2025, 26-11-2025 & 03-12-2025, 07/12/2025 & 19/12/2025 for MQ, Kaloji Narayana Rao University of Health Sciences hereby notifies to conduct Second round of spot Counseling for Admission into vacant seats in **BHMS** course under Management Quota(MQ) in Private Homoeo affiliated colleges to KNR University of Health Sciences.

Candidates whose names are notified as eligible candidates in the final merit list for BHMS course for the academic year 2025-26 notified on the KNRUHS website in the Management Quota merit list are only eligible to attend for **Second round of Spot counselling under MQ seats only** along with Demand Draft(DD) and all relevant original Certificates subject to the following conditions:

1. Candidates who are included in the List of In-eligible candidates to participate in Central/State /UT/ Institutional/Central Pool Quota/ AIQ (Private Institute) Counseling, 2025 for admission to ASU & H UG-courses for the A.Y. 2025-26, communicated by Ayush Admissions Central Counseling Committee (AACCC) are not permitted to attend the Second round of Spot admission.
2. Candidates who are admitted under KNRUHS for MBBS/BDS course under Competent Authority Quota and Management Quota are not permitted to attend the Second round of Spot admission.
3. Candidates who are admitted under MCC Counselling as notified on MCC website are not eligible to attend the Second round of Spot admission.
4. **Candidates who were admitted into UG AYUSH (BAMS, BHMS, BUMS and BNYS) courses seats in the previous phases of counseling under Competent Authority Quota and continuing in the course are not eligible to attend the Second round of Spot admission.**
5. **Candidates who are admitted into BHMS course under All India Quota & Management Quota in the previous phases of counseling and continuing in the course are not eligible to attend the Second round of Spot admission.**

6. Candidates who were admitted into BHMS course seats in the previous phases of counseling and who did not join the course/discontinued the course after joining under Management Quota are not eligible to attend the Second round of Spot admission.
7. Candidates have to attend with a Demand Draft for Rs. 15,000/- Cat-B quota & Rs. 20,000/- Cat-C/NRI quota towards University fee in favor of Registrar, KNRUHS, payable at Warangal and all original certificates compulsorily for counselling for MQ vacant seats.
8. Allotted candidates have to pay the Tuition fee and college fee at the counselling center to the Principal/staff of allotted college to complete admission process. Otherwise, provisional allotment will be cancelled.
