NOTIFICATION FOR REALLOCATION OF MBBS STUDENTS OF 2021-22 BATCH ADMITTED AT TRR AND MAHAVIR INSTITUTES OF MEDICAL SCIENCES

In accordance with the orders of National Medical Commission vide letter no. M-19011/1/2021-NMC-MARB 033710, Dated:25-08-2022 and Government of Telangana letter no.4596/C1/2022, Dated:26-08-2022, KNRUHS hereby notifies the procedure for reallocation of all the MBBS students admitted for the academic year 2021-22 under Competent Authority Quota and Management Quota at TRR Institute of Medical Sciences, Sangareddy and Mahavir Institute of Medical Sciences, Vikarabad to other Medical Colleges.

The candidates who were admitted into MBBS course for 2021-22 at TRR Institute of Medical Sciences, Sangareddy and Mahavir Institute of Medical Sciences, Vikarabad for academic year 2021-22 under KNRUHS and who are studying MBBS at these colleges are hereby directed to exercise web options compulsorily for re-allocation to the colleges in the table shown below.

The list of admitted candidates at TRR Institute of Medical Sciences, Sangareddy (TRR IMS) and Mahavir Institute of Medical Sciences, Vikarabad (Mahavir IMS) is notified on KNRUHS website.

The admitted candidates (TRR IMS & Mahavir IMS) can exercise web options from 9.00 A.M. on 29-08-2022 to 6.00 P.M. on 30-08-2022 through website https://tsmedadm.tsche.in/

Redistribution of students is done in accordance with the guidelines issued by National Medical Commission. As per NMC guidelines the students shall follow the fees as per the college norms where they are choosing for continuation of their studies. Tuition fee GO applicable for MBBS courses of various Medical colleges is enclosed as annexure.

The Principals and Managements of TRR Institute of Medical Sciences, Sangareddy and Mahavir Institute of Medical Sciences, Vikarabad, are hereby directed to return the original certificates and refund the fees (College fee, Tuition fee etc.) collected from the students before 05-09-2022 without fail, to facilitate admission of students at reallocated Medical colleges. Instructions to Candidates:

 Candidates can exercise web options through website https://tsmedadm.tsche.in/ from home or any other center having internet facility. Use only system with Internet facility. Do not use Tabs or Mobiles to exercise web-options.

- Admitted Candidates of 2021-22 MBBS batch as per the list notified on KNRUHS website on 27-08-2022 shall exercise weboptions for all the Medical colleges shown above in order of their priority.
- 3) Male candidates have to exercise priority order of web options for 12 Medical colleges and female candidates have to exercise priority order web options for 13 Medical colleges (Mallareddy Medical College for Women) compulsorily.
- Candidates have to login with NEET details and the same Registration number issued previously at the time of counseling. In case of any difficulty candidates can contact the helpline number 7842542216 and 9059672216 between 9.00am to 6.00pm.
- 5) One Time Password (OTP) will be sent to the registered mobile of the candidate at the time of exercising web options. The password consists of SIX letter code with English capitalsA to Z
- 6) Candidates are instructed to take a print out of saved options.
- 7) Allotments will be done as per the NEET-UG-2021 merit rank, category merit for Competent Authority Quota seats and as per NEET-UG-2021 merit rank for Management Quota (B & C categories) to the extent possible in view of limited number of seats available at each of the Medical colleges for reallocation of TRR IMS and Mahavir IMS students separately.
- 8) College wise list of allotted candidates will be displayed on KNRUHS website and will be communicated to the Principals of respective Medical colleges. Candidates have to report to the Principals of allotted Medical College, submit all original certificates, bond and pay the tuition fee/college fee to complete the process of admission before the last date of reporting to be notified by the University.

ORDER:

In the G.O. 1st read above, orders were issued for fixation of the fee structure and certain directions in respect of under graduate (BDS) and post graduate (MDS) in Army College of Dental Sciences, Secunderabad.

2. Orders were issued in G.O 2nd and 3rd read above for fixation of the fee structure in respect of Under Graduate Medical / Dental courses in Private Unaided Nonminority & Minority Colleges respectively in the state for the academic year 2016-2017.

3. In the G.O. 4th read above, orders were issued for retaining the existing fee structure for the Under Graduate Medical / Dental courses in private Unaided Minority Colleges, duly retaining the terms & conditions laid in G.O.3rd read above.

4. In the G.O. 5th read above, orders were issued for Undergraduate Medical / Dental Courses, increasing 5 % tuition fee for category B seats and in respect of C category, the fee shall not exceed two (2) times of "B" category seats for Private Unaided Non-Minority Colleges for academic year 2017-2018.

5. In the reference 6th read above, Telangana Admission and Fee Regulatory Committee, Hyderabad submitted its recommendations for fixation of fee structure for M.B.B.S, B.D.S courses for the block period 2020-2023 and requested the Government to issue necessary orders.

6. In the G.O.7th read above, orders were issued to retain the existing fee structure for the Undergraduate Medical and Dental Courses in Army College of Dental Sciences and in Private Unaided Non-Minority / Minority Medical and Dental Colleges, for the year 2020-2021 in view of the special circumstances due to COVID-19 pandemic, duly retaining the terms and conditions laid in G.O. 4th and 5th read above.

7. Government after examination of the matter, hereby accept the recommendations of the Telangana Admission and Fee Regulatory Committee and fix the fee structure for undergraduate medical (M.B.B.S) and dental courses (B.D.S) for the remaining block period 2021-2023 as appended to this order as annexure-I & II for the private unaided non-minority/minority medical and dental colleges in the state and also the Army College of Dental Sciences, Secunderabad.

8. The following conditions shall be followed by all the private unaided nonminority / minority medical and dental colleges in the state:-

(i) The Management shall not charge any capitation fee and there shall not be any profiteering. Except the above fee fixed by the Committee, no other amount, either directly or indirectly, can be charged un-authorizedly or

illegally by the management. If any such other amount is charged under any other head or guise (e.g. Donation etc.) it would amount to charging of capitation fee. The surplus (profit) that is generated from the collection of the fee must be for the benefit of the institution and cannot be diverted for other purposes or for personal gain.

- The total fee of the course (4 1/2 years) shall be collected at the beginning of (ii) every academic year and in five installments.
- The same fee shall continue for the students admitted during the block (iii) period of 2021-23 till they complete the course.
- The managements of the institutions may seek bank guarantee for tuition (iv) fee chargeable for every succeeding year.

The Registrar, KNR University of Health Sciences, Warangal, the Principals of 9 all the private unaided non-minority / minority medical and dental colleges in the state and also Principal of Army College of Dental Sciences, Secunderabad shall take necessary action in the matter accordingly.
