NOTIFICATION FOR ADMISSION INTO MDS COURSES UNDER COMPETENT AUTHORITY QUOTA FOR 2022-23

Application forms online are invited from NEET-MDS-2022 qualified candidates who have become eligible after lowering of cutoff score for admission into MDS courses under Competent Authority Quota for the academic year 2022-23 into Dental Colleges affiliated to KNR University of Health Sciences, Warangal in the State of Telangana.

Notification is issued for online registration for web based counseling from the candidates who have become eligible after lowering of cut-off score and for inclusion in provisional final merit list for admission into Competent Authority Quota seats only. Total number of vacant seats available under Competent Authority Quota for the academic year 2022-23 will be notified on KNRUHS website before exercising web options for second phase of counseling. Tuition fee payable will be as notified by the Government of Telangana vide G.O.Ms.No.20 HM&FW (C1) Dept. Dated:14-04-2021 (notified on KNRUHS website) and relevant Hon'ble High Court Orders.

Revised cut-off scores in NEET MDS 2022 Examination for MDS courses

Candidates should have secured the following revised cutoff score or above in NEET -MDS-2022 (as per the notice of NBE dated:14-10-2022)

Category	Revised Qualifying Criteria	Revised Cut off Score
General Category	24.286% percentile	174
SC/ST/OBC including PWD of SC/ST/OBC	14.286% percentile	138
UR- PWD	19.286% percentile	157

Candidates can apply on-line on web-site https://tsmds.tsche.in from 8.00AM on 18-10-2022 to 20-10-2022 up to 5.00PM.

- 1. Candidate should have passed BDS Degree examination from an Institution recognized by the Dental Council of India and should have completed internship by 31-07-2022.
- 2. The on-line application can be filled through any computer or laptop with internet connection.
- 3. Registration along with uploading of scanned Original certificates will be done only once irrespective of the number of times of exercising web options/ Number of counseling. No separate notification will be given for verification of original certificates. Therefore the candidates should register and upload all the mandatory Certificates without fail.
- 4. Scrutiny of uploaded Original Certificates shall be done by the University and concerned departmental officials. After scrutiny of application and certificates, the revised provisional final merit list will be released. Candidates are advised to refer to KNRUHS website for further details regarding schedule of exercising web options.
- 5. Registration and Processing fee for MDS Courses: The Registration and Processing fee of Rs.5500/- (Bank Transaction charges extra) for OC & BC candidates and Rs.5000/- (Bank Transaction Charges extra) for SC/ST candidates shall be paid on-line through Debit Card / Credit card or Net Banking.**
 - ** Registration fee once paid will not be refunded or adjusted to a further date.
 - ** Under any circumstances fee once paid will not be refunded or adjusted to further date.
- 6. Candidates who completed BDS from other States must pay equivalency verification / certificate verification fee along with the registration fee. BDS Degree from other State or other Country of Rs. 5,000 & Rs. 7,000 respectively.
- 7. Candidates are advised to refer to detailed Notification & Prospectus for Competent Authority Quota admissions issued earlier on 24-08-2022 carefully for eligibility and other details.

- 8. The prospectus of the course, instructions of filling on-line application form is available on University web-site http://knruhs.telangana.gov.in/
- 9. Merit position of the applied candidates will be prepared based on NEETMDS 2022 Score and will be included in the merit list.

- 1. Candidates who have completed the on-line application process already with reference to earlier notification for MDS Courses need not apply again.
