MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA 2022-23

NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR MOP-UP PHASE COUNSELING FOR MBBS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA INTO AFFILIATED GOVERNMENT, PRIVATE UN-AIDED MINORITY/NON-MINORITY MEDICAL COLLEGES.

In continuation to this office notifications dated: 10.10.2022, 23.10.2022, 28-10-2022 and 25-11-2022 Kaloji Narayana Rao University of Health Sciences hereby notifies the conduct of Mop-up phase of web based counseling for vacant seats after second phase of counseling for MBBS course under Competent Authority Quota (CQ) for 2022-23 in Government, Private un-aided Minority/Non- Minority Medical Colleges in the State of Telangana.

All the eligible candidates whose names are displayed in the Provisional final merit list including NCC, CAP categories and EWS quota candidates on KNRUHS website who were not allotted any seats in the previous phases of counseling can exercise web options from 1.00 P.M. on 10.12.2022 to 1.00 P.M. on 12.12.2022 subject to the following conditions through website https://tsmedadm.tsche.in/ from computer with internet connection.

- The candidates who were allotted seats in MBBS and BDS courses upto second phase of counseling and joined the course (CQ and MQ) are not eligible to exercise web options.
- 2. The candidates who were allotted seats in MBBS course in the previous phases of counseling and have not reported/discontinued the course (CQ) at the respective college are not eligible for exercising options.
- 3. Candidates who have not exercised web options in the previous phases of counseling (CQ) for MBBS are also not eligible to exercise web options.
- 4. Candidates who are admitted upto Mop-up phase of All India Quota Counseling as notified by MCC and after second phase of Dr.YSRUHS (Dr.NTRUHS) counselings (CQ and MQ) for MBBS and BDS courses are not eligible to exercise web options. Options of the candidates admitted in AIQ Mop-up phase of counseling shall be considered as null and void.

For eligibility criteria and regulations refer to notifications dated: 10.10.2022.

UNIVERSITY FEE: Allotted Candidates have to pay University fee of Rs. 12,000/for MBBS Course through payment Gateway by using
Online payment method. (Debit Card/Credit Card/Internet
Banking) and download the allotment letter.

TUITION FEE: Tuition fee is to be paid at respective Medical colleges. The tuition fee payable as notified by Government of Telangana in GO Ms No:5, HM& FW (C1)Department, .Dated:27. 01.2022 (notified on KNRUHS web site)

NOTE:

- The details of vacant seats available (seat matrix) are placed in the website http://knruhs.telangana.gov.in. Candidates can exercise web options for MBBS seats in all Medical colleges affiliated to KNRUHS through https://tsmedadm.tsche.in/.
- 2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, G.O. Ms. No. 125, Health, Medical and Family Welfare (C1) Department Dated: 22.09.2022, relevant Hon'ble High Court/Supreme court orders and University regulations,
- **3.** Candidates are advised to go through the Prospectus and the Government Orders on Rules of UG admissions available on website before exercising web options for the regulations.
- 4. Competent Authority Quota seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Competent Authority Quota seats in other Medical Colleges.
- **5.** Any vacant seats where candidates are not available in that particular

category will be converted in this phase of counseling in accordance with the 6.0.114

IMPORTANT INSTRUCTIONS TO THE CANDIDATES:

- 1) Eligible NEET-UG-2022 qualified candidates as per provisional final merit list for Competent Authority Quota can exercise web options for vacant MBBS seats in colleges as per their interest and priority through https://tsmedadm.tsche.in/ from computer with internet connection.
- 2) Candidates are advised to go through the Prospectus for the Regulations for MBBS course of KNRUHS, available on website before exercising weboptions.
- 3) Candidates exercising web-options for MBBS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per vacancies and candidates eligibility. If candidates are not interested to join in any subject or college they should not exercise web options for the same.
- 4) Candidates can exercise web options through a computer either from home / any other place having internet facility. Don't use mobiles and Tab's for exercising web options.
- One time pass word (OTP) will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read construction to the candidates before giving options)
- 6) Candidates are instructed to take a print out of saved options.
- 7) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to login to check their allotment status on https://tsmedadm.tsche.in/ website after each phase of counseling without fail.
- 8) The selected candidates shall download the allotment letter from website after payment of the University fee by payment gateway method by using online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of

respective college on or before the date specified on the allotment letter.

9) Selected candidates have to report to the Principal of the respective

college before the last date for joining as specified on the allotment letter.

submit all original certificates, relevant bonds and pay the tuition

fee/college fee to complete the process of admission. If the candidate

does not fulfill the above criteria to complete the admission process

within specified date for joining, the admission will be cancelled

automatically.

Candidates are hereby informed that final verification of original 10)

certificates will be conducted at the allotted college and in case of any

discrepancy, the provisional allotment will be cancelled and action

may be initiated as per University regulations.

11) Candidates have to compulsorily join at the allotted college in the allotted

course without fail in this phase of counseling. Failure to join the course will

be considered as being part of seat blocking and necessary legal action will be

initiated by the University.

Admitted candidates will have to pay discontinuation penalty amount of 12)

Rs.20 lakhs as per Government Orders, if they discontinue the course after

the second phase of counseling to get their original certificates back.

Candidates also will be debarred for 3 years for MBBS admission under KNRUHS

to prevent seat blocking.

13) The University fee once paid shall not be refunded under any circumstances.
