This Notification is issued for registration of the candidates to appear for **MDS Part-I (New Regulations)** Supplementary Examinations on **31.05.2024**.

## Eligibility to appear for MDS Part I (New Regulations) Supplementary Examinations, May 2024:

- As per New Regulations of DCI, The PG Dental Degree students who took admission into the colleges of Telangana state and whose admissions are approved by the KNRUHS during the academic year 2022-23 and who have completed one year course of study with 80% (EIGHTY PERCENT) attendance shall appear for Paper – I Basic Sciences Examination.
- 2. The Candidates of previous batches who have failed, detained and not registered for the said examinations conducted earlier are also eligible to appear for **MDS Part I** Examinations subject to the fulfillment of regulations.
- 3. The Cut-off date for calculation of attendance percentage of the candidates is up to 25.04.2024.
- 4. The uploading of the attendance percentage of the candidates is from 01.05.2024 to 03.05.2024.
- 5. The confirmation date for uploaded attendance percentage of the candidates is on 05.05.2024.

# **Digital Valuation and Providing only single answer booklet without additional answer booklet:**

The University is a Digital campus and implementing digital valuation for all courses. For MDS Course, exam will be conducted with single answer booklet with 64 writable pages with candidate specific bar code on each page for the candidates appearing for examinations and no additional answer book will be issued to the candidates. The candidates should answer all the questions in the single answer booklet of 64 writable pages only.
