**NOTIFICATION FOR ONLINE REGISTRATION FOR ADMISSIONS INTO B.Sc.
ALLIED HEALTH SCIENCES COURSES INCLUDING BPT AND B.Sc. (MLT) COURSES
UNDER COMPETENT AUTHORITY QUOTA FOR 2024-25**

Applications online are invited from eligible candidates for admission into the B.Sc. (Allied Health Sciences) courses including BPT and B.Sc. (MLT) courses for the academic year 2024-25 under Competent Authority Quota in affiliated colleges/Institutions.

Notification is issued for online registration to determine State Merit position for web-based counseling and admission into Competent Authority Quota seats. Provisional final merit list will be notified after scrutiny of all original certificates uploaded at the time of online registration.

Total number of seats available under Competent Authority Quota for BPT, B.Sc. (MLT) and B.Sc. (Allied Health Sciences) courses for the academic year 2024-25 will be notified along with notification for exercising web-options for counseling.

Note: If any new college/Institution is permitted for above courses, the same will be considered for admissions. No fresh registrations shall be done or notifications will be issued.

Provisional Final Merit position of the applied candidates will be prepared based on eligibility criteria notified here under after verification of uploaded original certificates.

I. ELIGIBILITY CRITERIA FOR ADMISSION:

Also refer to Prospectus of the courses for details

Admission into various Allied Health Sciences Courses including BPT and B.Sc. (MLT) courses in different Professional Educational Institutions shall be governed by the Rules of Admission notified by State Government. The Eligibility criteria for admission into all Courses shall be as mentioned below. The eligibility criteria shall be subject to modifications in accordance with criteria notified by National Commission for Allied and Healthcare Professions from time to time.

A. Nationality & Domicile:

A candidate for admission into Allied Health Sciences courses under Competent Authority Quota in Telangana should be Indian Nationals/Person of Indian Origin (PIO)/Overseas Citizens of India (OCI) card holder and shall fulfill the following conditions: (G.O.Ms.No. 140 HM&FW(C1) Dept. Dated: 04-10-2024).

i) The candidate should have studied in an Educational Institutions in the state of Telangana for a period of not less than four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in relevant qualifying examination.

or

ii) Where during the whole or any part of the four consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared for the relevant qualifying examination, he has not studied in Educational Institutions, the candidate should have resided in the state of Telangana for a period of not less than four (4) years immediately preceding the date of commencement of the relevant qualifying examination, in which he appeared or as the case may be first appeared.

iii) Further, in case the candidate has not studied in any educational institution and has resided in the state of Telangana as stated at (ii) above, to be eligible for admission into Under graduate Allied Health Sciences courses under Competent Authority Quota, the candidate should have appeared for the relevant qualifying examination in the State of Telangana.

B. Educational Qualification - Candidates seeking admission should have passed 2 years Intermediate Examination (10 + 2 pattern) with Botany, Zoology, Physics and Chemistry and English

or

Any other examination of (10 + 2 pattern) from recognized Board under AISSCE/ CBSE/ ICSE / SSCE / HSCE / NIOS / TOSS of other equivalent Board with Biology, Physics and Chemistry recognized as equivalent by Board of Intermediate Education, Telangana state.

or

Intermediate (10+2) with Bridge course with Biology and Physical Science.

C. AGE:

The minimum age for admission shall be 17 years on 31st December 2024.

II. Duration of the course – 4 years including 1 year compulsory Internship

III. Candidates are advised to download and read the Prospectus/Regulations of each of the courses available in the website www.knruhs.telangana.gov.in before filling the on-line application form and payment of application fee for admission for the academic year 2024-25.

IV. The eligible candidates as per the concerned regulations who desire to take admission for above courses in affiliated colleges shall apply online and upload all original certificates for determining the merit position for Telangana State Competent Authority Quota seats in the web-site: <https://alliedhs.tsche.in> from **8.00 A.M. on 29-10-2024 to 06-11-2024 upto 06.00 P.M.** The online application can be filled through any computer with internet connection.

V. REGISTRATION AND PROCESSING FEE: The registration and Processing fee Rs.2,500/- (Bank transaction charges extra) for OC and BC candidates and Rs.2000/- (Bank transaction charges extra) for SC/ST Candidates for each course. Fee shall be paid online through Debit card / Credit card or Net Banking.**

** Registration and processing fee once paid will not be refunded or adjusted to a further date.

NOTE: CANDIDATES NEED NOT SEND THE PRINT-OUT OF APPLICATION TO THE UNIVERSITY

VIII. Procedure for submission of filled-in online Application form and uploading original certificates at the time of online registration:-

- a) Visit website through Computer with Internet connection to fill the application form.
- b) Fill in all the details in the online application form and upload all the documents which are mandatory.
- c) On-line application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position.
- d) The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
- e) Candidates may please note that the University will take up the verification of uploaded certificates with regard to eligibility conditions i.e., Educational qualifications, Local/Non-Local area status, Category status and EWS certificate by the concerned department officials. If the information furnished by the candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deemed fit will be taken.
- f) Candidate's eligibility for admission for the academic year 2024-25 will be examined only after scrutiny of application and verification of uploaded original certificates and provisional final merit list will be notified.
- g) Online Registration along with uploading of scanned original certificates will be done only once irrespective of the number of counseling. Online verification of uploaded original certificates also will be done only once. Therefore candidates should register and upload all the mandatory certificates without fail.
- h) Provisional final merit list will be released after scrutiny of application and uploaded Original certificates. Candidates are advised to refer to KNRUHS website for further details regarding schedule of exercising web options. No individual communication will be sent.

- i) Admissions will be in accordance with the Orders issued from time to time by Government of Telangana (Rules of Admissions into B.Sc. Allied Health Sciences courses), criteria for admissions of National Commission for Allied and Healthcare Professions from time to time, University Regulations and relevant Hon'ble Supreme Court / High Court orders.
- j) This notification is for online registration for determining the merit position only for eligible candidates. The dates for exercising web options for admissions will be notified separately on University website. Candidates are advised to check the University web-site for notifications, counseling schedules, seat matrix and other details from time to time.
- k) An in-eligible candidate obtaining merit position does not make the candidate eligible for admission.
- l) After allotment candidate should download the allotment order, submit the print-out of the filled-in online application form and original certificates along with (1) set of self attested copies to the Principal of allotted college at the time of joining for final verification by Admissions Committee of allotted college. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
