In continuation to this office notifications dated 30-10-2024, 02-11-2024 and 27-12-2024, and in accordance with the NCISM and NCH Letters dated 08-01-2025, KNRUHS hereby notifies fresh online registration **for SC/ST candidates who have become eligible after reduction of cut-off percentile for admission into PG AYUSH (HOMEO/AYURVEDA) courses under Competent Authority Quota in affiliated PG AYUSH colleges**

Notification is issued for online registration for SC/ST candidates to determine Merit position for web-based counseling for admission into vacant **Competent Authority Quota** seats in MD AYURVEDA/HOMEO in Government/Private AYUSH Medical Colleges. COURSES FOR THE ACADEMIC YEAR 2024-25**

Applications on-line are invited from candidates who have qualified in AIAPGET-2024 (Ayurveda), who fulfilled the eligibility for admission into MD Ayurveda Course by securing cut-off percentage of score and above for the academic year 2024-25 in Dr. BRKR Government Ayurveda Medical College, Hyderabad affiliated to KNR UHS.

Candidates can apply on-line through web-site <http://tsmdayush.tsche.in> From 4.00 PM on 30.10.2024 to 05.11.2024 up to 6.00 PM.

On-line application can be filled through any computer with internet connection.

SUBMISSION OF FILLED IN ON-LINE APPLICATION FORM :

The print-out of application along with 1 set of self attested copies should be submitted at the time of certificate verification and counseling as per schedule notified by KNR UHS.

1. ELIGIBILITY AS LOCAL CANDIDATE:

(as per G.O. Ms. No. 148 HM&FW(C1) Dept., dated 28-10-2024)

- i. A Candidate to be eligible for Admission into PG AYUSH Courses under these Rules should be an Indian National/Person of Indian Origin/Overseas Citizen of India card holder and be a local candidate:
- ii. Local candidate means a candidate who has studied in the Educational Institutions in the state of Telangana as for a period of not less than four consecutive years ending with the academic year in which he appeared or as the case may be, first appeared in the relevant qualifying examination subject to

Explanation (a): A candidate who is regarded as a local candidate for the purpose of Admission into Undergraduate (UG AYUSH) in the state of Telangana, but has studied in a State wide Institutions outside the state of Telangana, shall also be regarded as a Local candidate.

Explanation (b): A candidate, who has secured Admission to the relevant Undergraduate course (UG AYUSH) under Non-Local Quota in the State of Telangana, shall not be regarded as Local candidate.

2. As per the guidelines issued by Ministry of AYUSH and National Commission for Indian System of Medicine the following are the eligibility criteria for admission into Post Graduate Courses.

a) **Candidates who have appeared for AIAPGET 2024 and Candidate should have secured the following minimum eligibility percentile or above.**

i) **50% for General Category (Open) candidates.**

ii) **45% for General Category (Persons with Disabilities (OC PWD) candidates.**

iii) **40% for SC,ST and other Backward class including Persons with Disabilities**

b) Those who have passed the BAMS Degree Examination after undergoing a course of study in Ayurveda of not less than 5 ½ years duration including the period of compulsory internship;

or

Those who passed equivalent Degree Examination included in the 2nd schedule of IMCC Act 1970.

3. The candidates should have completed internship by 31-08-2024. Internship certificate to be issued by Principal of the college

4. Candidates who are already admitted and studying M.D. (Ayurveda) course shall not be permitted for counseling, until they discontinue the course before submitting the application form and such candidate shall submit the discontinuation certificate issued by the Head of the Institution along with the application.

5. Candidates who are already holding a Post Graduate Degree in Ayurveda in a subject shall not be eligible for admission into another P.G. Ayurveda Course.

6. For in-service candidates three years of regular service shall be calculated as on **30-09-2024**. Service quota allotments are subject to orders of Government of Telangana.

7. Merit Position of the candidates who have applied on-line shall be determined based on AIAPGET-2024 (Ayurveda) rank and percentile as per their eligibility.

8. **Registration and Processing fee** : Rs. 4,000=00 for OC/BC Candidates.

Rs. 3,000=00 for SC/ST Candidates.

- (i) Latest Service Certificate issued by Commissioner/Director AYUSH (after 01.10.2024)
- (j) Council Registration Certificate.

- (l) EWS Certificate valid for 2024-25 year if applicable

2. The fee can be paid through Debit card / Credit card or Net Banking

3. The fee paid by the applicants is not refundable under any circumstances.

NOTE :

- 1) Applications on-line are to determine the provisional state merit position. Final merit position will be determined after verification of original certificates
- 2) Print-out of application form should be submitted at the time of verification of Original Certificates and counseling along with 1-set of self attested copies. Incomplete applications and applications without enclosures will not be considered.

- 3) Orders issued by Government of Telangana and National Commission for Indian System of Medicine will be applicable for admissions.
- 4) Candidates admission is strictly provisional. The mere fact that the Merit position issued to the candidate does not imply that his/her candidature is accepted by the University and it does not mean that the entries made by him/her in the on-line application are accepted as true and correct. On-line application can be filled through any computer with internet connection.

Explanation (a): A candidate who is regarded as a local candidate for the purpose of Admission into Undergraduate (UG AYUSH) in the state of

Telangana, but has studied in a State wide Institutions outside the state of Telangana, shall also be regarded as a Local candidate.

Explanation (b): A candidate, who has secured Admission to the relevant Undergraduate course (UG AYUSH) under Non-Local Quota in the State of Telangana, shall not be regarded as Local candidate.

2. As per the guidelines issued by Ministry of AYUSH and National Commission for Homoeopathy, the following are the eligibility criteria for admission into Post Graduate Courses.

a) Candidates who have appeared for AIAPGET 2024 and Candidate should have secured the following minimum eligibility Percentile or above.

i) 50% for General Category (Open) candidates.

ii) 45% for General Category (Persons with Disabilities (PWD)) candidates.

iii) 40% for SC, ST and other Backward class including Persons with Disabilities

b) Those who have passed the BHMS Degree Examination after undergoing a course of study in Homoeopathy of not less than 5 ½ years duration including the period of compulsory internship;

or

Those who passed equivalent Degree Examination included in the 2nd schedule of Homoeopathy Central Council Act 1973.

3. The candidates should have completed internship by 31-08-2024. Internship completion certificate to be issued by Principal of the college

4. Candidates who are already admitted and studying M.D. (Homeo) course shall not be permitted for counseling, until they discontinue the course before submitting the application form and such candidate shall submit the discontinuation certificate issued by the Head of the Institution along with the application.

5. Candidates who are already holding a Post Graduate Degree in Homoeopathy in a subject shall not be eligible for admission into another P.G. Homeo Course.

6. For in-service candidates three years of regular service shall be calculated as on **30-09-2024**

7. Merit Position of the candidates who have applied on-line shall be determined based on AIAPGET-2024 (Homoeo) rank and percentile as per their eligibility.
8. **Registration and Processing fee** : Rs. 4,000=00 for OC/BC Candidates.
