## PROSPECTUS FOR ADMISSION INTO MDS COURSES UNDER MANAGEMENT QUOTA FOR THE ACADEMIC YEAR 2025- 26

## **REGULATIONS:**

The following are the Regulations for admission into MDS Courses under Management Quota for the academic year 2025-26 into Dental Colleges including Army Dental College affiliated to KNR University of Health Sciences in the State of Telangana.

## 1. NUMBER OF SEATS UNDER MANAGEMENT QUOTA:

- **a.** The number of MDS seats to be available for the academic year 2025-26 under Management Quota in MDS courses at Private Dental colleges will be in accordance with the orders of the DCI/GOI/Govt. of Telangana.
- **b.** The seats for the year 2025-26 will be displayed in the KNRUHS website before exercising web options for counseling.
- c. In case any new seats in MDS Courses are permitted by Government of India in colleges affiliated to the University for the academic year 2025-26, those seats also will be filled up. No further notification will be issued.

## 2. ELIGIBILITY:

- a. The candidates who fulfill the following criteria are eligible for admission into MDS courses. They have to apply online and upload the original certificates for Management Quota seats in Dental colleges affiliated to Kaloji Narayana Rao University of Health Sciences, Warangal.
- **b.** The candidates who have qualified in NEET- MDS 2025 examination with the following revised cutoff scores and above are eligible to apply.

Category	Qualifying criteria	Cut off score
General	50 <sup>th</sup> percentile	261
SC / ST/ BC /OBC	40 <sup>th</sup> percentile	227
PWD (OC)	45 <sup>th</sup> percentile	244

\*Lower percentage / percentile of marks for SC/ST/BC/OBC /PWD is only for eligibility purpose and will not be applicable for reservations as there are no reservations under Management Quota.

- The Candidates from All over India are eligible for Management Quota Sub Category – 1.
- ii. NRI / OCI/PIO/ NRI sponsored candidates are eligible for Management Quota Sub – Category – 2 (NRI Quota)
- iii. Candidates sponsored by the Managements of Private Dental Colleges having MDS Courses in Telangana State are eligible for Management Quota Sub – Category – 3.
- iv. Army Dental College MDS seats are reserved for wards of army personnel only.
- v. BDS Degree shall be recognized by the Dental Council of India.
- vi. BDS Graduates pursuing internship shall have completed internship on or before 30-06-2025.
- vii. Must have registered with State Dental Council and subject to the fulfillment of the conditions stipulated in Regulations and its documentary proof should be uploaded along with online application.

#### Note:

- i. If a candidate is found to have submitted false information or concealed any relevant information regarding this matter, such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be taken by the University/respective institution.
- ii. If the candidate is having a Dental qualification equivalent to BDS (Primary Dental qualification) from outside India, the Degree should have been recognized by Dental Council of India for enrolment as Dental Practitioner in the Country.

- iii. Candidate must have registered with Dental Council of India or any State Dental Council.
- iv. Candidates who are already studying MDS course shall not be permitted for registration for web-based counseling unless they discontinue the course by remitting requisite bond amount and stipend drawn up to that date before submitting the application form. Such candidates shall have to upload the certificate issued by the Head of the Institution to that effect along with the online application form.
- v. **Equivalency fee:** Candidates must pay fee for verification of certificates with regard to equivalence / equivalency as specified in the regulations along with the registration fee, in case of obtaining BDS Degree from other state or other country.
- vi. The Registration fee and Verification fee once paid will not be refunded or adjusted to a future date. Therefore, candidates are advised to check eligibility conditions thoroughly before applying for determining merit position in respective categories for State quota seats using NEET-MDS-2025 rank.

## 3. ONLINE APPLICATIONS:

The on-line application form for determining merit position in respective categories (Sub category – 1,2 & 3) for Management Quota seats using NEET–MDS–2025 scores will be available on the website <u>https://pvttsmds.tsche.in</u> from **08.00AM on 03-07-2025 up to 03.00 PM on 07-07-2025**.

**Note**: The candidates are advised to take a print out of the Prospectus / Instructions to fill the application from the website <u>http://www.knruhs.telangana.gov.in</u> or <u>https://pvttsmds.tsche.in</u> before proceeding to fill the application form.

The candidate should fill the online application form available in the Website and upload all necessary certificates with the data required for through Computer. The online application form can be filled through any computer with Internet connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, scanned Photo and Signature in the jpg/.gif format separately (as shown below) (step-1) and ready to enter his/her correct data and upload the certificates, photo and signature after the payment of application fee through Online.

## 4. APPLICATIONS THROUGH ONLINE:

- **4.2** Keep the following required documents ready:

  - (e) Study Certificate(s) from 1st BDS to final BDS.
  - (f) Latest Category certificate in case of BC/SC/ST candidates issued by Competent Authority (if applicable for MDS NEET 2025 Cut-off score under category for eligibility)
  - (g) Internship completion certificate
  - (h) Dental Council Registration Certificate.
  - (i) Permanent Dental Registration Certificate is mandatory if the candidate obtained Degree Certificate from outside the country.
  - (j) Candidates claiming NRI quota (MQ2) should submit the following documents from a Blood relative such as Father/Mother/Brother/Sister/Uncle/Aunt only and should submit a declaration to that effect.
    - 1. NRI Sponsorship certificate (DECLARATION Form)
    - 2. NRI status certificate of the financial supporter issued by embassy of respective country under their seal.
    - 3. Copy of NRI Bank account pass book of the financial supporter.
    - 4. Copy of Pass port of NRI financial supporter
  - (k) Sponsorship Certificate from College for Institutional Quota (MQ3)
  - (I) Credit/Debit Card

- (m) Documents required for eligibility in Army College of Dental Sciences (ACDS)
  - Copy of Ex-servicemen Identity card, discharge book, PPO, Part II order and ECHS card of the candidate along with certificate as per ACDS Prospectus duly signed by Zilla Sainik Welfare Officer.
  - 2. Copy of Serving certificate, Dependency certificate.
- **4.3** The fee can be paid through Debit card / Credit card or Net Banking.



#### 5. **REGISTRATION & VERIFICATION FEE FOR ONLINE APPLICATION:**

The Registration and Verification fee is Rs. 10,000/- (Bank transaction charges extra).

# 6. EQUIVALENCY FEE FOR CANDIDATES STUDIED OUTSIDE THE STATE AND COUNTRY:

Candidates must pay fee for verification of certificates with regard to equivalence / equivalency as specified in the regulations along with the registration fee, in case of obtaining BDS Degree from other state or other country of Rs. 5,000 & Rs. 7,000 respectively.

The Registration fee and Verification fee once paid will not be refunded or adjusted to a future date.

<u>Note</u>: The candidature of the applicant will not be considered for admission to MDS courses unless the candidate uploads all relevant scanned original certificates.

## 7. MERIT LISTS:

The final merit position of the candidates who have applied online in response to the notification issued by KNRUHS for Management Quota seats shall be determined by NEET – MDS - 2025 Rank and as per their eligibility criteria, applicable regulations, guidelines viz:

- i. As per MDS Regulations of Dental Council of India, the candidates who secure minimum of 50th percentile for general category, 40th percentile for SC/ST/BC candidates and 45<sup>th</sup> percentile for Persons with disabilities category in NEET-MDS-2025 cutoff scores are eligible for admission into MDS Courses only for the purpose of qualifying criteria as there are no reservations under Management Quota. Any changes in the qualifying score as notified by DCI shall be applicable.
- The University will release final merit list of eligible candidates for exercising web options after verification of uploaded certificates by the University.

<u>Management Quota Seats are allotted as per G.O.Ms.No.40, HM&FW (C1) Dept., dated:</u> 09-05-2017: and subsequent amendments (for rules of admissions).

- a) 50% of seats in each specialty in each college are Management Quota seats. The Management Quota Seats are categorized into Management Quota (a) Sub Category MQ1. 25%, Management Quota (b) Sub Category MQ2. 15% NRI quota (NRI/NRI Sponsored) (c)Management Quota Sub Category MQ3 Institutional Preference Quota 10%.
- b) For Management Quota Sub Category MQ1 25%, candidates from all the states and union territories of India are eligible.
- c) For Management Quota Sub Category MQ2 15%, NRI candidates, NRI sponsored candidates, OCI card holders and Persons of Indian Origin (PIO) are eligible.
- d) For Management Quota Sub Category MQ3 10%, candidates sponsored by the Managements of the Private Dental Colleges having Post Graduate Course in the State of Telangana.

#### Note: I. The eligibility criteria for sub category MQ3 in an institution is as follows.

- 1. Candidate completed BDS from that institution
- 2. Candidate is an employee of that institution
- 3. Candidate is the son / daughter of employee of that institution

#### II. The Eligibility criteria for NRI (MQ2) Quota is as follows:

- i) Admission to NRI seats will be made on the basis of NEET-MDS-2025 merit ranks of eligible candidates who have applied on-line for NRI seats.
- ii) NRI Financially supporting the candidate must be a Blood relative such as Father/Mother/Brother/Sister/Uncle/Aunt only and should submit a declaration to that effect.
- iii) Candidate opting for NRI seat must furnish the photocopies of following supporting documents.

1) NRI Sponsorship certificate (Declaration Form)

- 2) NRI status certificate of the financial supporter issued by embassy of respective country under their seal.
- 3) Copy of NRI Bank account pass book of the financial supporter.
- 4) Copy of Pass port of NRI financial supporter

There are no reservations for SC/ST/BC/EWS in all the categories of the Management Quota seats. There are no other reservations.

#### 8. UNIVERSITY FEE:

1. Allotted candidates have to pay the following University fee through payment gate way for downloading the allotment order

MQ 1 Management Quota sub category 1: Rs.49,600/-

MQ2 (NRI) & MQ3 (Institutional Quota): Rs.69,600/-

- 2. Tuition Fee as notified by the Government
- **3**. The candidates selected into MDS course shall work for one year as "Senior Resident" in the Institution where they pursued the course.

<u>Note:</u> Candidates who have applied online in response to this office notification for determining merit position for Management Quota seats shall upload the certificates online along with the application. Candidates have to submit one set of print out of application form, original certificates and self-attested copies of certificates at allotted college at the time of admission for verification. In case of any discrepancy, allotment of admission is cancelled.

#### 9. <u>COUNSELING</u>:

The notification for schedule for exercising web options will be issued separately on KNRUHS website. Verification of uploaded certificates will be done only once for webbased counseling irrespective of number of rounds of exercising web-based options and number of counseling. Hence, candidates who have applied on-line are advised to upload all original certificates at the time of online registrations without fail for scrutiny by university. No individual communications will be sent. Candidates are informed to check the website regularly for notifications.

The Admission Committee shall have power to review the selection in case of any errors, misrepresentation or glaring injustice and cancel the selection/admission. In all matters relating to selection and admissions, the decision of the Admission Committee shall be final and binding on the Candidates and selections cannot be questioned after admissions are closed.

#### 10. ADMISSION RULES:

- 10.1.1 The letter of selection of admission for selected candidates has to be downloaded from the website after payment of University fee through payment gateway. All the candidates joining the MDS courses shall execute bond on a non-judicial stamp paper of Rs. 100/- as prescribed in Annexure-II to the effect that he / she will complete the prescribed period of training or in default to pay Rs.5,00,000/- (Rupees Five Lakhs only) to the University.
- 10.1.2 **Bond for service after completion of degree**: Candidate shall submit a bond for serving the State of Telangana as per existing Government Regulations at the time of admission.
- 10.2 The candidates who discontinue the course after issue of notification for final round of counseling or later will have to pay discontinuation fee of Rs.5,00,000/- (Rupees Five Lakhs only) They will be debarred from participating in counseling's for admission into MDS for a period of three (3) years under KNR UHS.
- **10.3** The original certificates submitted at the time of admission to the Principal of the allotted college shall not be returned to the candidates until they complete their course.
- **10.4 <u>ATTENDANCE</u>**: Candidates selected for the various courses should be whole time students. The candidate is required to put in a minimum of 80% attendance during each academic year for being eligible to appear for the examination.

In a year all 365 days will be considered as working days and students should get 80% attendance each year separately to get eligibility for appearing for University exams. The remaining days of absence (including maternity leave) will be considered for extension.

- **10.5** <u>**LEAVE**</u>: Each year students will be permitted to avail 30 days leave. No Post Graduate is allowed to go on leave for more than 10 days at a stretch. In-case the absence of the candidate availing Medical Leave / Maternity Leave / Any other Leave or unauthorized absence is beyond 30 days in a year the study period of the candidate will be extended to the extent of such period. No other leave is permitted.
- **10.6 MATERNITY LEAVE:** Women students can avail maternity leave up to 180 days only once in their MDS course of study and the study period will be extended to the extent of Maternity leave availed. The candidate shall not be eligible to appear in the University examination till the completion of study period as per DCI Regulations (Duration of course).

#### 10.7 BREAK OF STUDY AND RE-ADMISSION:

- a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals, Clinicals). If a student absents continuously for a period of 91 days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
- b. If the break of study (91 days or more) in more than one spell, the candidate's representation in the prescribed pro-forma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.
- c. Candidates who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission in to the course and the studentship stands cancel without any further notice.
- d. The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the Dental Council of India from time to time.

#### **10.8 <u>PRIVATE PRACTICE</u>:**

No Post Graduate is allowed to do any private practice or consultation and should not accept any part time employment in any State or central or Quasi Government or private organizations during the period of Post Graduate study. The Principal has to take appropriate action after giving opportunity for explanation, if any student violates this rule.

#### 10.9 COLLEGE REGULATIONS:

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal.

#### **11. CLOSURE OF ADMISSIONS:**

- **11.1** The admissions shall be closed as per the time schedule given by the DCI.
- **11.2** Any vacancy that arises after closure of admissions shall not be filled.

#### **12. PERIOD OF TRAINING:**

The duration of MDS Course is 3 Years. A candidate admitted into MDS course shall pass the examination within 4 years from the date of completion of the course. If he/she fails to pass the examination within the period specified above, he/she shall not be permitted to appear for the examination thereafter and qualify for the award of MDS Degree.

#### **13. COMMENCEMENT OF THE COURSE:**

The course shall commence as per the schedule notified. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.

## **14. POWERS OF THE PRINCIPAL:**

Notwithstanding anything contained in these regulations, the Principal may, at any time before completion of the Post Graduate course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks' time from the date of the receipt of the show cause notice to submit a written explanation and or on a personal hearing, order the cancellation of admission to the course, if in his opinion, such candidate had furnished incorrect particulars or false information in the application form or in the documents attached thereto or in the Statements made either before the authority In-charge of admissions or the Principal or any other manner. Against any such order of the Principal, an appeal shall lie to the Registrar, KNR University of Health Sciences, Telangana

#### **15. POWERS OF THE KNR UNIVERSITY OF HEALTH SCIENCES:**

KNR University of Health Sciences, may either suo moto or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation there to as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation. University has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake / false/forged.

#### **16. DISCIPLINE:**

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University either before the print or electronic media or anywhere which amounts to dereliction of duties. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities/ DCI/Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.

## 17. RAGGING:

Ragging is prohibited in the Educational Institutions of State of Telangana and students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per law.
