## NOTIFICATION FOR ADMISSION INTO MBBS AND BDS COURSES UNDER COMPETENT AUTHORITY QUOTA FOR THE ACADEMIC YEAR 2025-26 IN TO MEDICAL & DENTAL COLLEGES AFFILIATED TO KNRUHS IN THE STATE OF TELANGANA

Applications through online are invited from the candidates those who have qualified by securing the cutoff scores or above in National Eligibility-cum- Entrance Test (NEET) UG-2025 for admission into the Under Graduate Medical and Dental Courses for the academic year 2025-26 under Competent Authority Quota in to Government, Private Medical & Dental Colleges affiliated to KNRUHS, Warangal in the State of Telangana.

Notification is issued for online registration for web-based counseling to determine State Merit position for admission into Competent Authority Quota seats only i.e., the seats in Government Medical / Dental Colleges after deducting 15% of seats contributed to All India Quota and Category 'A' seats in Private Un-aided Non-Minority and Minority Medical colleges, Private Un-aided Non-Minority Dental Colleges including Army College of Dental Sciences, Secunderabad. Total number of seats available under Competent Authority Quota in all categories along with seat matrix for the academic year 2025-26 will be notified on KNRUHS website before exercising web options for counselling. Tuition fee notified by the Government of Telangana vide G.O.Ms.No. 106 HM&FW (C1) Dept., Dated: 28.07.2023.

#### Cut-off score in NEET UG - 2025 for MBBS and BDS courses:

Qualifying Cut off score Category Criteria General Category including 50<sup>th</sup> Percentile 144 **EWS** SC/ST/BC & PWD Candidates of SC/ST/BC 40<sup>th</sup> Percentile 113 Categories. Persons with Disability (OC) 45<sup>th</sup> Percentile 127

Candidates should have secured the following cutoff score or above in NEET-UG-2025

#### Schedule for registration through online and uploading of all relevant certificates:

Candidates can register online and upload scanned original certificates on website <a href="https://tsmedadm.tsche.in">https://tsmedadm.tsche.in</a> from <a href="https://tsmedadm.tsche.in">08.00 AM on 16-07-2025 up to 06.00 PM on 25-07-2025.</a>

Provisional Final Merit position of the applied candidates will be prepared based on NEET UG – 2025 Rank and other eligibility criteria notified here under after verification of scanned original certificates. Final verification of original certificates will be conducted at the time of admission at allotted college by the Admission Committee of the college.

#### I. ELIGIBILITY:

The candidates, who have qualified in NEET- UG -2025 by securing marks of cutoff score or above have to apply for determining the State Merit position for Competent Authority Quota seats subject to the conditions specified in admission Regulations/Prospectus for the AY 2025-26.

- 1. A candidate for admission into Under graduate courses under Competent Authority Quota in Telangana should be Indian Nationals (or) Person of Indian Origin (PIO), Overseas Citizens of India (OCI) card holder (PIO/OCI status issued before 04-03-2021) and shall fulfill the following provisions (G.O.Ms.No. 33 HM&FW(C1) Dept. Dated: 19-7-2024).
  - If the candidate has studied in an Educational Institutions in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in relevant qualifying examination.

or

- Where during the whole or any part of the four consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared for the relevant qualifying examination, he has not studied in Educational Institutions, if he had resided in that local area for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination, in which he appeared or as the case may be first appeared.
- Local area herein means the State of Telangana. Further, in case the candidate has not studied in any educational institution and has resided in the local area as stated at (ii) above, to be eligible for admission into Under graduate courses under Competent Authority Quota, the candidate should have appeared for the relevant qualifying examination in the State of Telangana.

**NOTE:** Admissions are subject to the final outcome of the pending SLPs in the Hon'ble Supreme Court of India.

## 2. Educational Qualification: - In accordance with NMC Regulations

The candidate should have passed Intermediate (10+2 pattern) or its equivalent examination with Physics, Chemistry, Biology (Botany, Zoology) / Biotechnology and English.

- i. OC candidates should obtain not less than 50% marks in science subjects.
- BC/SC/ST candidates should obtain not less than 40% marks in science subjects.
- iii. OC PWD candidates should obtain not less than 45% marks in science subjects.
- iv. Candidates claiming reservation under EWS category also should obtain 50%marks in science subjects.
- 3. The candidate should have qualified in NEET UG -2025 as per cut off scores notified above.
- 4. Age: The candidate should have completed 17 years of age as on 31-12-2025. The candidates who do not complete 17 years as on 31-12-2025 need not apply for the counseling. The above age criteria are applicable to all candidates of all categories.
- 5. The candidates who claim for admission under Persons with Disabilities (PWD) category shall mention in the online application as applying under PWD category and have to appear before a Medical Board to be constituted for the purpose by the University as per the schedule to be notified by the University for eligibility under PWD status.
- 6. The candidates are advised to download and read the Prospectus/Regulations available in the website <u>http://www.knruhs.telangana.gov.in/</u> before filling the online application form for admission into MBBS & BDS Courses for the academic year 2025-26.
- 7. NEET UG 2025 qualified and eligible candidates as per the concerned regulations who desire to take admission in to MBBS/BDS Courses in to Government, Private Un- aided Non- minority & Minority Medical colleges & Govt. Dental College and Private Non- Minority Dental Colleges including Army College of Dental Sciences shall apply online and to upload all original certificates for determining the Merit position for Telangana State Competent Authority Quota seats. The online application can be filled through any computer with internet connection. (NOTE: PREFERBLY DESKTOP OR LAPTOP only)

- 8. **Registration and Processing Fee for UG Medical and Dental Courses: -** The Registration and Processing fee is Rs.4000/- (Bank transaction charges extra) for OC & BC candidates and for SC/ST candidates is Rs.3200/- (Bank transaction charges extra). Fee shall be paid online through Debit card / Credit card or Net Banking.\*\*
  - \*\* Registration & Processing fee once paid will not be refunded or adjusted to a further date.
- 9. The candidates are advised to download and read the Prospectus of the course to verify for eligibility.
- 10. Procedure for filling online application and online payment for MBBS and BDS Courses:
  - i. The registration & Processing fee can be paid through Debit card / Credit card or Net Banking.
  - ii. The registration & Processing fee paid by the applicants is not refundable under any circumstances.
  - iii. Read the Notification, Prospectus / Regulations carefully.

- **12.** Visit website through Computer or Laptop only with Internet connection to fill the application form.
- 13. Fill in all the details in the online application form and upload all the documents which are mandatory.
- 14. Important information to the candidates:
  - a. On-line application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-UG-2025 Rank.
  - b. The mere fact that merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
  - c. Candidates may please note that the University will take up the verification of certificates with regard to eligibility conditions i.e., educational qualifications, Local status, category status as per uploaded relevant certificates by the concerned department officials. If the information furnished by the candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deemed fit will be taken.

- d. Candidates' eligibility for admission into UG courses for the academic year 2025-26 will be examined by the University only after scrutiny of application along with all uploaded copies of required certificates and provisional final merit list will be notified.
- e. Registration along with uploading of Scanned Original certificates will be done only once irrespective of the number of counsellings. No separate notification will be issued for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
- f. This notification is for online registration for determining the State Merit position in respective categories using NEET- UG-2025 Rank only for eligible candidates. The schedule for exercising web options for admission to MBBS/BDS courses will be notified separately on University website. Candidates are advised to check the University web-site for notifications, counseling schedule, seat matrix and other details from time to time.
- g. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission. Admission will be considered only for candidates, who have secured marks above cutoff score in NEET- UG-2025 exam and based on the state merit order as the case may be.
- h. Scrutiny of uploaded Original Certificates shall be conducted by the University and concerned departmental officials. After scrutiny of application and certificates provisional final merit list will be released. Candidates are advised to refer to KNRUHS website for further details regarding schedule of exercising web options. No individual communication will be sent.
- i. Admissions will be in accordance with the procedure notified in Rules of Admission vide G. O. MS. No. 114 HM& FW(C1) Department Dt. 05.07.2017, subsequent amendments, G.O.Ms.No. 125, Health, Medical and Family Welfare (Cl) Department Dated: 22.09.2022, G.O.Ms No.75 HM&FW(C1) Dept. Dated:04-07-2023, G.O.Ms No.33 HM&FW(C1) Dept. Dated:19-07-2024 and relevant Hon'ble Supreme Court/High Court orders.
- j. Candidates have to exercise web options for seats in the colleges in which they are interested to join for MBBS course and BDS course separately. Candidates and parents are informed to exercise web options very carefully in order of their preference for colleges and also to take a print out of exercised web options which are uploaded for reference.

k. After allotment the candidate should download the allotment order, submit the print- out of the filled-in Online application form, allotment order, Bonds and original certificates along with (1) set of self-attested copies to the Principal of allotted college at the time of joining for final verification by the admissions committee of allotted college. The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
