In continuation to this office notifications dated: 26.06.2025, 07.07.2025, 17.07.2025 and 08.08.2025, as per National Board of Examinations (NBE) in Medical Sciences, New Delhi, notification dated 14.08.2025 issued in accordance with the Ministry of Health & Family Welfare, Govt. of India letter No. V. 12025/84/2024-DE dated 10th August 2025, KNRUHS hereby notifies online registration from NEET-MDS- 2025 qualified candidates for admission into MDS courses under Competent Authority Quota into Dental Colleges affiliated to KNR University of Health Sciences including Army College of Dental Sciences in the State of Telangana.

Notification is issued for online registration for web-based counseling to update State Merit position for admission into **Competent Authority Quota** seats only. Updated Final Merit list will be notified after scrutiny of all certificates uploaded at the time of online registration. Total number of vacant seats available under Competent Authority Quota for the academic year 2025-26 will be notified on KNRUHS website before exercising web options for counselling. Tuition fee payable will be as notified by the Government of Telangana.
