In continuation to this office notifications dated: 02.07.2025, 23.07.2025, 30.07.2025 & 14.08.2025, as per National Board of Examinations (NBE), New Delhi, notification dated 14.08.2025, issued in accordance with the Ministry of Health & Family Welfare, Govt. of India letter No. V. 12025/84/2024-DE dated 10th August 2025, KNRUHS hereby notifies online registration from NEET-MDS-2025 qualified candidates for admission into vacant MDS seats under Management Quota MQ1, MQ2 (NRI), MQ3 categories for the academic year 2025-26 into affiliated Private Dental colleges in Telangana State including Army College of Dental Sciences.

Notification is issued for online registration for web-based counseling to update State Merit position for admission into **Management Quota** seats only. Updated Final Merit list will be notified after scrutiny of all certificates uploaded at the time of online registration. Total number of vacant seats available under Management Quota for the academic year 2025-26 will be notified on KNRUHS website before exercising web options for counseling. Tuition fee payable will be as notified by the Government of Telangana.
