**NOTIFICATION TO SUBMIT CERTIFICATE OF EMPLOYMENT FROM THE  
COMPETENT AUTHORITY FOR THE CANDIDATE'S FATHER/MOTHER'S SERVICE  
OUTSIDE THE STATE FOR THE PERIOD CORRESPONDING TO THE CANDIDATE'S  
YEAR(S) OF STUDY OUTSIDE TELANGANA**

In-continuation of the earlier notification dated 31-07-2025, as per G.O. Ms. No. 150, Health, Medical & Family Welfare (C1) Department, Dated: 08.09.2025 and orders of Hon'ble Supreme Court of India in SLP (C) Nos. 021536-021588 of 2024, the candidates who studied outside Telangana for any period during the requisite four consecutive academic years ending with the academic year in which he appeared, or as the case may be, first appeared in the relevant qualifying examination will be eligible to be considered if they fall under any of the below categories;

1. Children of employees of the Telangana State Government who have served or are serving outside Telangana corresponding to the candidate's year/s of study outside Telangana.
2. Children of serving or retired employees belonging to the Telangana cadre of All India Services (IAS/IFS/IPS) who have served or are serving outside Telangana corresponding to the candidate's year/s of study outside Telangana.
3. Children of defence personnel/ex-servicemen/ Central Armed Police Force service who at the time of joining service, have declared their hometown to be in the State of Telangana and who have served or are serving outside Telangana corresponding to the candidate's year/s of study outside Telangana.
4. Children of employees of a Corporation/Agency/ Instrumentality under Government of Telangana, liable to be transferred anywhere in India as per the terms and conditions of his/her employment, who have served or are serving outside Telangana corresponding to the candidate's year/s of study outside Telangana.

Subject to the candidate submitting Certificate of employment from the competent authority for the candidate's father/mother's service outside the State for the period corresponding to the candidate's year/s of study outside Telangana.

**NOTE:** Candidates who fall under above mentioned categories and have already registered for MBBS/BDS admissions under Management Quota for the AY 2025-26 are only eligible for verification of Certificate of employment and are instructed to visit KNRUHS, Telangana, Warangal in person for verification.

The eligible candidates shall visit KNRUHS, Telangana, Warangal, in person with the following certificates from **10.00 AM on 09.09.2025 up to 05.00 PM on 11.09.2025** for verification and to consider for admissions into MBBS/BDS courses under Management Quota for the AY 2025-26.

1. Certificate of employment from the competent authority for the candidate's father/mother's service outside the State for the period corresponding to the candidate's year/s of study outside Telangana.
2. Printout of Filled in Application form of registration.
3. Bonafide/study certificates of candidate from 9<sup>th</sup>, 10<sup>th</sup> class and Intermediate/10+2 or equivalent certificate. (Original).
4. Aadhaar card of the candidate.
5. Photocopies (1 set) of all the above certificates.
