This notification is issued for registration of the candidates to appear for MD/MS Ayurveda First Summative Assessment Supplementary Examinations commencing from **01.11.2025**.

1) Eligibility to appear for MD/MS Ayurveda First Summative Assessment Supplementary Examinations:

The MD/MS Ayurveda students admitted by the KNRUHS during the academic year **2024-25** whose admissions are approved by the University and completed study period with minimum **80% attendance** in each subject and minimum **60% Semester Grade Point Average (SGPA) in the first semester** are eligible to appear for the examinations in November 2025 subject to the course regulations.

- 2) The Cut-off date for calculation of attendance percentage of the students is up to **01.10.2025**.
- 3) The uploading of the attendance and SGPA of the students is from **06.10.2025 to 08.10.2025**.
- 4) The confirmation date for uploaded attendance and SGPA of the students is on **10.10.2025**.
- 5) **Digital valuation and providing only single answer booklet without additional answer booklet:**

The University is a digital campus and implementing digital valuation for all courses. For MD/MS Ayurveda course, single answer booklet with candidate specific bar code on each page will be issued to the candidates appearing for examinations and no additional answer book will be issued to the candidates. The candidates should answer all the questions in the single answer booklet only.
