REGULATIONS:

The following are the Regulations for admission into Management Quota seats MQ-1, MQ-2 NRI QUOTA & MQ-3 INSTIUTIONAL QUOTA in Post Graduate Medical Degree / Diploma Courses for the academic year 2025-26 and shall apply to all admissions into all the Un-aided Private Non- Minority and Minority Medical Colleges affiliated to KNR University of Health Sciences in the State of Telangana.

1. Number of seats under Management Quota:

- a. The number of seats to be available for the academic year 2025-26 into Post Graduate Medical Degree/Diploma courses at Private Un-Aided Non-Minority and Minority Medical Colleges will be in accordance with the orders of the NMC/GOI/Govt. of Telangana.
- **b.** The seat matrix for Management Quota seats for the academic year 2025-26 will be displayed in the KNRUHS website before notification for exercising web options into counseling.
- c. In case any new PG Medical seats are permitted by the Government of India in colleges affiliated to the KNRUHS for the academic year 2025-26, those seats also will be filled up. **NO FURTHER NOTIFICATION WILL BE ISSUED.**

2. ELIGIBILITY:

- a. The candidates who fulfill the following criteria are eligible for admission into post graduate Medical Degree / Diploma courses. Candidates have to apply through online and to upload the original certificates for Management Quota MQ-1, MQ-2 NRI QUOTA & MQ-3 INSTIUTIONAL QUOTA seats into colleges affiliated to Kaloji Narayana Rao University of Health Sciences, Warangal.
- b. The candidates qualified in NEET PG-2025 examination with the following cutoff scores and above as per National Board of Examinations, New Delhi as per section (10) of Indian Medical Council Act, 1956 are eligible to apply.

NEET PG 2025 CUTOFF SCORE:

General Category/EWS	50 th Percentile	276
SC/ST/OBC (including PWD of SC/ST/OBC)	40 th Percentile	235
Persons with Disability (OC) PWD	45 th percentile	255

*Lower percentage / percentile of marks for SC/ST/BC/OBC /PWD is only for eligibility purpose and will not be applicable for reservations as there are no reservations under management quota.

- i. The Candidates from all over India are eligible for Management Quota Sub –
 Category 1.
- ii. NRI / OCI / NRI sponsored candidates are eligible for Management QuotaSub -Category 2.
- iii. Candidates sponsored by the Managements of Private Un Aided Non Minority and Minority Medical Colleges having Post Graduate Courses in Telangana State are eligible for Management Quota Sub Category 3
 Institutional Quota
- iv. MBBS Degree should be recognized by the MCI/NMC.
- v. MBBS Graduates pursuing internship should have completed internship on or before 31.07.2025 from recognized colleges. (by NMC).
- vi. Must have registered with Telangana State Medical Council and subject to the fulfillment of the conditions stipulated in Regulations and its documentary proof should be uploaded along with the online application.

Note:

i. If a candidate is found to have submitted false information or concealed any relevant information regarding admission matter, such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be initiated by the University/respective institution as per rules. Legal issues if any shall be under the High Court of Judicature at Hyderabad for the State of Telangana.

- ii. If the candidate is having a Medical qualification equivalent to MBBS (Primary Medical qualification) from outside India, the Degree should have been recognized by the Medical Council of India/ National Medical Commission for enrolment as Medical Practitioner in the Country and registered by MCI/NMC.
- iii. Candidate must have Permanent Registration with Telangana State Medical Council and attested copies shall be uploaded along with the application.
- iv. Candidates must pay equivalency fee for verification of degree certificate obtained outside the State/Country as specified in the regulations along with the registration fee.
- v. The Registration and Verification fee once paid shall not be refunded or adjusted to a future date. Therefore, candidates are advised to check eligibility conditions thoroughly before applying for determining merit position.

3. ONLINE APPLICATIONS:

The on-line application form for determining merit position in respective categories (Sub category – 1,2 & 3) for Management Quota seats using NEET-PG-2025 scores will be available on the website https://pvttspgmed.tsche.in/ from 06.00 PM on 04.10.2025 up to 06.00 PM on 11.10.2025.

Note:

- The candidates are advised to take a print out of the Prospectus / Instructions to fill the application from the website http://www.knruhs.telangana.gov.in or https://pvttspgmed.tsche.in/ before proceeding to fill the application form.
- The candidate should fill the online application form available in the Website and to upload all necessary certificates with the data required for through computer with data connection. The online application form can be filled through any computer with Internet connection or mobile with data connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, scanned Photo and Signature in the jpg/.gif format separately (as shown below) (step-1) and ready to enter his/her correct data and upload the original certificates, photo and signature after the payment of application fee through Online.

4.1 The following documents are required:

- (c) Original/Provisional MBBS Degree Certificate
- (d) Aadhar Card
- (e) Study Certificate(s) from 1st year to final Year MBBS Course.
- (f) Latest Category certificate in case of BC/SC/ST candidates issued by the Competent Authority if applicable for NEET Cut-off score under category as there are no reservations for Management Quota seats.
- (g) Muslim Minority Certificate issue by the Competent Authority Government of Telangana if applicable.
- (h) Internship completion certificate by 31-07-2025.
- (i) Valid Permanent Medical Council Registration Certificate from Telangana state medical council.

(j) candidates claiming NRI quota (MQ2) shall submit the following documents

- from a Blood relative such as Father/Mother/Brother/Sister/Uncle/Aunt only and should submit a declaration to that effect.
 - 1. NRI Sponsorship certificate (DECLARATION Form)
 - 2. NRI status certificate of the financial supporter issued by embassy of respective country under their seal.
 - 3. Copy of NRI Bank account pass book of the financial supporter.
 - 4. Copy of Pass port of NRI financial supporter





- 4. A copy of the annual medical register where in the name appears will be supplied to every person registered on payment.

 5. After the publication of name in the printed medical register the last edition of the register alone is the legal evidence of registration:
- 6. All persons registered under this act are eligible to practice modern system of Medicine.

5. REGISTRATION & VERIFICATION FEE FOR ONLINE APPLICATION:

The Registration and Processing fee is Rs.15,000/- (Bank transaction charges extra).

6. EQUIVALENCY VERIFICATION FEE FOR CANDIDATES STUDIED OUTSIDE THE STATE AND ABROAD:

The candidates who completed Under Graduate Degree course outside the State or Country/Abroad and got their certificates registered with Medical Council of India and applying for admission into Post Graduate Medical Degree/Diploma courses under this University, shall pay Verification fee of Rs.8000/- for the Degrees acquired outside the State and of Rs.10,000/- for Degree certificates acquired abroad.

7. MERIT LISTS:

The provisional and final merit position of the candidates who have applied online in response to the notification issued by KNR University of Health Sciences for Management Quota seats MQ-1, MQ-2 NRI QUOTA & MQ-3 INSTIUTIONAL QUOTA shall be determined as per NEET-PG-2025 scores and as per their eligibility criteria, applicable regulations, guidelines viz:

- As per PG Medical Regulations of National Medical Commission / Medical Council of India, the candidates shall secure minimum of marks at 50th percentile for General category, 40th percentile for SC/ST/BC category and 45th percentile for Persons with disabilities (under General category) in NEET PG 2025 cutoff scores are eligible for admission into PG Medical Courses only for the purpose of qualifying criteria as there are no reservations under Management Quota
- **ii.** The University will notify provisional and final merit list of eligible candidates for exercising web options after verification of uploaded original certificates by the University and issue schedule for exercising web options.

<u>Management Quota Seats (as per G.O.Ms.No.40, 42, HM&FW (C1) Dept., dated: 09-05-2017: and subsequent amendments for distribution of seats</u>

a) 50% of seats in each specialty in each college are management quota seats. The Management Quota Seats are categorized into Management Quota (a) Sub – Category – MQ1. 25%, Management Quota (b) Sub – Category – MQ2. 15% NRI quota (NRI/NRI Sponsored) (c)Management Quota Sub – Category – MQ3 Institutional Quota – 10%.

- **b)** For Management Quota Sub Category MQ1 25%, candidates from all the states and union territories of India are eligible.
- c) For Management Quota Sub Category MQ2 15%, NRI candidates and NRI sponsored candidates are eligible.
- **d)** For Management Quota Sub Category MQ3 10%, candidates sponsored by the Managements of the Private Un Aided Non Minority and Private Un-aided Minority Medical Colleges having Post Graduate Course in the State of Telangana.

Note:

- I. The eligibility criteria for sub category MQ3 in an institution is as follows.
 - 1. Candidate completed MBBS from that institution
 - 2. Candidate is an employee of that institution
 - 3. Candidate is the son / daughter of employee of that institution
 - 4. Candidate shall submit a sponsorship certificate from the Principal of concerned Medical College.

II. The Eligibility criteria for NRI (MQ2) Quota is as follows:

- Admission to NRI seats will be made on the basis of NEET PG- 2025 merit ranks of eligible candidates who have applied on-line for NRI seats.
- ii) NRI Financially supporting the candidate must be a Blood relative such as Father/Mother/Brother/Sister/Uncle/Aunt only and should submit a declaration to that effect.
- iii) Candidate opting for NRI seat must furnish the photocopies of following supporting documents.
 - 1) NRI Sponsorship certificate (DECLARATION Form)
 - 2) NRI status certificate of the financial supporter issued by embassy of respective country under their seal.
 - 3) Copy of NRI Bank account pass book of the financial supporter.
 - 4) Copy of Pass port of NRI financial supporter

There are no reservations for SC/ ST, BC categories in the Management Quota seats, there are no other reservations.

Minority medical colleges seats will be filled with Muslim Minority category candidates only.

In case, Muslim Minority candidates are not available, those seats will be allotted to Non- Minority students in the last phase of counseling.

8. UNIVERSITY FEE:

a) Allotted candidates have to pay the following University fee through payment gate way for downloading the allotment order

MQ 1 Management Quota sub category 1: Rs.49,600/-

MQ2 (NRI) & MQ3 (Institutional Quota): Rs.69,600/-

- b) Tuition Fee as notified by the Government of Telangana
- c) The candidates selected into MD / MS / Diploma courses shall work for one year as "Senior Resident" in the Institution where they pursued the course.

NOTE: Candidates who have applied online in response to this office notification for determining merit position for Management Quota seats shall upload the certificates online along with the application. Candidates have to submit one set of print out of application form, original certificates and self attested copies of certificates at allotted college at the time of admission for verification. in case of any discrepancy, allotment of admission is cancelled.

9. **COUNSELING:**

Provisional and final merit list will be displayed on KNRUHS website after scrutiny of application and uploaded certificates. Verification of uploaded certificates will be done only once for web based counseling irrespective of number of phases of exercising web based options and counselings. Hence, candidates who have applied through on-line are advised to upload all original certificates at the time of online registrations without fail for scrutiny by the University. No individual communications will be sent. The notification for schedule for exercising web options will be issued separately on KNRUHS website. Candidates are informed to check the website regularly for notifications.

The Admission Committee shall have power to review the selection in case of any errors, misrepresentation or glaring injustice and cancel the selection/admission. In all matters relating to selection and admissions, the decision of the Admission Committee shall be final and binding on the Candidates and selections cannot be questioned after admissions are closed.

The procedure of Preparation of seat Matrix and selection of candidates will be as per G.O.MS. No. 40 & 42, HM&FW (c1) Dept., Govt. of Telangana, G.O.MS. No. 38, HM&FW (c1) Dept., dated 30-03-2019, subsequent amendments from time to time and relevant Hon'ble Supreme Court & Hon'ble High Court orders.

The Tuition fee for Management Quota seats in respect of Degree and Diploma of Clinical, Para-clinical and Pre-clinical courses will be as notified by the Government of Telangana

10. ADMISSION RULES:

The letter of selection of admission for selected candidates has to be downloaded from the website after payment of University fee by payment gateway. The following rules are applicable to all the candidates.

- All the candidates joining the Postgraduate Degree/Diploma courses shall execute bond on a stamped paper of Rs. 100/- as prescribed in Annexure-II to the effect that he / she will complete the prescribed period of training or in default to pay Rs.50,00,000/- (Rupees Fifty Lakhs only) to the University.
- The admitted candidates who discontinue the course after the second phase of counseling or later will have to pay penalty of Rs.50,00,000/- (Rupees Fifty Lakhs only) to prevent seat blocking. They will be debarred from participating in counsellings for admission into Postgraduate Degree/Diploma courses for a period of three (3) years under KNR UHS.
- 10.3 Senior Residency service Bond after completion of degree: All Postgraduate candidates on admission into postgraduate degree course shall execute a Bond at the time of admission to undertake to serve the Institution where they pursued the Course as a Senior Resident for a period of one year after successful completion of the PG Degree / Diploma Course.

- 10.4 The original certificates submitted by the candidates at the time of admission to the Principal of the allotted college shall not be returned to the candidates until they complete their course of study, subject to subregulations mentioned above.
- **10.5 Attendance:** Candidates selected for the various courses should be whole time students. The candidate is required to put in a minimum of 80% attendance for being eligible to appear for the examination.
 - a) **For Three Years Degree course**: -As per NMC regulations total days in a three year course will be 1095 days. So the total working days will be 939 days after deducting weekly offs (52×3 years =156 days). A student will require 80% attendance of working days (i.e., 751 days of 939 days) for appearing in the Examination. However period of training will be extended by the same number of days for which maternity/ paternity leave and total excess casual leave have been availed in three years.
 - b) For Two- Years Diploma course:- As per NMC regulations total days in a two year course will be 730 days. So the total working days will be 626 days after deducting weekly offs (52×2 years =104 days). A student will require 80% attendance of working days (i.e., 501 days of 730 days) for appearing in the Examination. However period of training will be extended by the same number of days for which maternity/ paternity leave and total excess casual leave have been availed in two years.
- 10.6 Leave: Students will be permitted to avail 20 days leave per year. 5 days of academic leave is permitted for entire duration of the training period. Post Graduates are not allowed to go on leave for more than 10 days continuously. In-case of Medical Leave / Maternity Leave / Any other Leave or unauthorized absence beyond 20 days in a year, the study period of the candidate will be extended to the extent of such period. No other leave is permitted.
- 10.7 Maternity Leave: Women students can avail maternity leave upto 180 days only once in their PG course of study and the study period will be extended to the extent of Maternity leave availed. The candidate shall not be eligible to appear in the University examination till the completion of study period as per MCI Regulations (Duration of course).

10.8 SANCTION OF LEAVE BEYOND 3 MONTHS AND TERMINATION OF STUDENTSHIP

- a. Every candidate after his admission shall attend the classes on all working days (Theory, Practicals, Clinicals). If a student absents continuously for a period of 91 days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
- **b.** If the break of study (91 days are more) in more than one spell, the candidate's Application in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.
- **c.** Candidates who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission in to the course and the studentship stands cancel without any further notice.
- **d.** The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the National Medical Commission from time to time.
- e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course

10.9 Private Practice:

No Post Graduate is allowed to do any private practice or consultation and should not accept any part time employment in any State or central or Quasi Government or private organizations during the period of Post Graduate study. The Principal has to take appropriate action after giving opportunity for explanation, if any student violates this rule.

10.10 College Regulations:

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Candidates are informed that their correspondence with the University shall be forwarded by the Principal of college with his remarks. (through proper channel) for consideration. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal.

11. CLOSURE OF ADMISSIONS:

- 11.1 The admissions shall be closed as per the schedule given by the University as per NMC Regulationss.
- Any vacancy after the date of closure of admissions shall not be filled. They shall not be carry forward to the next year as per the directions of the Hon'ble Supreme court of India.

12. COMMENCEMENT OF THE COURSE:

The course shall commence as per the schedule notified. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.

13. DURATION OF COURSE:

i. The duration of P.G. Diploma courses is 2 years and P.G. Degree courses is 3 years, In the case of students having a recognized two year Post Graduate Diploma course in the same subject, the duration of Degree course in the same subject shall be two years.

ii. DISSERTATION:

The Post Graduates must register the topic of their dissertation with the University after admission within six months of commencement of the course and approval of the University should be obtained. The dissertation shall be submitted within 2 ½ years of commencement of the course. In the case of the candidates granted exemption of one year of study period of degree course (candidates passed diploma of the same subject), the dissertation shall be submitted within 1 ½ years of commencement of the course. If the above schedule is not followed, the period of Post Graduation course shall be extended by six months.

iii. A student of a Postgraduate degree course in broad specialties shall present one poster and present one paper at a National / State conference. Candidate has to present one research paper which should be published / accepted for publication /submitted for publication during the period of his / her Postgraduate studies so as to make him / her eligible to appear at the Postgraduate degree examination.

14. MIGRATION AND TRANSFER OF CANDIDATES:

Migration / Transfer / Mutual transfer of Post Graduate students from one Medical college to another Medical College, from one course to another course and from Degree to Diploma and vice versa are not permitted under any circumstances.

15. PERIOD OF TRAINING:

The duration of P.G. Diploma courses is 2 years and P.G. Degree courses is 3 years, A candidate admitted into PG course shall pass the examination within 4 years from the date of completion of the course and the candidates registered for P.G. Diploma courses should clear the examination within 2 (two) years after completion of the course. If he/she fails to pass the examination within the period specified above, he/she shall not be permitted to appear for the examination thereafter and qualify for the award of PG Degree.

16. POWERS OF THE PRINCIPAL:

Not with standing anything contained in these regulations, the Principal may, at any time before completion of the Post Graduate course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit a written explanation and or on a personal hearing, order the cancellation of admission to the course, if in his opinion, such candidate had furnished incorrect particulars or false information in the application form or in the documents attached or in the Statements made either before the authority In- charge of admissions or the Principal or any other manner. Against any such order of the Principal, an appeal shall lie to the Registrar, KNR University of Health Sciences, Telangana.

17. POWERS OF THE KNR UNIVERSITY OF HEALTH SCIENCES:

KNR University of Health Sciences, may either suomoto or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the

concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation there to as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation. University has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake / false/forged.

18. Discipline:

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University either before the print or electronic media. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities/ NMC/Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.

19. Ragging:

Ragging is prohibited in the Educational Institutions of State of Telangana and students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per law.

20. Any candidate who has applied online and uploaded certificates for verification and exercises web options for web based counseling is deemed to have read the Prospectus and shall abide by all conditions and clauses of the Prospectus.
