PROSPECTUS FOR ADMISSIONS INTO M.D.(UNANI) COURSES UNDER COMPETENT AUTHORITY QUOTA FOR THE ACADEMIC YEAR 2025-26

The following are the Regulations for admission into M.D. (UNANI) in Govt. Nizamia Tibbi College, Hyderabad, affiliated to KNR University of Health Sciences, Telangana, Warangal for the academic year 2025-26.

2. **NUMBER OF SEATS**:

No. of seats permitted and available for admission for the academic year 2025-26 after excluding the seats contributed to All India Quota will be notified through KNRUHS website separately.

3. ELIGIBILITY FOR ADMISSION:

- **3.1.** Candidates who have appeared AIAPGET 2025 and whose names are included in the merit list of AIAPGET-2025 for Unani P.G. course are eligible to apply, subject to fulfillment of regulations, Candidate should secure the following minimum eligibility percentile or above.
 - a) 50th Percentile for General Category (Open)/EWS candidates.
 - **b)** 45th Percentile for General Category (Persons with Disabilities (OC-PWD)) candidates
 - c) 40th Percentile for SC, ST and other Backward class including Persons with Disabilities
- 3.2 The PG Courses leading to Doctor of Medicine in Unani are open to the holders of a Degree obtained after undergoing a regular institutional course of study in Unani both Theory and Practical of not less than four years duration of a University established in India by a state, provincial or Central Act or of an Institution or Board recognized by the University Grants Commission or by a State Government or incorporated under a Central or a State Act.
- **3.3** The candidate should have completed internship by 31.07.2025.
- 3.4 For in-service candidates, three years of regular service shall be calculated as on 09-2025. The in-service seats subject to the rules and regulations of Government of Telangana. The admissions into in-service seats will be considered subject to availability of in-service seats and deputation orders issued by Government of Telangana.

- 3.5 Candidates who are already admitted and studying MD (UNANI) Course shall not be permitted for counseling unless they discontinue the course by remitting the bond amount and the stipend taken upto that date before submitting application form and such candidates shall submit the discontinuance certificate issued by the Head of the Institution along with the application.
- **3.6** Candidates who are already holding a Post Graduate Degree in Unani in a subject shall not be eligible for admission into another P.G. Unani Course.
- **3.7** Regarding seats of Central Government Nomination (CGN), Revised Guidelines shall be applicable communicated by Govt. of India vide Letter F.No.Y-11030/14/2021-EP-III, dt. 02-05-2025.

4. **RESERVATIONS**:

4.1 15% seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Castes. As per G.O. Ms. No. 10, SCD(POA.A2) Dept., Dated: 14.04.2025 and as per Government orders dated. 16.05.2025, out of 15% of seats reserved for SC, 1% of seats shall be reserved for SC Group I, 9% of seats shall be reserved for SC Group III. The Rationalization of reservations shall be followed as per the said G.O. and Government orders from the AY 2025-26.

10% and 29% of the seats available in each course shall be reserved for ST and BC categories respectively under Competent Authority Quota.

- 4.2 A candidate claiming reservation under clause 4.1 shall produce a certificate of his / her social status in the form specified and appended as Annexure II to the application. Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to castes which are notified in the list as per the Telangana Government orders will be considered against the respective reserved seats.
- 4.3 The seats reserved for the SCs shall be made available to the STs and vice-versa, if qualified candidates are not available in these categories, the seats reserved for both SCs and STs shall be made available to the candidates in general pool, if qualified candidates belonging to the SCs and STs are not available.
- 4.4 15% of seats in clinical subjects and 30 % of seats in non-clinical subjects are reserved for in service candidates in each category. Candidates selected on merit in the respective categories shall be counted against in service quota. Candidates working on contract basis, consolidated pay basis, daily honorarium and adhoc basis are not considered as regular service candidates.

Explanation: An in-service candidate is one who has put in a minimum of three years of regular service as certified by Director of AYUSH Telangana.

4.5. Reservation for Persons with Disabilities category (PWD):

5% of seats in each specialty course wise are reserved for Persons with Disabilities category candidates. (PWD Quota reservation will be followed if sufficient number of seats are available for each course under each category).

4.6 EWS reservation:

Will be implemented as per the seats sanctioned by Government.

4.7 The number of seats reserved to various categories are as follows as per G.O.Ms.No.603, HM & FW (R2) Dept., dt.28-12-2004 and after making provision for 3 seats in Advia course for Government of India Nominees as per GOI Letter No.R.12013/1/2003-E&C (i), dt.23-3-2004 and 1 seat each in Moalijat and Qabalat-O-Amraz-e-Niswan courses for foreign nationals as per GOI Letter No.R.12013/1/2003-E&C (ii), dt.23-3-2004.

5. ELIGIBILITY AS LOCAL CANDIDATE:

(As per G.O. Ms. No. 149, HM&FW(C1) Dept., dated 28-10-2024)

- i. A Candidate to be eligible for Admission into PG AYUSH Courses under these Rules should be an Indian National/Person of Indian Origin/Overseas Citizen of India card holder and be a local candidate:
- ii. Local candidate means a candidate who has studied in the Educational Institutions in the state of Telangana as for a period of not less than four consecutive years ending with the academic year in which he appeared or as the case may be, first appeared in the relevant qualifying examination subject to
- Explanation (a): A candidate who is regarded as a local candidate for the purpose of Admission into Undergraduate (UG AYUSH) in the state of Telangana, but has studied in a State wide Institutions outside the state of Telangana, shall also be regarded as a Local candidate.
- Explanation (b): A candidate, who has secured Admission to the relevant

 Undergraduate course (UG AYUSH) under Non-Local Quota in the

 State of Telangana, shall not be regarded as Local candidate.

6. **ELIGIBILITY FOR ADMISSION:**

- 6.1 The PG Courses leading to Doctor of Medicine in Unani are open to the holders of BUMS Degree of any University/Statutory body included in the 2nd schedule to the IMCC Act, 1970.
- The candidate should have completed training as internee/House Officer before 31-07-2025.
- **6.3** For in service candidates three years of regular service shall be calculated as on 30-09-2025.
- 6.4 Candidates who are already admitted and studying MD (Unani) Course shall not be permitted for counseling unless they discontinue the course by remitting the bond amount and the stipend taken upto that date before submitting application form and such candidates shall submit the discontinuance certificate issued by the Head of the Institution along with the application.
- 6.5 Candidates who are already holding a Post Graduate Degree in Unani in a subject shall not be eligible for admission into another P.G. Unani Course.
- 6.6 Regarding seats of Central Government Nomination (CGN), Revised Guidelines shall be applicable communicated by Govt. of India vide Letter F.No.Y-11030/14/2021-EP-III, dt. 02-05-2025.

7. **APPLICATIONS:**

7.1 The online application form will be available on the website http://tsmdayush.tsche.in from 6.00 A.M. on 16.10.2025 up to 6.00 PM on 21.10.2025.

Note: The candidates are advised to take a print out of the prospectus / instructions to fill the application form from the website http://knruhs.telangana.gov.in before proceeding to fill the application form.

7.2 The candidate should fill the online application form available in the Website with the data required-for, through internet. The online application form can be filled through any computer with internet connection (home/internet café/net center). The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the .jpg/.gif format separately (as shown below) (step-1) and ready to enter his/her correct data and upload the photo and signature after the payment of application fee through Online.


1. Open the website https://tsmdayush.tsche.in Home page displayed as follows.

- d. Uploading of Certificates.






3. After entering the details click on validate button.




- 4. If all the details entered are correct and verified with OTP's your system will display a successful message and proceed to registration form





- 8. Now you will be directed to the Payment Gateway, Click OK

Do not refresh or close the page until you will receive a Successful Payment message It may take few seconds to processes the payment and verify the details wait patiently






11. For updating the details of the candidate enter Roll Number and the Registration number sent to your mobile and click on validate button to enter into the Application form.

- 7.4 After completing the data entry in all pages of the online application and after submitting the data through online, the candidate should take the print-out of the filled-in online application form. The Candidate should note the Barcode application number which appears on the printout of application for future reference.
- 7.5 The candidate should paste a recent passport size photograph in the space provided in the print out of online application form. The Photo should be attested by Gazetted Officer/ Principal of the College (identical to the photo that used for scanning)
- **7.6** The candidate should sign at the declaration area in the print out of the online application form and also put left hand thumb impression at the space provided without fail.
- 7.7 The candidate should submit the print-out of the filled-in online application along with the self attested copies of required certificates at the time of certificate verification and counseling at Help line center as notified by the University.

8. Registration and Processing Fee:

The registration and Processing fee is Rs. 4,000/- (Bank transaction charges extra) for OC/BC categories and Rs.3,000/- (Bank transaction charges extra) for SC/ST categories. For GOI Nominee candidates - Rs.4000 + Bank charges

- 9. The following certificates shall be uploaded during online registration and submitted along with print out of on-line application form at the time of admission:
- a) AIAPGET-2025 (UNANI) Hall Ticket.
- b) AIAPGET-2025 (UNANI) Rank Card.
- c) Self Attested copy of 6th to Intermediate.
- d)Self Attested copy of the Provisional / Original Degree Certificate of the qualifying examination
- d) Self Attested copies of memo of Marks obtained in all examinations of the qualifying examination (from first year to final year).
- e) Self Attested copy of Date of Birth Certificate.
- f). Study Certificate from 1st Year to Final Year BUMS.
- g) Self Attested copy of Internship Certificate.
- h) Certificate of Caste or Social Status as in proforma issued by MRO.

Note: In case candidates passed BUMS Course from state-wide institutions i.e. Government Nizamia Tibbi College, Hyderabad they shall enclose the study certificates from VI to Intermediate.

j) Service certificate if applicable.

10. VERIFICATION OF ORIGINAL CERTIFICATES.

The University will notify the schedule for counseling which includes verification of Original Certificates of candidates and exercising options by the candidates.

11. MERIT LIST:

Merit position of candidates shall be determined based on percentile and rank obtained in AIAPGET-2025. (Unani)

12. SELECTIONS:

- **12.1** Provisional Selection shall be made by the Selection Committee constituted by the University.
- **12.2** The Selection Committee shall provisionally select the candidates as per these regulations from among the candidates who qualified AIAPGET 2025 as per merit list.
- 12.3 The candidates shall produce their original certificates for verification and after verification if eligible, candidates shall exercise options for the courses they are interested to join in order of priority. Candidates are permitted to exercise one time options only irrespective of number of phases of counseling.
- 12.4 The candidates shall be called to appear for verification of original certificates one after another and they shall not enter the selection committee room in groups. Any person who obstructs the proceedings of the Selection Committee or otherwise misbehaves or causes disturbance at the selection committee meeting will be liable for disciplinary action as may be taken by the University.
- 12.5 The candidates shall submit their option for subjects of his / her choice in order of priority to Selection Committee. The Selection Committee will select the candidates as per the Admissions Regulations and Government Rules from among the eligible candidates after verification of original certificates and who

have submitted their options. The list of provisionally selected candidates will be displayed and the provisional selection intimations will be issued to the selected candidates.

- 12.6 The Selection Committee shall have power to review the provisional selection in case of any errors, misrepresentation, fraud or glaring injustice. In all matters relating to selections and admissions, the decision of the selection committee shall be final and binding on the candidates and selections cannot be questioned after admissions are closed.
- 12.7 If a candidate after choosing the subject fails to pay fees or fails to submit the bond, his/her selection stands cancelled automatically. If a candidate is absent for verification of original certificates and exercising options, he/she will not be considered for selection at the subsequent selection in the then available courses.

13. CONDITIONS OF ADMISSION:

- 13.1 The Principal, Govt. Nizamia Tibia, Unani Medical College, Hyderabad shall verify the correctness of documents. On his/her satisfaction he/she shall direct the candidates to credit the college fee etc., immediately.
- 13.2 Candidates joining courses shall execute a bond on non judicial stamp paper of value of Rs.100/- in the form specified in Annexure-I to ensure completion of the prescribed period of training or in default or for any other reason has to pay Rs.1,00,000/- to the Registrar, KNR University of Health Sciences and shall refund the stipend received upto that date to Government.
- **13.3** The Original certificates submitted shall not be returned to the candidates till they complete their course.
- 13.4 Candidates selected to various courses shall be whole time students. Service Candidates will have to apply for study leave and are required to produce the orders wherein such leave has been sanctioned to them from the competent authority within 3 months after joining the course.

14. FEES:

- 14.1 All the selected candidates are required to pay the admission fee, tuition fees, college fee, caution deposits etc., as per rules in force.
- **Tuition Fee**: All the candidates selected are required to pay the tuition fee as prescribed by the Government. If any of the candidate who joined in a course is allotted to another course, the tuition fee paid by the candidate will be

adjusted to the newly selected course and the tuition fee paid already shall not be refunded under any circumstances.

15. <u>UNIVERSITY FEE:</u>

Allotted candidates have to pay the following University fee through payment gate way for downloading the allotment order. The fee once paid shall not be refunded under any circumstances.

<u>UNIVERSITY FEE: 15,000/- (Rupees Fifteen Thousands only)</u>

16. ATTENDANCE AND LEAVE:

- **16.1** The post graduate students shall complete eighty five percent of attendance in all subjects separately before they appear for final examination.
- **16.2 Leave**: Leave rules shall be applied as per the regulations issued by NCISM from time to time.
- **16.3 Maternity leave**: Post Graduate students are eligible for maternity leave as per Government rules and the period of study shall be extended accordingly.

17. SANCTION OF LEAVE OF ABSENCE BEYOND 3 MONTHS AND TERMINATION OF STUDENTSHIP:

- a) Every candidate after his admission shall attend classes on all working days (Theory, Practicals, Clinicals). If a student absents continuously for a period of 91 days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
- b) If the break of study (91 days are more) in more than one spell, the candidate's representation in the prescribed profroma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.

- c) Candidates who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission in to the course and the studentship stands cancel without any further notice.
- d) The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the National Medical Commission from time to time.
- e) On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course

18. PRIVATE PRACTICE:

No PG student shall do any private practice or consultation practice and shall not accept any part-time employment during his/her Post Graduation. The Principal of the college shall not hand over the certificates to the students under any circumstances without obtaining prior permission from the University.

19. COLLEGE REGULATIONS:

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University and they shall not make any correspondence with higher authorities directly without prior permission of the Professor of the concerned unit and Principal.

20. STIPENDS:

- 20.1 Stipends may be paid by the Principal as per the orders of Government of Telangana to the PG students who are regular in attendance and show good progress every month in their academic pursuits. The total period during which the stipends may be paid to the students shall not exceed thirty six months for the course. No candidate will be eligible to draw the stipend for more than 36 months during the entire PG study period.
- 20.2 Service candidates shall not be paid stipend if they draw leave salary or salary.

21. COMMENCEMENT OF THE COURSE:

The course shall normally commence as per the date mentioned in the schedule at last page. The duration of the course shall be calculated from this date of commencement of the course and shall be uniform for all the candidates irrespective of their individual dates of admission.

22. CLOSURE OF ADMISSIONS:

Admissions shall be closed as per the date specified in the schedule notified by NCISM. Any vacancy as on the day of closure of admissions or that arises after closure of admissions shall not be filled up.

23. <u>DURATION OF COURSE AND MAXIMUM PERIOD FOR COMPLETION OF THE</u> COURSE:

The period of training of Doctor of Medicine in Unani shall be of 3 years duration in the department concerned. Candidate should complete the course within the duration equivalent to double the period of course of study. i.e.,: 6 years

24. MEDIUM OF INSTRUCTION:

English shall be the medium of instruction and examination.

25. POWERS OF THE PRINCIPAL:

Notwithstanding anything contained in these regulations, the Principal, Govt. Nizamia Tibbi College, Hyderabad may at any time before completion of the PG course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit written explanation and or a personal hearing, order the cancellation of admission to the PG course if in his opinion such candidates had furnished false or incorrect information in the application form or in the documents attached, certificates enclosed there to or in the statements made either before the authority incharge of admissions or the Principal or in any other fraudulent manner, obtained admission into such course. Against any such order of the Principal an appeal shall lie to the KNR University of Health Sciences, Telangana, Warangal.

26. POWER TO AMEND REGULATIONS AND REVIEW SELECTION OR ADMISSION OF CANDIDATES:

26.1 The KNR University of Health Sciences shall have the power to add or to delete

or amend or alter these regulations from time to time.

26.2 The University may either suomoto or on an application made to them, call for

and examine records relating to any selection or admission or cancellation

thereof made by the authority in charge of selection or admission for the

purpose of satisfying themselves as to the legality or regularity of such selection

or admission orders in relation thereto, as they deem fit including cancellation

of the selections already published or admissions already made provided that

the University may before cancelling such selection or admission give an

opportunity to the authority in charge of selection or admission and to the

person effected to show cause against such cancellation.

27. FINALITY OF SELECTION:

All selections under these Regulations shall be subject to any general

regulations or order that may be made by University from time to time.

29. MIGRATION /TRANSFER: No Transfers during the course period are

permitted from one college to another college under any

circumstances.
