NOTIFICATION FOR ON-LINE APPLICATIONS FOR ADMISSION INTO MD AYURVEDA COURSES UNDER COMPETENT AUTHORITY QUOTA FOR THE ACADEMIC YEAR 2025-26

Applications on-line are invited from candidates who have qualified in AIAPGET-2025 (Ayurveda), who fulfilled the eligibility for admission into MD Ayurveda Course by securing cut-off percentage of score and above for the academic year 2025-26 in Dr. BRKR Government Ayurveda Medical College, Hyderabad affiliated to KNR UHS.

Candidates can apply on-line through web-site http://tsmdayush.tsche.in from 6.00 A.M. on 16.10.2025 up to 6.00 PM on 21.10.2025.

On-line application can be filled through any computer with internet connection.

SUBMISSION OF FILLED IN ON-LINE APPLICATION FORM:

The print-out of application along with 1 set of self attested copies should be submitted at the time of certificate verification and counseling as per schedule notified by KNR UHS.

1. ELIGIBILITY AS LOCAL CANDIDATE:

(as per G.O. Ms. No. 149, HM&FW(C1) Dept., dated 28-10-2024)

- i. A Candidate to be eligible for Admission into PG AYUSH Courses under these Rules should be an Indian National/Person of Indian Origin/Overseas Citizen of India card holder and be a local candidate:
- ii. Local candidate means a candidate who has studied in the Educational Institutions in the state of Telangana as for a period of not less than four consecutive years ending with the academic year in which he appeared or as the case may be, first appeared in the relevant qualifying examination subject to

Explanation (a): A candidate who is regarded as a local candidate for the purpose of Admission into Undergraduate (UG AYUSH) in the state of Telangana, but has studied in a State wide Institutions outside the state of Telangana, shall also be regarded as a Local candidate.

Explanation (b): A candidate, who has secured Admission to the relevant Undergraduate course (UG AYUSH) under Non-Local Quota in the State of Telangana, shall not be regarded as Local candidate.

- 2. As per the guidelines issued by Ministry of AYUSH and National Commission for Indian System of Medicine the following are the eligibility criteria for admission into Post Graduate Courses.
- a) Candidates who have appeared for AIAPGET 2025 and Candidate should have secured the following minimum eligibility percentile or above.
 - i) 50% for General Category (Open)/EWS candidates.
 - ii) 45% for General Category (Persons with Disabilities (OC PWD) candidates.
 - iii) 40% for SC,ST and other Backward class including Persons with Disabilities.
- b) Those who have passed the BAMS Degree Examination after undergoing a course of study in Ayurveda of not less than 5 ½ years duration including the period of compulsory internship;

or

Those who passed equivalent Degree Examination included in the 2nd schedule of IMCC Act 1970.

- 3. The candidates should have completed internship by 31-07-2025. Internship certificate to be issued by Principal of the college
- 4. Candidates who are already admitted and studying M.D. (Ayurveda) course shall not be permitted for counseling, until they discontinue the course before submitting the application form and such candidate shall submit the discontinuation certificate issued by the Head of the Institution along with the application.
- 5. Candidates who are already holding a Post Graduate Degree in Ayurveda in a subject shall not be eligible for admission into another P.G.Ayurveda Course.
- 6. For in-service candidates three years of regular service shall be calculated as on <u>30-09-2025</u>. Service quota allotments are subject to orders of Government of Telangana.
- 7. Merit Position of the candidates who have applied on-line shall be determined based on AIAPGET-2025 (Ayurveda) rank and percentile as per their eligibility.
- **8. Registration and Processing fee**: Rs. 4,000=00 for OC/BC Candidates.

Rs. 3,000=00 for SC/ST Candidates.

Candidates are advised to download the Prospectus displayed on KNRUHS web-site: http://knruhs.telangana.gov.in and read carefully for eligibility criteria and availability of seats before filling the application form.

Instructions to Candidates :

Procedure of filling online application and Procedure for online payment:

Read the Notification, Prospectus / Regulations carefully for eligibility criteria and available seats.

- 1. Keep all the following required documents ready.
 - (a) AIAPGET-2025 (Ayurveda) Hall Ticket.
 - (b) AIAPGET-2025 (Ayurveda) Rank Card.
 - (c) Date of Birth Certificate.
 - (d) Study Certificate B.A.M.S. (1st year to final year)
 - (e) Study certificates from 6th class to Intermediate
 - (f) Internship completion certificate. .
 - (g) All marks memos from 1st B.A.M.S. to final B.A.M.S.
- (h) Category Certificate if applicable.
- (i) Latest Service Certificate issued by Commissioner/Director AYUSH (by 30.09.2025)
- (i) Council Registration Certificate.
- (k) Aadhar Card.
- (1) EWS Certificate valid for 2025-26 year if applicable
- 2. The fee can be paid through Debit card / Credit card or Net Banking
- 3. The fee paid by the applicants is not refundable under any circumstances.

NOTE:

- 1) Applications on-line are to determine the provisional state merit position. Final merit position will be determined after verification of original certificates
- 2) Print-out of application form should be submitted at the time of verification of Original Certificates and counseling along with 1-set of self attested copies. Incomplete applications and applications without enclosures will not be considered.

3) Orders issued by the Government of Telangana and National Commission for Indian System of

Medicine will be applicable for admissions.

4) Candidates admission is strictly provisional. The mere fact that the Merit position issued to the

candidate does not imply that his/her candidature is accepted by the University and it does not mean

that the entries made by him/her in the on-line application are accepted as true and correct.

Candidates are informed that the University will take up the verification of original certificate with

regard to eligibility conditions. i.e. educational qualification, validity of registration with State

Council concerned internship, local/non local area status after duly verifying all the relevant

certificates in original at the time of verification of original certificates / counseling. If the

information furnished by the candidate in the application is incorrect, his / her candidature is liable

to be cancelled and further action that deems fit will be taken.

5. Admissions will be only for candidates who have qualified in AIAPGET-2025 for admission into

MD Ayurveda course and whose names figure in the final merit list of KNRUHS.
