1. The following are the regulations for admission into M.D. (AYURVEDA) at Dr. B.R.K.R. Govt. Ayurvedic Medical College, Hyderabad affiliated to KNR University of Health Sciences, Telangana, Warangal for the academic year 2025-26.

NOTE:

- (1) One seat in Kayachikitsa Course at Dr. B.R.K.R. Government Ayurvedic College, Hyderabad is reserved for foreign Nationals as per Government of India Lr. No. R.12013/1/2003 e & c (ii) Dt: 23-3-2004.
- (2) One seat in each specialty is allocated to All India Quota. All India Quota seats are filled by the counseling committee of AYUSH Department, Government of India as per the rules and regulations of Government of India (AACCC).
- (3) The remaining seats will be filled by the State Competent Authority i.e., KNR University of Health Sciences as per the rules and regulations of the Government of Telangana and Ministry of AYUSH, Government of India.

3. ELIGIBILITY FOR ADMISSION:

- 3.1** Candidates who have qualified AIAPGET- 2025 are only eligible to apply, subject to fulfillment of regulations, Candidate should secure the following minimum eligibility percentile or above.

- a) 50% for General Category (Open)/ EWS candidates.
- b) 45% for General Category (Persons with Disabilities (OC-PWD)) candidates.
- c) 40% for SC, ST and other Backward class including Persons with Disabilities.

3.2 Those who have passed the Degree examination after undergoing a course of study in AYURVEDA of not less than 5½ years duration including the period of compulsory internship from any Ayurvedic Medical College in the State of Telangana.

3.3 The candidate should have completed internship by 31.07.2025.

3.4 Candidates who are already admitted and studying MD (AYURVEDA) Course shall not be permitted for counseling unless they discontinue the course by remitting the bond amount and the stipend taken upto that date before submitting application form and such candidates shall submit the discontinuance certificate issued by the Head of the Institution along with the application.

3.5 Candidates who are already holding a Post Graduate Degree in AYURVEDA in a subject shall not be eligible for admission into another PG AYURVEDA Course.

3.6 For in-service candidates three years of regular service shall be calculated as on **30-09-2025**. The allotment of seats for service candidates subject to the rules and Regulations of Government of Telangana. The admissions into in-service seats will be considered subject to availability of seats for service candidates and deputation orders issued by Government of Telangana.

3.7 Regarding seats of Central Government Nomination (CGN), Revised Guidelines shall be applicable communicated by Govt. of India vide Letter F.No.Y-11030/14/2021-EP-III, dt. 02-05-2025.

4. RESERVATION:

4.1 15% seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Castes. As per G.O. Ms. No. 10, SCD(POA.A2) Dept., Dated: 14.04.2025 and as per Government orders dated. 16.05.2025, out of 15% of seats reserved for SC, 1% of seats shall be reserved for SC Group I, 9% of seats shall be reserved for SC Group II, 5% of seats shall be reserved for SC Group III. The Rationalization of reservations shall be followed as per the said G.O. and Government orders from the AY 2025-26.

10% and 29% of the seats available in each course shall be reserved for ST and BC respectively of Competent Authority Quota.

4.2 A candidate claiming reservation under clause 4.1 shall produce a certificate of his / her social status in the prescribed standard format.

4.3 The seats reserved for the SCs shall be made available to the STs and vice-versa, if qualified candidates are not available in these categories. The seats reserved for both SCs and STs shall be made available to the candidates in general pool, if qualified candidates belonging to the SCs and STs are not available.

4.4 15% of seats in PG courses are reserved for in service candidates in each category. Candidates selected on merit in the respective categories shall be counted against in service quota. Candidates working on contract basis, consolidated pay basis, daily honorarium and adhoc basis are not considered as regular service candidates.

Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to castes which are notified in the list as per the Telangana Government orders will be considered against the respective reserved seats.

Explanation: An in-service candidate is one who has put in a minimum of three years of regular Service as certified by Director of AYUSH Telangana.

4.5 RESERVATION FOR PERSONS WITH DISABILITIES:

5% of seats in each specialty course wise are reserved for Persons with Disabilities category candidates. (PWD Quota reservation will be followed if sufficient number of seats are available for each course under each category).

4.6 RESERVATION FOR EWS:

Will be implemented as per the seats sanctioned by Government of India/NCISM for implementation of EWS reservation.

5. ELIGIBILITY AS LOCAL CANDIDATES:

(as per G.O. Ms. No. 149, HM&FW(C1) Dept., dated 28-10-2024)

- i. A Candidate to be eligible for Admission into PG AYUSH Courses under these Rules should be an Indian National/Person of Indian Origin/Overseas Citizen of India card holder and be a local candidate:
- ii. Local candidate means a candidate who has studied in the Educational Institutions in the state of Telangana as for a period of not less than four consecutive years ending with the academic year in which he appeared or as the case may be, first appeared in the relevant qualifying examination subject to

Explanation (a): A candidate who is regarded as a local candidate for the purpose of Admission into Undergraduate (UG AYUSH) in the state of Telangana,

but has studied in a State wide Institutions outside the state of Telangana, shall also be regarded as a Local candidate.

Explanation (b): A candidate, who has secured Admission to the relevant Undergraduate course (UG AYUSH) under Non-Local Quota in the State of Telangana, shall not be regarded as Local candidate.

6. APPLICATIONS:

6.2 The candidate should fill the online application form available in the Website with the data required-for, through internet. The online application form can be filled through any computer with internet connection (home/internet café/net center). 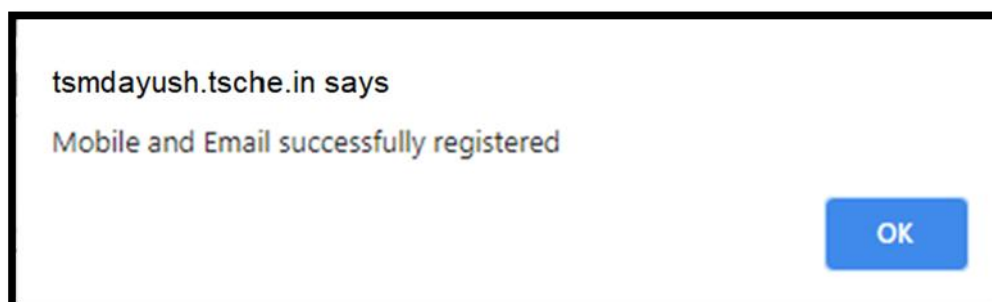

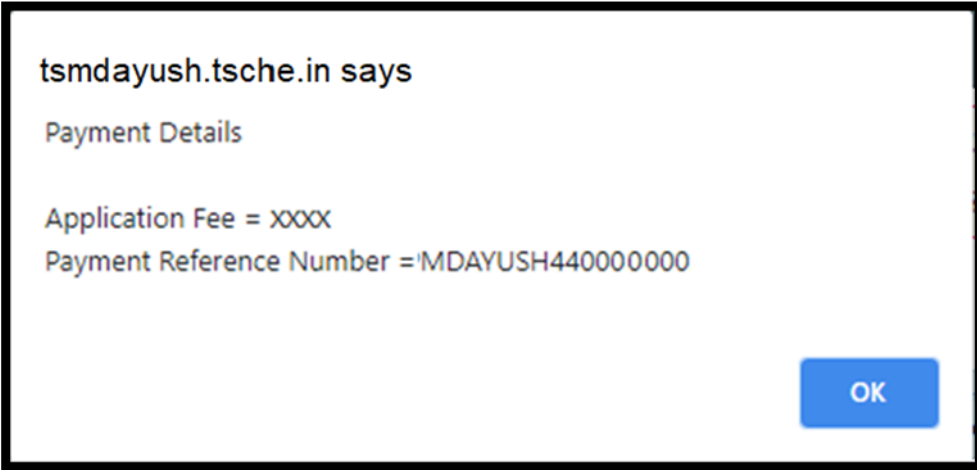

11. VERIFICATION OF ORIGINAL CERTIFICATES:

University will notify the schedule for counseling after verification of uploaded original Certificates of the candidates and preparation of final merit list for exercising options by the candidates.

12. MERIT LIST :

Merit position of candidates shall be determined based on percentile and rank obtained in AIAPGET-2025.

13. SELECTIONS:

- 13.1 Provisional Selection shall be made by the Selection Committee constituted by the University.
- 13.2 The Selection Committee shall provisionally select the candidates as per these regulations from among the candidates who qualified **AIAPGET 2025** as per merit list.
- 13.3 The candidates shall upload their original certificates for verification and after verification merit list shall be notified. Eligible candidates notified in the merit list

shall exercise web options for the courses they are interested to join in order of priority as per the schedule notified by University.

- 13.4 The candidates shall exercise their web options for subjects in order of their priority. The Selection Committee will select the candidates as per the Admissions Regulations and Government Rules from among the candidates who have completed the verification of original certificates, who are eligible, and who have been notified in the final merit list and exercised their web options. The list of provisionally selected candidates will be displayed on the KNRUHS website and the provisional selection intimations will be issued to the selected candidates.
- 13.5 The Selection Committee shall have power to review the provisional selection in case of any errors, misrepresentation, fraud or glaring injustice. In all matters relating to selections and admissions, the decision of the selection committee shall be final and binding on the candidates and selections cannot be questioned after admissions are closed.
- 13.6 If a candidate after choosing the subject fails to pay fees or fails to submit the bond, his/her selection stands cancelled automatically. If a candidate does not exercise web options in the first phase, he/she will not be considered for selection at the subsequent selection in the then available courses
- 13.7 If a candidate after allotment to the PG AYUSH specialty course fails to pay the fees or after paying the fees fails to submit the bond, original certificates, the selection of such candidate shall stand cancelled automatically and the candidate will not be eligible for selection for the next phases of counseling.

Vacancies after the 1st/2nd phase of counseling shall be filled by another phase of web-based counseling as per the schedule notified by the University on the website of the University.

14. CONDITIONS OF ADMISSION:

- 14.1 The Principal of the allotted Ayurvedic College shall verify the correctness of documents. On his/her satisfaction he/she shall direct the candidates to credit the college fee etc., immediately. In case of any discrepancy, the allotment shall be cancelled and necessary action shall be initiated by the University.
- 14.2 Candidates joining courses shall execute a bond on non judicial stamp paper of value of Rs.100/- in the form specified in Annexure-I to ensure completion of the prescribed period of training or in default or for any other reason has to pay

Rs.1,00,000/- to the Registrar, KNR University of Health Sciences and shall refund the stipend received upto that date to Government.

14.3 The Original certificates submitted shall not be returned to the candidates till they complete their course.

14.4 Candidates selected to various courses shall be whole time students.

Service candidates will have to apply for study leave and are required to produce the orders wherein such leave has been sanctioned to them from the Competent Authority within 3 months after joining the course

15. FEES:

15.1 All the selected candidates are required to pay the admission fee, tuition fees etc., as per rules in force.

15.2 **TUITION FEE:** All the candidates selected are required to pay the tuition fee as notified by the Government. If any of the candidates who have joined in a course is allotted to another course in the subsequent phase of counseling, the tuition fee paid by the candidate will be adjusted to the newly selected course and the tuition fee paid already shall not be refunded under any circumstances.

15.3. **UNIVERSITY FEE:** Allotted candidates have to pay the following University fee through payment gate way for downloading the allotment order. The fee once paid shall not be refunded under any circumstances.

UNIVERSITY FEE : 15,000/- (Rupees Fifteen Thousands only)

16. ATTENDANCE AND LEAVE:

16.1 The post graduate students shall mandatorily complete eighty five percent of attendance in all subjects separately for eligibility to appear for the final examination.

16.2 **Leave:** Leave rules shall be applied as per the regulations issued by NCISM from time to time.

16.3 **Maternity leave:** Post Graduate students are eligible for maternity leave as per Government rules and the period of study shall be extended accordingly.

17. SANCTION OF LEAVE BEYOND 3 MONTHS AND TERMINATION OF STUDENTSHIP

- a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals, Clinicals). If a student absents continuously for a period of 91 days or more and seeks permission to attend the course before 2 years after

discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.

- b. If the break of study (91 days are more) in more than one spell, the candidate's representation in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.
- c. Candidates who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission in to the course and the studentship stands cancel without any further notice.
- d. The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the National Commission for Indian System of Medicine from time to time.
- e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course

18. PRIVATE PRACTICE:

PG students are not permitted to do any private practice or consultation practice and shall not accept any part-time employment during his/her Post Graduation. The Principal of the college shall not hand over the certificates to the students under any circumstances without obtaining prior permission from the University.

19. COLLEGE REGULATIONS:

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University and they shall not make any correspondence with higher authorities directly without prior permission of the Professor of the concerned unit and Principal.

20. STIPENDS:

- 20.1 Stipends may be paid by the Principal as per the orders of Government of Telangana to the PG students who are regular in attendance and show good progress every month in their academic pursuits. The total period during which the stipends may be paid to the students shall not exceed thirtysix months for the course. No candidate will be eligible to draw the stipend for more than 36 months during the entire PG study period.
- 20.2 Service candidates shall not be paid stipend if they draw leave salary or salary.

21. COMMENCEMENT OF THE COURSE:

The course shall normally commence as per the date mentioned in the schedule at last page. The duration of the course shall be calculated from this date of commencement of the course and shall be uniform for all the candidates irrespective of their individual dates of admission.

22. CLOSURE OF ADMISSIONS:

- 22.1 Admissions shall be closed as per the schedule notified by NCISM.
- 22.2 Any vacancy as on the day of closure of admissions or that arises after closure of admissions shall not be filled up.

23. DURATION OF COURSE AND MAXIMUM PERIOD FOR COMPLETION OF THE COURSE :

The period of training of Doctor of Medicine in Ayurveda shall be of 3 years duration in the department concerned. Candidate should complete the course within the duration equivalent to double the period of course of study .i.e., 6 years

24. MEDIUM OF INSTRUCTION:

English shall be the medium of instruction and examination

25. POWERS OF THE PRINCIPAL:

Notwithstanding anything contained in these regulations, the Principal of the College may at any time before completion of the PG course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit written explanation and or a personal hearing, order the

cancellation of admission to the PG course if in his opinion such candidates had furnished false or incorrect information in the application form or in the documents attached, certificates enclosed there to or in the statements made either before the authority in charge of admissions or the Principal or in any other fraudulent manner, obtained admission into such course. Against any such order of the Principal an appeal shall lie to the KNR University of Health Sciences, Telangana, Warangal.

26. POWER TO AMEND REGULATIONS AND REVIEW SELECTION OR ADMISSION OF CANDIDATES:

- 26.1 The KNR University of Health Sciences shall have the power to add or to delete or amend or alter these regulations from time to time.
- 26.2 The University may either suo moto or on an application made to them, call for and examine records relating to any selection or admission or cancellation thereof made by the authority in charge of selection or admission for the purpose of satisfying themselves as to the legality or regularity of such selection or admission orders in relation thereto, as they deem fit including cancellation of the selections already published or admissions already made provided that the University may before cancelling such selection or admission give an opportunity to the authority in charge of selection or admission and to the person effected to show cause against such cancellation.

27. FINALITY OF SELECTION:

All selections under these Regulations shall be subject to any general regulations or order that may be made by University from time to time.

- 28. MIGRATION /TRANSFER:** No Transfers during the course period are permitted from one college to another college and from one course to other after closure of admissions under any circumstances.
