NOTIFICATION FOR ADMISSION INTO MD (HOMOEO) COURSES UNDER ALL INDIA QUOTA SEATS (AIQ) IN PRIVATE HOMOEOPATHIC MEDICAL COLLEGES AFFILIATED TO KNRUHS FOR THE ACADEMIC YEAR 2025-26

Applications through online are invited for **All India Quota admissions** from AIAPGET- 2025 qualified candidates for admission into MD Homoeo courses for the academic year 2025-26 in Private Homoeopathic Medical Colleges affiliated to KNRUHS, Warangal in the State of Telangana.

Notification is issued for online registration, uploading of scanned original certificates and exercising one-time options for allotment and admission into All India Quota MD Homoeo seats (i.e., 15% of intake of seats) from Private Homoeopathic Medical Colleges affiliated to KNRUHS.

Schedule for Registration of online application, uploading of original certificates and exercising options through Website https://tsmdayushaiq.tsche.in/ from

06.00 AM on 23-10-2025 to 6.00 PM on 28-10-2025

Provisional final Merit position of the applied candidates will be prepared based on the AIAPGET - 2025 Rank and other eligibility criteria notified hereunder after verification of scanned original certificates and allotments will be done based on options exercised from eligible candidates. Final Verification of original certificates will also be conducted at the time of admission at allotted college by Admission Committee.

1. **ELIGIBILITY**:

A. Candidates, who have qualified in AIAPGET - 2025 by securing the following marks of cutoff score or above have to apply for online registration and exercising one time options for **All India Quota** seats.

Minimum Qualifying Scores in AIAPGET - 2025 for PG AYUSH courses:

Candidates should have secured the following cutoff score or above in AIAPGET - 2025.

Category	Qualifying Criteria
General category including EWS	50 th Percentile
SC/ST/BC & PWD Candidates	40 th Percentile
Persons with Disability, PWD (OC)	45 th Percentile

Note: Cutoff score of OC PH / BC / SC / ST is only for purpose of eligibility for admission. There is no reservation for All India Quota (AIQ).

Those who have passed the BHMS Degree Examination after undergoing a course of study in Homoeopathy of not less than 5 ½ years duration including the period of compulsory internship;

Those who passed equivalent Degree Examination included in the 2nd schedule of Homoeopathy Central Council Act 1973.

The candidates should have completed internship by 31-08-2025. Internship completion certificate to be issued by Principal of the college

3. The AIAPGET- 2025 qualified and eligible candidates as per the concerned regulations who desire to take admission into in All India Quota MD Homoeo Course shall apply online and upload all original certificates for determining the Merit position for **ALL INDIA QUOTA** SEATS and exercise options. The online application can be filled through any computer with internet connection or Mobile with Data connection. (**NOTE: PREFERBLY DESKTOP OR LAPTOP**).

4. **Registration and Verification Fee for MD Homoeo Course**: The Registration and verification fee is **Rs.2,000/-**(Bank transaction charges extra) for OC, BC, SC & ST category candidates (Bank transaction charges extra). Fee shall be paid online through Debit card / Credit card or Net Banking.**

** Registration and verification fee once paid is not refundable

5. Verification Fee for Equivalency:

The candidates who acquired their Under Graduate Degree outside the State of Telangana or Country/Abroad and got their certificates registered with Council and applying for admission under this University, shall pay a verification fee of Rs.5,000/- for degree certificates acquired Abroad and Rs.3,000/- for the degrees acquired outside the State.

- **6. University Fee :** Allotted Candidates have to pay University fee of Rs. 15000/-
- 7. Candidates selected under All India Quota in the counseling conducted by KNRUHS for PG Homoeo courses are permitted to leave /Surrender the seat till the last date of free exit notified by KNRUHS on website with forfeiture of the University and College fee. If the candidate cancels the admission/ discontinues the course after the last date for free exit, candidate have to pay a penalty of Rs. 1,00,000/- in addition as per State Government order and they will not be eligible for MD Homoeo admission under KNRUHS for 3 years.
- 8. Ministry of AYUSH Directive for Counseling & Admission in in Post Graduate (MD/MS)Courses for the Academic Year 2025-26, dated: 10.09.2025 for allotment of AIQ PG seats in Private ASU & H Institutes shall be followed for AIQ admissions.

9. Procedure of filling online application and online payment for MD Homoeo Course

- i. The registration fee can be paid through Debit card/Credit card or Net Banking.
- ii. The registration fee paid by the applicants is not refundable under any circumstances.
- iii. Visit website through Computer with Internet connection or Mobile with Data Connection to fill the application form.
- iv. Registration number sent to the registered mobile after entering the basic data should be noted for further use. The Registration number should be kept confidential and not to be disclosed to others.

10. The following Documents are required (PDF format):

a. AIAPGET-2025(Homoeo) Admit Card.

- b. AIAPGET-2025(Homoeo) Rank Card.
- c. Date of Birth Certificate.
- d. Study Certificate B.H.M.S. (1st year to final year)
- e. Internship completion certificate.
- f. All marks memos from 1st B.H.M.S. to final B.H.M.S.
- g. Council Registration Certificate.
- h. Credit card / Debit card.
- i. Aadhar Card.
- j. Latest Permanent Caste Certificate (Integrated Community Certificate) for BC/SC/ST Categories issued by competentauthority of their respective State. (For cutoff score relaxation in eligibility criteria)
- 11. Undertaking in the form of Affidavit shall be submitted at the time of admission by the candidates stating that the submitted certificates are genuine and they will be held responsible for any further consequences as per law if any discrepancy noticed.

Important information for candidates:

- Visit website through Computer with Internet connection or Mobile with Data Connection to fill the application form.
- 2. Fill in all the details in the online application form and upload all the documents which are mandatory and exercise one time options for MD Homoeo courses in which you are interested as per your priority.
- 3. Online application form without uploading mandatory Certificates, Passport size photo, without signature at declaration area, incomplete applications and applications without options for colleges will be automatically rejected and will not be considered for determining the Merit position in respective categories using AIAPGET-2025 rank and allotment.
- 4. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by candidate in the online application are accepted as true and correct.
- 5. Candidates may please note that the University will take up the verification of original certificates with regard to eligibility conditions i.e., AIAPGET -2025 Rank and other details as peruploaded relevant certificates by the concerned department officials. If the information furnished by the candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deemed fit will be taken.

- 6. University shall make allotments as per one time options exercised by the candidates. Candidates are advised to refer to KNRUHS website for allotment details. No individual communication will be sent. In case of any vacancies after first phase of counseling the same options shall be considered for second phase. Any vacancies after 2nd phase of counseling are reverted to Convenor Quota.
- 7. Candidates are informed that if an admitted candidate (of 1st phase) is allotted a seat in the 2nd phase of counseling as per his/her priority of options, the seat allotted in the 1st phase is automatically vacated and allotted to the next meritorious candidate.
- 8. Admissions will be in accordance with the Government Orders, NCH & University Regulations from time to time. Candidates are directed to read the Regulations and Prospectus for admission into PG AYUSH courses notified on KNRUHS website.
- 9. After allotment candidate will receive SMS of allotment. Allotment list will also be displayed on KNRUHS website. Candidates are informed to check KNRUHS website for allotment notification.
- 10. Allotted candidates should download the allotment order on payment of University Fee by payment gate way, check the details of allotment and report to the Principal of allotted college before the last date mentioned in the allotment letter. If the candidate fails to join the course at the allotted college after allotment in the 1st phase of counseling, the candidate will not be eligible for 2nd phase of counseling.
- 11. Candidates shall submit the printout of the filled-in online application form, allotment order, Bonds and original certificates along with (1) set of self attested copies to the Principal of allotted college.
- 12. Candidate has to pay the college fee and tuition fee at the time of joining. The admission committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.
- 13. Tuition Fee is Rs. 70,000/- per annum as notified in G.O.Ms.No.109, Health, Medical & Family Welfare (C1) Department Dated: 28-07-2023, issued by Government of Telangana.
