BDS ADMISSIONS UNDER COMPETENT AUTHORITY QUOTA FOR THE ACADEMIC YEAR 2025-26

NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR MOP UP PHASE OF COUNSELING

In continuation to this office notifications dated: 15.07.2025, 25.07.2025, 08.09.2025, 12.09.2025, 15.09.2025, 19.09.2025 & 01.10.2025, Kaloji Narayana Rao University of Health Sciences hereby notifies to conduct the Mop Up phase of web-based counseling for vacant seats under Competent Authority Quota (CQ) for admission into BDS course for the AY 2025-26 in Government, Private Dental Colleges & Army College of Dental Sciences, Secunderabad in the State of Telangana.

Candidates whose certificates were uploaded at the time of online registration and provisionally verified by staff of concerned departments and whose names are notified as eligible candidates in the final merit list of UG Admissions on the KNRUHS website on 15.09.2025 and addendums are eligible to exercise web - options through online from computer with internet connection.

All the eligible candidates whose names are displayed in the final merit list including PWD, PMC, CAP categories candidates on KNRUHS website can exercise web options for admission into BDS course from 11.30 AM on 30.10.2025 up to 11.30 AM on 31.10.2025 through website https://tsbdsadm.tsche.in/ subject to following conditions;

- 1. The Candidates who were allotted seats in the previous phases of counselling and have not reported/discontinued the course after joining at the respective college are not eligible for exercising options.
- 2. Candidates who have not exercised web options in the first phase of counselling are not eligible to exercise web options.
- 3. Candidates whose names are notified in the college wise allotment list of MBBS course under Competent Authority Quota after Mop Up Phase of counselling on KNRUHS website are not eligible to exercise web-options.
- 4. The candidates who were allotted BDS seats in the previous phases of counselling and joined into the course and continuing the course are eligible to exercise web options.

5. Candidates who are admitted under MCC counselling up to third phase of counselling as notified on MCC website are not eligible to exercise web-options.

For eligibility criteria and regulations refer to notifications dated: 15.07.2025.

UNIVERSITY FEE: Allotted Candidates have to pay University fee of Rs. 12,000/- for BDS

Course through payment Gateway by using Online payment method.

(Debit Card/Credit Card/Internet Banking) and download the allotment order. Candidates who have paid University fee in the previous phases of counselling and if slides in Mop Up phase of counselling, need not to pay the University fee again.

TUITION FEE: Tuition fee is to be paid at respective Dental Colleges.

The tuition fee payable as notified by the Government of Telangana.

NOTE:

- 1. The details of vacant seats are placed in the University website http://knruhs.telangana.gov.in. Candidates can exercise web options for BDS seats in all Dental Colleges affiliated to KNRUHS through https://tsbdsadm.tsche.in/;
- 2. The allotment of seats will be made in accordance with the selection procedure notified in Government orders G.O.Ms.No. 114, HM&FW(C1) Dept., Dated: 05.07.2017, subsequent amendments, G.O. Ms. No. 125, Health, Medical and Family Welfare (C1) Department Dated: 22.09.2022, G.O. Ms. No. 75, Health, Medical and Family Welfare (C1) Department Dated: 04-07-2023, G.O. Ms. No. 33, Health, Medical and Family Welfare (C1) Department Dated: 19-07-2024, G.O.Ms.No. 10, Scheduled Castes Development (POA.A2) Department, Dated: 14.04.2025, G.O.Ms.No. 150, Health, Medical and Family Welfare (C1) Department Dated: 08.09.2025 and relevant Hon'ble High Court/Supreme court orders and University regulations.
- 3. Admitted candidates are not permitted to withdraw/discontinue from the course after Mop Up phase of counselling.

IMPORTANT INSTRUCTIONS TO THE CANDIDATES:

- Eligible NEET-UG-2025 qualified candidates as per final merit list for Competent
 Authority Quota and reported candidates in the previous phases of counselling can
 exercise web options for BDS course into the affiliated Dental colleges of KNRUHS as
 per their interest and priority through https://tsbdsadm.tsche.in/ from computer with
 internet connection.
- Candidates are advised to go through the Prospectus for the Regulations for admission into BDS course and Government Orders on Rules of Admission on KNRUHS website before exercising web-options.
- 3. Admitted candidates will have to pay discontinuation penalty amount of Rs. 20 lakhs as per Government Orders, if they discontinue the course after the Mop Up phase of counselling to get their original certificates back. Candidates also will be debarred for 3 years for MBBS admission under KNRUHS to prevent seat blocking.
- 4. If a candidate is allotted a seat in BDS course as per his/her web-options in this phase and does not join the course, penalty clause shall be applicable including penalty amount of Rs. 20 lakhs and debarment for 3 years to prevent seat blocking.
- 5. Candidates exercising web-options for MBBS course are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of colleges the candidate is interested to join as per candidate's eligibility.
- 6. Candidates are advised to exercise web options for BDS seats in all colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in previous phases of counseling to other seats as per their web options in this phase of counselling. If candidates are not interested to join in any college, they should not exercise web options for the same.
- 7. If a seat is allotted in this phase of counseling as per web options exercised by the candidate, the seat allotted in previous phases of counseling will be automatically cancelled and allotted to the other candidate by order of merit and as per their options. Therefore, candidates are informed to exercise web options carefully for sliding with awareness of this fact.
- 8. One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read instructions to the candidates before giving options).
- 9. Candidates are instructed to take a print out of saved options.

- 10. Candidates will receive SMS message on their registered mobile after allotment of seat and sliding of the college, if allotted. Candidates are also informed to login to check their allotment status on https://tsmedadm.tsche.in/ website after each phase of counseling.
- 11. The selected candidates shall download the allotment order from the website after payment of the University fee by gateway method by using online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment and report to the Principal of respective Dental College on or before the date specified on the allotment order.
- 12. Selected candidates have to report to the Principal of the respective Dental College before the last date for joining as specified in the allotment order, to submit all original certificates, relevant bonds and to pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and penalty clause shall be applicable including penalty amount of Rs. 20 lakhs and debarment for 3 years to prevent seat blocking.
- 13. If the candidate slides to other college during Mop Up phase of counseling in colleges affiliated to KNRUHS, the original certificates will be sent to the college concerned after the closure of admissions. Candidates have to get relieved from previous phase joined college, obtain custodian certificate, collect fees and to report at the allotted college before the last date of joining. Admitted candidates shall not be permitted to discontinue from the course after allotment in Mop Up phase of counselling.
- 14. Candidates are hereby informed that final verification of original certificates will be conducted at the allotted/slided College and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated against the candidate & parent as per University regulations.
- 15. Original certificates submitted at the time of admissions shall not be returned to the candidate, unless the candidate discontinues the course before the last date for free exit notified by the University.
- 16. The University fee once paid shall not be refunded under any circumstances.
