NOTIFICATION FOR EXERCISING ONE TIME WEB OPTIONS FOR ADMISSION INTO MD (HOMEO) COURSES UNDER ALL INDIA QUOTA SEATS (AIQ) IN AFFILIATED PRIVATE HOMEOPATHIC MEDICAL COLLEGES FOR THE ACADEMIC YEAR 2025-26.

In continuation to this office notifications 22-10-2025 and 30-10-2025, Kaloji Narayana Rao University of Health Sciences hereby notifies to conduct counseling for allotment of seats of MD Homoeo courses under All India Quota in affiliated Private Homoeo Colleges.

Candidates who have registered online and whose names are notified in the final merit list for All India Quota on the website of KNRUHS are eligible to exercise one-time web-options online from computer with internet connection.

All the eligible candidates can exercise web options as per eligibility and priority for college /course from **8.00 A.M. on 31-10-2025 to 11.00 A.M. on 01-11-2025** through web-site https://tsmdayushaiq.tsche.in/

IMPORTANT NOTE:

- 1. Candidates are hereby informed that one time web options only shall be exercised for MD Homoeo courses. The web options exercised by candidates with regard to order of preference for courses/ colleges is final and the same options will be considered for two phases of allotments.
- 2. Candidates selected under All India Quota in the counseling conducted by KNRUHS for PG Homoeo courses at Private Homoeopathic Colleges are permitted to leave /surrender the seat till the last date of free exit to be notified by KNRUHS on website with forfeiture of the University and College fee. If the candidate cancels the admission/ discontinues the course after the last date for free exit, candidate have to pay a penalty of Rs. 1,00,000/- in addition as per State Government order and they will not be eligible for MD Homoeo admissions under KNRUHS for 3 years.

3. Ministry of AYUSH Guidelines dated.10.09.2025 for allotment of AIQ PG seats in Private ASU & H Institutes shall be followed for admission.

- a) All AIQ PG seats of Private Homoeo colleges are open in nature. However, relaxation in qualifying criterion may be considered category wise as mentioned above. Candidates domicile certificate is not required for allotment of All India Quota seats in Private AYUSH colleges.
- b) Passing marks for eligibility in admission to ASU & H PG courses should be as perthe ASU & H PG regulations and should be followed strictly. The details qualifications for different categories are as follows:
- c) The candidate must have passed final year UG examination from a recognized University or Board or medical institution specified in the Schedules to the Act and enrolled in Central or State register of Indian System of Medicine and must have completed satisfactorily one year compulsory rotating internship as on or before 31.08.2025.
- 4. Undertaking in the form of affidavit shall be submitted at the time of admission by the candidates stating that the submitted certificates are genuine and they will be held responsible for any further consequences as per law if any discrepancy noticed.
- 5. **UNIVERSITY FEE:** Allotted Candidates have to pay University fee of Rs. 15000/(Rupees Fifteen Thousands only) for through payment Gateway by using Online

payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter.

The University fee once paid shall not be refunded under any circumstances.

Tuition Fee is Rs. 70,000/- per annum as notified in G.O.Ms.No.109, Health,

Medical & Family Welfare (C1) Department Dated: 28-07-2023, issued by the

Government of Telangana.

IMPORTANT INSTRUCTIONS TO CANDIDATES:

- a) Admissions will be in accordance with the Government Orders and University Regulations.
- b) Candidate can exercise one time web options for MD Homoeo Courses in the Colleges as per their priority for the course and college. There is no limit to the number of options.
- c) Candidates are informed that they have to exercise one time web options to the course and colleges in which they are interested to join. If they are not interested to join in course/college, they should not exercise options for the same.
- d) If a candidate is allotted a seat in MD Homoeo course as per their one time web options and does not join the course, their one time web options will not be considered for second phase of allotment.
- e) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read instructions to the candidates before exercising web options).
- f) Candidates are instructed to take a print out of saved options.
- g) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on Website https://tsmdayushaiq.tsche.in/ without fail. Candidates are also informed to check the KNRUHS website from time to time for subsequent phase of allotments.
- h) Allotted candidates should download the allotment order on payment of University Fee by payment gate way, check the details of allotment and report to the Principal of allotted college before the last date mentioned in the allotment letter. If the

candidate fails to get admitted after allotment in the 1st phase of counseling, the

candidate will not be eligible for 2nd phase of allotments.

i) Candidates shall submit the printout of the filled-in online application form,

allotment order, Bonds and original certificates along with (1) set of self attested

copies to the Principal of allotted college.

j) Candidate has to pay the college fee and tuition fee at the time of joining. The

admission committee is responsible for scrutiny of the original certificates

submitted b the candidate. In case of any discrepancy, the provisional allotment

order for admission will be cancelled.

k) Candidates are informed that if an admitted candidate (of 1st phase) is allotted a

seat in the 2nd phase of allotment as per his/her priority of options, the seat

allotted in the 1st phase is automatically cancelled and allotted to the next

meritorious candidate.

l) If the candidate does not fulfill the above criteria to complete the admission process

within specified date for joining, the admission will be cancelled automatically and the

candidates one time web options will not be considered for second phase of allotment.

m) Candidates are hereby informed that final verification of original certificates will be

conducted at the allotted college and in case of any discrepancy, the provisional

allotment will be cancelled and action may be initiated as per University regulations.

n) Original certificates will not be returned to candidate, unless the candidate

discontinues the course.
