**ADMISSION INTO UG AYUSH (BAMS, BHMS, BUMS and BNYS) COURSES UNDER  
COMPETENT AUTHORITY QUOTA FOR THE ACADEMIC YEAR 2025-26  
NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR SPECIAL STRAY VACANCY PHASE OF  
COUNSELING**

In continuation to this office notifications dated: 29/09/2025, 16/10/2025, 22/10/2025, 28/10/2025, 17/11/2025 and 26/11/2025, Kaloji Narayana Rao University of Health Sciences hereby notifies to conduct the Special Stray Vacancy phase of web based counseling for vacant seats under Competent Authority Quota (CQ) for admission into UG AYUSH(BAMS, BHMS, BUMS and BNYS) courses for the academic year 2025-26 in Government and Private AYUSH Colleges affiliated to KNRUHS, Warangal, in the State of Telangana.

All the eligible candidates whose names are notified in the final merit list on KNRUHS website can exercise web options for admission into UG AYUSH(BAMS, BHMS, BUMS and BNYS) courses from **05.00 PM on 07-12-2025 to 03.00 PM on 08-12-2025** through website <https://tsbahnu.tsche.in> subject to the following conditions:

- 1. Candidates who are admitted into MBBS & BDS courses under KNRUHS and in MCC counselings are not eligible to exercise web options.**
- 2. Candidates who are admitted into UG AYUSH courses under All India Quota and are notified as ineligible for state counseling by AACCC are also not eligible to exercise web options.**
- 3. Candidates who were allotted UG AYUSH (BAMS, BHMS, BUMS and BNYS) courses seats in the previous phases of counseling under Competent Authority Quota and continuing in the course are not eligible to exercise web-options.**
- 4. Candidates who are admitted into BHMS course under All India Quota & Management Quota in the previous phases of counseling and continuing in the course are not eligible to exercise web options.**
- 5. Candidates who were allotted UG AYUSH (BAMS, BHMS, BUMS and BNYS) courses seats in the previous phases of counseling under Competent Authority Quota and not reported in the allotted college are not eligible to exercise web-**

options.

- 6. Candidates who have discontinued the UG AYUSH (BAMS, BHMS, BUMS and BNYS) courses after joining in the previous phases of counselling under CQ, AIQ & MQ are not eligible to exercise web-options.**

For eligibility criteria and regulations refer to notification dated: 29/09/2025.

The details of vacant seats available (seat matrix) for admission into UG(BAMS, BHMS, BUMS and BNYS) courses are notified on website <http://knruhs.telangana.gov.in> (<https://tsbahnu.tsche.in>).

**UNIVERSITY FEE:** Allotted Candidates have to pay University fee of Rs. 8,000/- through payment gateway by using online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter.

**TUITION FEE:** Tuition fee is to be paid at respective colleges. The tuition fee payable as notified by the Government for Government & Private AYUSH colleges.

**IMPORTANT INSTRUCTIONS TO THE CANDIDATES:**

- 1) The details of vacant seats available (seat matrix) are notified in the website <http://knruhs.telangana.gov.in> . Eligible candidates as per final merit list can exercise web options for vacant seats in UG (BAMS, BHMS, BUMS and BNYS) courses in all AYUSH colleges as per their interest and priority through <https://tsbahnu.tsche.in> from computer with internet facility subject to aforementioned conditions. Do not use Tabs or Mobiles to exercise web-options.
- 2) Candidates are advised to go through the Prospectus and the Government Orders on rules available on KNRUHS website before exercising web-options.
- 3) Candidates are informed that they have to exercise options to the course and colleges in which they are interested to join.
- 4) **Important Note: Candidates are informed that if they exercise web- options for a seat and allotted a seat as per their choice of web- options in this phase of counseling and if they do not join the course at the allotted college then he/she has to pay penalty of Rs. 1,00,000/- (one lakh) and also will be debarred for 3 years for UG AYUSH admission under KNRUHS if any to prevent seat blocking.**
- 5) Admitted candidates will have to pay discontinuation penalty amount of Rs. 1,00,000/- (one lakh) as per Government Orders, if they discontinue the course

after the Additional Stray Vacancy phase of counselling to get their original certificates back. Candidates also will be debarred for 3 years for UG AYUSH admission under KNRUHS to prevent seat blocking.

- 6) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read instructions to the candidates before giving options)
- 7) Candidates are instructed to take a print out of saved options.
- 8) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to login to check their allotment status on <https://tsbahnu.tsche.in> website after each phase of counseling without fail.
- 9) Selected candidates have to report to the Principal of the respective AYUSH College before the last date for joining as specified on the allotment letter, submit all original certificates, relevant bonds and pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically and penalty clause will be applicable.
- 10) Candidates are hereby informed that final verification of original certificates will be conducted by the Admission Committee at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
- 11) Original certificates will not be returned to candidates unless the candidate discontinues from the course.
- 12) **The University fee once paid shall not be refunded under any circumstances.**
