Notification of counseling for spot Admissions into vacant seats in BHMS, BNYS and BUMS Courses under Competent Authority Quota

In continuation to this office notifications dated: 29/09/2025, 16/10/2025 22/10/2025, 28/10/2025, 17/11/2025, 26/11/2025 and 08/12/2025 for CQ, Kaloji Narayana Rao University of Health Sciences hereby notifies to conduct KNR University of Health Sciences, Warangal, Telangana State hereby notifies to conduct Spot Counseling for Admission into vacant seats after Special Stray Vacancy phase of counseling in to **BHMS, BNYS and BUMS** courses under Competent Authority Quota(CQ) in AYUSH affiliated colleges to KNR University of Health Sciences.

Candidates whose names are notified as eligible candidates in the final merit list for UG AYUSH courses for the academic year 2025-26 notified on the KNRUHS website in the Competent Authority Quota merit list are only eligible to attend for **Spot counselling under CQ seats only** along with Demand Draft(DD) and all relevant original Certificates subject to the following conditions:

- 1. Candidates who are admitted into MBBS & BDS courses under KNRUHS and in MCC counselings are not eligible to attend the spot admission.
- 2. Candidates who are admitted into UG AYUSH courses under All India Quota and are notified as ineligible for state counseling by AACCC are also not eligible to attend the spot admission.
- 3. Candidates who were allotted UG AYUSH (BAMS, BHMS, BUMS and BNYS) courses seats in the previous phases of counseling under Competent Authority Quota and Management Quota and continuing in the course are not eligible to attend the spot admission.
- 4. Candidates who are admitted into BHMS course under All India Quota & Management Quota in the previous phases of counseling and continuing in the course are not eligible to attend the spot admission.
- 5. Candidates who were allotted UG AYUSH (BAMS, BHMS, BUMS and BNYS) courses seats in the previous phases of counseling under

Competent Authority Quota and Management Quota not reported in the allotted college are not eligible to attend the spot admission.

- 6. Candidates who have discontinued the UG AYUSH (BAMS, BHMS, BUMS and BNYS) courses after joining in the previous phases of counselling under CQ, AIQ & MQ are not eligible to attend the spot admission.
- 7. Candidates have to attend with a Demand Draft for Rs. 8000/- towards University fee in favor of Registrar, KNRUHS, payable at Warangal and all original certificates compulsorily for counselling for CQ vacant seats.
- 8. Candidates without original certificates and Demand Draft for Rs. 8000/- as detailed above shall not be permitted for Spot Counselling.
- 9. Allotted candidates shall submit the DD and original certificates to complete the admission immediately.
- 10. Allotted candidates have to pay the Tuition fee and college fee at the counselling center to the Principal/staff of allotted college to complete admission process. Otherwise, provisional allotment will be cancelled.

- 1) The details of vacant seats available (seat matrix) are notified in the website http://knruhs.telangana.gov.in and to follow the same.
- 2) The seats shall be allotted as per rules basing on the merit list by merit following due procedure.
- 3) In case of non-availability of candidates of a particular reserved category, the vacant seats shall be converted and allotted as per Government Orders.
- 4) Candidates are hereby informed that final verification of original certificates

will be conducted by the Admission Committee at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University regulations.

- 5) Original certificates will not be returned to the candidates unless the candidate discontinues from the course.
- 6) The University fee once paid shall not be refunded under any circumstances.
