**MD (HOMOEOPATHY) COURSE ADMISSIONS UNDER MANAGEMENT QUOTA FOR THE  
ACADEMIC YEAR 2025-26  
NOTIFICATION FOR EXERCISING WEB OPTIONS FOR MOP UP PHASE**

In continuation to this office notifications 22-10-2025, 17-12-2025 and 21-12-2025 for Management Quota, Kaloji Narayana Rao University of Health Sciences hereby notifies to conduct Mop up phase of web based counseling for admission into MD Homoeopathy course under Management Quota in affiliated Private Homoeopathy Medical Colleges.

Eligible candidates whose names are notified in the final merit list for MD Homoeopathy course under Management Quota for the academic year 2025-26 on the KNRUHS website are eligible to exercise web-options online from computer with internet connection.

All the eligible candidates can exercise web options for MQ1 and MQ2 categories as per eligibility and priority for college /course from **04.00 P.M. on 20-01-2026 to 02.00 P.M. on 21-01-2026** through the web-site <https://tsmdayushmq.tsche.in>

**Candidates who did not join the course after allotment in the first, second phase of counselling shall not be permitted to exercise web options for Mop up phase of counseling.**

**The Management of the colleges shall send the nomination letter for admission into Management Quota sub category III quota (MQ3) seats from eligible AIAPGET-2025 qualified candidates from the Management Quota final merit list notified on website by the University.**

**IMPORTANT NOTE:**

1. Candidates shall submit an undertaking in the form of affidavit at the time of admission stating that the submitted certificates are genuine and they will be held responsible for any further consequences as per law if any discrepancy noticed.
2. **UNIVERSITY FEE:** Allotted Candidates have to pay the following University fee through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking) and download the allotment letter.

MQ 1 Management Quota sub category 1: Rs.25,000/-

MQ2 (NRI) & MQ3 (Institutional Quota) : Rs.40,000/-

The University fee once paid shall not be refunded under any circumstances. Candidates who have already paid the University fee in the previous phases of counseling need not to pay again. Tuition Fee to be paid as notified by Government of Telangana.

**Important Instructions to Candidates: -**

1. The details of vacant seats available for all the courses/colleges are notified on the web site: <http://knruhs.telangana.gov.in/> .
2. Candidates are advised to exercise web options for vacant seats in all MD HOMEIO courses/colleges in which they are interested to join irrespective of available vacant seats shown in seat matrix, as vacancies will arise during counseling process due to sliding of candidates from allotted seats in second phase of counseling to other seats as per their web options in the Mop up phase of counseling.
3. If a seat is allotted in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the seat allotted in second phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore, candidates are informed to exercise web options carefully for sliding with awareness of this fact.
4. Candidate can exercise web options for MD Homoeo Courses as per their priority for the course and the college. There is no limit to the number of web-options.
5. Candidates are informed that they have to exercise web options to the course and colleges in which they are interested to join. If they are not interested to join in course/college, they should not exercise options for the same.
6. Candidates have to exercise web-options for MQ1 category and for MQ2 (NRI) in order of priority for college and MQ1 or MQ2 category. Allotments will be made according to the order of preference in the web options exercised by the candidate
7. One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z. (For details read instructions to the candidates before exercising web options).
8. Candidates are instructed to take a print out of saved options.
9. Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are directed to login to check their allotment status on Website <https://tsmdayushmq.tsche.in> without fail. Candidates are also informed to check the KNRUHS website from time to time for subsequent phase notification.

10. Allotted candidates shall download the allotment letter by paying the University Fee through payment gateway, check the allotment details and report to the Principal of allotted college before the last date mentioned in the allotment letter.
11. The Candidates should take print out of allotment letter, check their allotment and report to the Principal of allotted college on or before the date specified on the allotment letter. Selected candidates have to report to the Principal of the respective college before the last date for joining as specified on the allotment letter, submit all original certificates, pay the tuition fee/college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically.
12. If the candidate slides to other college during Mop up phase of counseling in colleges affiliated to KNRUHS, the candidates have to get relieved from the college joined after second phase of counseling, collect custodian certificate and report to the Principal of allotted college before last date of joining.
13. Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college. The Admission Committee of the college is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University regulations.
14. Original certificates will not be returned to candidate, unless the candidate discontinues the course.
