NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR SECOND PHASE OF COUNSELLING

In continuation to this office notification dated: 04.10.2025, 07.01.2026, 15.01.2026, 16.01.2026 and 19.01.2026, KNRUHS hereby notifies to conduct the second phase of web-based counseling for allotment of the Post Graduate seats under Management Quota MQ1 and MQ2/NRI quota for admission into PG Medical Degree/Diploma courses for the academic year 2025-26 into Private Unaids Non-Minority and Minority Medical colleges in Telangana State affiliated to KNRUHS and Neelima Institute of Medical Sciences, Ghatkesar.

As per State Private Universities Act, 25% of MQ1 seats in Neelima Institute of Medical Sciences are reserved for candidates of the state of Telangana.

The candidates whose online uploaded certificates were provisionally verified and whose names are notified in the final merit list for PG Medical Admissions on the website of KNRUHS, Warangal are eligible to exercise web-options through online from computer with internet connection.

The Candidates who were allotted seats in the first phase of counselling and have not reported/discontinued the course at the respective college are not eligible for exercising web options.

Candidates who have not exercised web options in the first phase of counselling are also not eligible to exercise web options in accordance with the Government orders.

The candidates who were allotted PG seats in the first phase of counselling and joined the course are eligible to exercise web options and are informed to exercise web options.

All the eligible candidates whose names are displayed in the final merit list for PG Medical Degree/ Diploma admissions under Management Quota can exercise web-options from **08.00 AM on 25.01.2026 up to 08.00 AM on 27.01.2026**.

As per the candidates registration and eligibility for MQ-1, MQ-2 (NRI) categories, Candidates will have to exercise web options for the Post Graduate Medical seats as per their priority through <https://pvtspgmed.tsche.in> and allotments will be done accordingly.

NOTE: Candidates are informed that they will be considered only to the category / categories to which they have registered.

For eligibility criteria and regulations refer to notifications dated: 04.10.2025.

UNIVERSITY FEE:	Allotted Candidates have to pay the following University fee by way of payment gate-way through online and to download the allotment order. Candidates who have already paid University fee in the first phase of counselling, need not pay again. A) MQ1 Management Quota sub category 1: Rs.49,600/- B) MQ2(NRI category) and MQ3 (Institutional Quota): Rs. 69,600/-
TUITION FEE:	Tuition fee is to be paid at respective Medical colleges. The tuition fee payable shall be as notified by the Government of Telangana orders.

NOTE:

The details of seats available (seat matrix) in all Private Non-Minority & Minority Medical Colleges affiliated to KNRUHS & Neelima Institute of Medical Sciences, Ghatkesar are placed in the website <http://knruhs.telangana.gov.in> The candidates can exercise web options for PG Medical Degree/Diploma seats under KNRUHS through <https://pvttspgmed.tsche.in>.

INSTRUCTIONS TO CANDIDATES:

- 1) Eligible NEET-PG-2025 qualified Candidates as per the final merit list for Management Quota can exercise web options for Post Graduate Degree / Diploma seats in all Medical colleges as per their interest and priority for MQ-1, MQ-2 (NRI) categories (as per eligibility).
- 2) Candidates are advised to go through the Prospectus for the Regulations into PG Medical Degree/Diploma courses of KNRUHS, available on website before exercising web options.
- 3) Candidates exercising web options for PG Medical Degree / Diploma courses are informed that, there is no limit of choices (number) for exercising web-options, candidates can exercise options for any number of subjects and colleges the candidate is interested to join as per eligibility and registration.
- 4) Candidates are advised to exercise web options for PG seats into courses and colleges in which they are interested to join. If they are not interested to join in any subject or college then they should not exercise options for the same.

- 5) Management Quota MQ-1 & MQ-2 (NRI) seats into Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Management Quota seats in other Medical Colleges.
- 6) Candidates have to exercise web options for MQ1 and if eligible for MQ2 (NRI) category in order of priority for course and college. Allotments will be made according to the order of preference in the web options exercised by the candidate. Candidates have to exercise options very carefully as per their priority.
- 7) **IMPORTANT NOTE:** Candidates are informed that if they exercise web-options for a seat and allotted a seat as per their choice in the web- counseling and **if they do not join the course at the allotted college then they will not be eligible for exercising web - options for subsequent rounds of counseling to prevent seat blocking.**
- 8) Candidates can exercise web options through online from computer having internet facility.
- 9) Candidates are advised to exercise web options for PG seats in all courses and colleges in which they are interested to join irrespective of available seats shown in seat matrix, as vacancies will arise during counselling process due to sliding of candidates from allotted seats in first phase of counselling to other seats as per their web options in the second phase of counselling. If candidates are not interested to join in any subject or college they should not exercise web options for the same.
- 10) If a PG seat is allotted in this phase of counseling as per web options exercised by the candidate in this phase of counseling, the seat allotted in 1st phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore, the candidates are informed to exercise web options carefully for sliding with awareness of this fact.
- 11) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options).
- 12) Candidates are instructed to take a print out of saved options. Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to check their allotment status on portal/website

- 13) The selected candidates shall download the allotment order from website after payment of the University fee by gateway method by using Online payment method. (Debit Card/Credit Card/Internet Banking), check their allotment and report to the Principal of allotted college on or before the date specified on the allotment order.

- 14) Candidates are hereby informed that final verification of original certificates will be conducted at the college by the admission committee and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.
- 15) Selected candidates have to report at the respective colleges before the last date for joining as specified in the allotment letter, to submit all original certificates, relevant bonds and to pay the tuition fee / college fee to complete the admission process. If the candidate does not fulfill the above criteria to complete the admission process within the specified date the admission shall be cancelled automatically and the candidate will not be permitted to exercise web options for subsequent rounds of counselling as to prevent seat blocking.
- 16) If the candidate slides to other college during second phase of counseling, they have to get relieved from first phase joined college, collect original certificates, fees and report to the allotted college before last date of joining.
- 17) Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI relative in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at the respective colleges.
- 18) Original certificates will not be returned to the candidate, unless the candidate discontinues the course or slides to other college during subsequent phases of counseling.
- 19) **Allotment for MQ3 (Institutional quota) will be done after all the relevant sponsorship letters are received by the University from the Medical Colleges for Institutional quota.**
- 20) The University fee once paid shall not be refunded under any circumstances.
