This notification is issued for registration of the candidates to appear for MD/MS Ayurveda Second Summative Assessment Supplementary Examinations commencing from **04.05.2026**.

1) Eligibility to appear for MD/MS Ayurveda Second Summative Assessment Supplementary Examinations:

The MD/MS Ayurveda students admitted by the KNRUHS during the academic year **2024-25** whose admissions are approved by the University and completed study period with minimum **80% attendance** in each subject and minimum **60% Semester Grade Point Average (SGPA) in the Second semester** are eligible to appear for the examinations in May 2026 subject to the course regulations.

2) Before appearing for the second summative assessment, it is mandatory for the student to submit the synopsis.

3) The Cut-off date for calculation of attendance percentage of the students is up to 26.03.2026.

4) The uploading of the attendance and SGPA of the students is from 01.04.2026 to 04.04.2026.

5) The confirmation date for uploaded attendance and SGPA of the students is on 07.04.2026.

Digital valuation and providing only single answer booklet without additional answer booklet:

The University is a digital campus and implementing digital valuation for all courses. For MD/MS Ayurveda course, single answer booklet with candidate specific bar code on each page will be issued to the candidates appearing for examinations and no additional answer book will be issued to the candidates. The candidates should answer all the questions in the single answer booklet only.
