Synopsis for MD(Ayurveda) Courses – 2025–26 Admission Batch – Reg.

1. It is hereby informed that, as per KNRUHS Dissertation Guidelines, all students admitted to the MD(Ayurveda) **2025–26 batch** are required to submit their Dissertation Synopsis for approval and allotment of Dissertation Registration Numbers.
2. **Submission Timeline:** The synopsis must be submitted within six (6) months from the date of commencement of the course, i.e., on or before **31.07.2026** A grace period of two (2) months, up to **30.09.2026** will be allowed with a fine of Rs. 2,000/- in the form of Demand Draft in favour of "The Registrar, KNRUHS."

No submissions will be accepted after this period.

3. The Candidates shall submit the synopsis through the proper channel:
 - o Guide
 - o Head of the Department (HOD)
 - o Institutional Ethical Committee (IEC) approval
 - o The same shall be forwarded by the Principal in the prescribed excel sheet.
4. The same shall be duly forwarded by the respective principals in the prescribed format (Excel Sheet) & also individual synopsis in the form of soft copies i.e., Pen Drive to the O/o The Controller of Examinations, KNRUHS, Telangana, through Speed Post/ Special Messenger.

5. The Excel Sheet of dissertation topics, in the proforma enclosed with this letter shall be mailed to knruhsdissertations@gmail.com.
6. Students must refer to the KNRUHS website and review dissertation topics from the past three years to avoid duplication. The selected topic must not repeat previously submitted topics in the same speciality.
7. The students must submit an acknowledgement confirming:
 - Review of the past three years' dissertations.
 - The chosen topic has not been previously worked on in the same speciality.
8. **Change of Topic / Guide:**
 - Any change will be permitted **only with proper justification**.
 - Requests must be submitted **through the Principal to the University**.
 - Changes are allowed within one and half (1½) year from the date of commencement of the course.
9. A **fine of Rs. 10,000/-** is applicable for such changes in the form of Demand Draft in favour of "The Registrar, KNRUHS" after one year from date of commencement.
 - **No changes will be permitted after one and half (1½) year from the date of commencement of course.**
 - No change in dissertation topic or guide shall be made **without prior approval of the University**.

Note: All Principals are requested to ensure strict compliance with the above guidelines.
