This Notification is issued for registration of the candidates to appear for B.Sc. Allied Health Sciences First Year Examinations commencing from **13.08.2026**.

1) ELIGIBILITY TO APPEAR FOR B.Sc. ALLIED HEALTH SCIENCES FIRST YEAR SUPPLEMENTARY EXAMINATIONS:

The B.Sc. Allied Health Sciences First year students admitted by KNRUHS during the academic year 2024-25 whose admissions are approved by the University and completed study period and who are having **80% attendance** in each of the subjects and passed internal assessment examinations with **50% marks** and also the students of previous batch who have failed, detained and not registered for the previous examinations are eligible to appear for B.Sc. Allied Health Sciences First Year Supplementary Examinations in the month of August 2026.

- 2) The Cut-off date for calculation of attendance percentage of the candidates is up to **25.07.2026**.
- 3) The uploading of the attendance percentage and internal assessment marks of the candidates is from **30.07.2026 to 01.08.2026**.
- 4) The confirmation date for uploaded attendance percentage and internal assessment marks of the candidates is on **03.08.2026**.

Digital Valuation and Providing only single answer booklet without additional answer booklet:

The University is a Digital campus and implementing digital valuation for all courses. For B.Sc. Allied Health Sciences Courses, exam will be conducted with single answer booklet with candidate specific bar code on each page for the candidates appearing for examinations and no additional answer book will be issued to the candidates. The candidates should answer all the questions in the single answer booklet only.
