PROSPECTUS FOR ADMISSION INTO B.Sc. NURSING 4 YDC COURSE FOR 2026-27

1. REGULATIONS:

- A)** These Regulations are applicable for admission into Competent Authority Quota Seats in Government and Private Nursing colleges.
- B)** All the Candidates shall fulfill the regulations for admission into B.Sc.,(N) 4 years Degree Course for admission into Competent Authority Quota Seats.
- C)** The candidates are advised to take a print out of the prospectus / instructions to fill the application form from the website www.knruhs.telangana.gov.in before proceeding to fill the application form.
- D)** The Seat matrix for Competent Authority Quota seats into B.Sc Nursing 4 YDC Course at Government and Private Colleges for academic year 2026-27 will be displayed on the KNRUHS website before exercising web options for counseling.
- E)** Tuition Fee shall be as notified by the State Government.
- F)** In case any new BSc Nursing 4 YDC seats/new colleges are permitted by Authorities for the Academic Year 2026-27, those seats will also be filled up. No further notification will be issued.

A. Eligibility as Local Candidate

(as per G.O.Ms.No. 139 HM&FW(C1) Dept. Dated: 04-10-2024):

Nationality & Domicile: A candidate for admission into B.Sc. (Nursing) course under Competent Authority Quota in Telangana should be Indian National/Person of Indian Origin (PIO)/Overseas Citizens of India (OCI) card holder and shall fulfill the following conditions

- i) The candidate should have studied in the Educational Institutions in the state of Telangana for a period of not less than four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared in the relevant qualifying examination.
- or
- ii) Where during; the whole or any part of the four (4) consecutive academic years ending with the academic year in which he appeared or as the case may be first appeared for the relevant qualifying examination, he has not studied in Educational Institutions, he should have resided in the state of Telangana for a period of not less than four years immediately preceding the date of commencement of the

relevant qualifying examination, in which he appeared or as the case may be first appeared.

- iii) Further, in case the candidate has not studied in any educational institution and has resided in the state of Telangana as stated at (ii) above, to be eligible for admission into B.Sc. (Nursing) course under Competent Authority Quota, the candidate should have appeared for the relevant qualifying examination in the State of Telangana.

NOTE : Domiciles of other states are not eligible for Competent Authority Quota seats in the state of Telangana.

- B.** Candidates shall secure the following of cutoff scores or above in TG- EAPCET – 2026 to be eligible for admissions in accordance with regulations of Indian Nursing Council.

Cut-off score for B.Sc(Nursing) 4 YDC course:

- i. Eligible TG - EAPCET- 2026 qualified Candidates have to apply online and upload the original certificates in response to notification to be issued by KNRUHS. The merit rank notified after verification of certificates by KNR University of Health Sciences, shall be the basis for selection into B.Sc.,(N) 4Ydc course into Competent Authority Quota seats.
- ii. **EDUCATIONAL QUALIFICATIONS:**
- a. Candidates seeking admission into **B.Sc.,(Nursing) 4 YDC** Course should have passed 2 years Intermediate Examination (10 + 2 pattern) with 45% aggregate of

marks in Science (Biology, Physics ,Chemistry) and English is compulsory subject in 10+2.

Or

- b. Any other examination of (10 + 2 pattern) from recognized Board under AISSCE / CBSE/ ICSE / SSCE / HSCE / NIOS / TOSS of other equivalent Board with Biology, Physics and Chemistry recognized as equivalent by Board of Intermediate Education, Telangana state.

Or

Intermediate (10+2) Vocational with Bridge course with Biology and Physical Sciences.

- c. Those who belong to SC/ST and BC categories are eligible with 40% aggregate marks in the science group subjects (Biology and Physical Sciences). English is compulsory subject as per the norms of the Indian Nursing Council, New Delhi vide letter No.F.No.1-2/2014-INC and vide circular No.F.No.1-6/2016 –INC Dated: 21-09-2016.

Note: The Intermediate (TOSS) Candidates who have qualified in the year 2021 shall be treated as having minimum required percentage of marks at Intermediate level as prescribed by concerned authorities/Deemed to be Universities/other Private Universities recognized by UGC. vide reference: G.O.Ms.No.17 Dated:29.10.2020 and G.O.Ms.No.19 Dated:29.06.2021.

- C. AGE:** Candidates should have completed the age of 17 years as on 31st December 2026. No Upper age limit.

Note:

- i. Age shall be calculated on the basis of date of birth as indicated in the Secondary School Certificate examination or equivalent examination.
- ii. No request for relaxation of age of a candidate shall be permitted.
- iii. Candidates born on or after 02-01-2010 are not eligible
- iv. Student shall be medically fit.

2. RESERVATION OF SEATS FOR SCHEDULED CASTES & SCHEDULED TRIBES.

1. 15% seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Castes. As per G.O. Ms. No. 10, SCD(POA.A2) Dept., Dated: 14.04.2025 and as per Government orders dated. 16.05.2025, out of 15% of seats reserved for SC, 1% of seats shall be reserved for SC Group I, 9% of seats shall be reserved for SC Group II, 5% of seats shall be reserved for SC Group III. The Rationalization of reservations shall be followed as per the said G.O. and Government orders from the AY 2026-27

2. 10% of seats under Competent Authority Quota shall be reserved for candidates belonging to Scheduled Tribes as per G.O.Ms.No. 33, Tribal Welfare Department, dated.30.09.2022.
3. Candidates of the Scheduled Castes and Scheduled Tribes belonging to the State of Telangana for castes which are notified by the Government of Telangana from time to time shall be considered for reservations.
4. If the candidates from Scheduled Castes & Scheduled Tribes are not available these reserved seats shall be converted to open category seats and allotted on the basis of merit.
5. Reservation for the Scheduled Castes and Scheduled Tribes shall be considered for castes which are notified in the SC/ST caste list as per the Telangana Government orders only.

3. RESERVATION FOR BC CANDIDATES:

- a) 29% of the total seats under Competent Authority Quota shall be reserved for candidates belonging to Backward Classes and shall be allotted among the five sub - groups of Back Ward Classes as follows:-
BC-A-7%, BC-B-10%, BC-C-1%, BC-D-7% and BC-E-4%.
- b) Candidates who belong to the notified Backward Class castes of the States of Telangana which are listed in the Telangana State Government orders shall be considered for reservations.
 - i. If eligible candidates belonging to Backward Classes of a particular sub-group are not available, the left over seats can be allotted to the candidates of next sub- group ie., BC A to BC B to BC C to BC D to BC E.
 - ii. If eligible candidates of Back Ward Classes category are not available for the 29% seats reserved for them, the left over seats shall be converted to Open category seats and shall be allotted as open category seats on the basis of merit.
- c) While calculating the number of seats in the sub-groups if the total number of seats falls short of or exceeds 29%, it shall be limited to 29% by adding or eliminating the candidates on the basis of merit in the sub- groups in which the fractions were rounded to nearest figure.

CERTIFICATION OF CASTE:

- a) Scheduled Caste, Scheduled Tribe and Backward class candidates shall in support of their claim, have to furnish Permanent caste certificate issued by the Competent Authority of State Government.

- b) The social status of the candidates who have applied for the seats reserved for Scheduled Castes, Scheduled Tribes and Backward Classes shall be scrutinized as per the rules notified by the concerned department officials of Government of Telangana.
- c) The decision of the verification officer deputed by the Director / Commissioner of BC Welfare, SC Welfare and ST Welfare from the Government of Telangana is final in all respects.
- d) Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to Telangana State for castes which are notified as per the Telangana Government orders will be considered against the reserved seats.

4. RESERVATION FOR EWS CATEGORY :

10% of total seats under Competent Authority Quota are reserved for economically weaker section (EWS) category candidates who are not covered under the existing scheme of reservation for SC, ST & Socially and Educationally Backward Classes.

Candidates claiming reservation under EWS Category shall obtain the relevant latest EWS certificate valid for 2026-27 for reservation under economically weaker section issued by Tahsildar, who is the Competent Authority in state of Telangana for issue of EWS Certificate.

5. RESERVATION FOR WOMEN CANDIDATES:

33 1/3% of seats are guaranteed for women candidates in each category i.e., Open category, Scheduled Castes, Scheduled Tribe, Backward Classes Group A, B, C, D and E. This regulation of guarantee shall not be applicable if women candidates selected on merit in each category form 33 1/3% or more of the seats therein. When the number of women candidates falls short of this percentage, it would be made up by replacing the last selected male candidates by women candidates in that category.

6. RESERVATION UNDER PWD CATEGORY:

5% of total seats in each categories shall be reserved for the Persons With Disabilities (PWD) i.e., OC, SC, ST, BC-A, BC-B, BC-C, BC-D and BC-E categories as per Government of India guidelines.

The candidate seeking the benefit of reservation should present him/herself before a Medical Board constituted by the University, comprising
professors from

Government Medical colleges from relevant specialties. The decision of the Medical Board constituted by the University is final.

7. ONLINE APPLICATIONS:-

The on-line application form for determining merit position for Competent Authority Quota seats will be available on the website <https://tsparamed.tsche.in> from **9.00 AM on 16-09-2026 up to 05.00 PM. On 24-09-2026.**

Note: The candidates are advised to take a print out of the Prospectus / Instructions to fill the application form from the website <http://www.knruhs.telangana.gov.in/> or from <https://tsparamed.tsche.in> before proceeding to fill the application form.

The candidate should fill the online application form available in the Website with the data required for through computer or Laptop with data connection. The online application form can be filled through any computer with internet connection or Laptop. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) and ready to enter his/her correct data and upload the photo, signature and original certificates, after the payment of application fee through Online.

8. Registration and Verification Fee:

The Registration and Processing fee Rs.2500/- (Bank transaction charges extra) for OC & BC candidates and Rs.2000/- (Bank transaction charges extra) for SC/ST candidates shall be paid online through Debit card / Credit card or Net Banking.**

****Registration and Verification fee once paid will not be refunded or adjusted to a further date.**

In case of payment failure resulting in a subsequent successful payment (double payment), candidates shall submit their representation for refund of the failed/duplicate payment only through e-mail to **knruhs.doublepayments@gmail.com**. Upon verification, the amount received through the failed/duplicate transaction, if any, shall be refunded to the candidate's bank account by following due procedure only after the closure of admissions.

Note: The process of admissions into B.Sc. (Nursing) 4-YDC course will be in accordance with the rules issued from time to time by Indian Nursing Council/Government of Telangana and Rules and Regulations of KNRUHS.

9. CATEGORIZATION OF SEATS:

- i.** Sixty percent (60%) of the total number of seats in Private institutions shall be filled as Competent Authority Quota seats by University.
- ii.** Forty percent (40%) seats shall be filled as Management Quota seats by the Managements of Private Colleges.
- iii.** In respect of the Government colleges 100% seats shall be Competent Authority Quota, will be filled by the University.

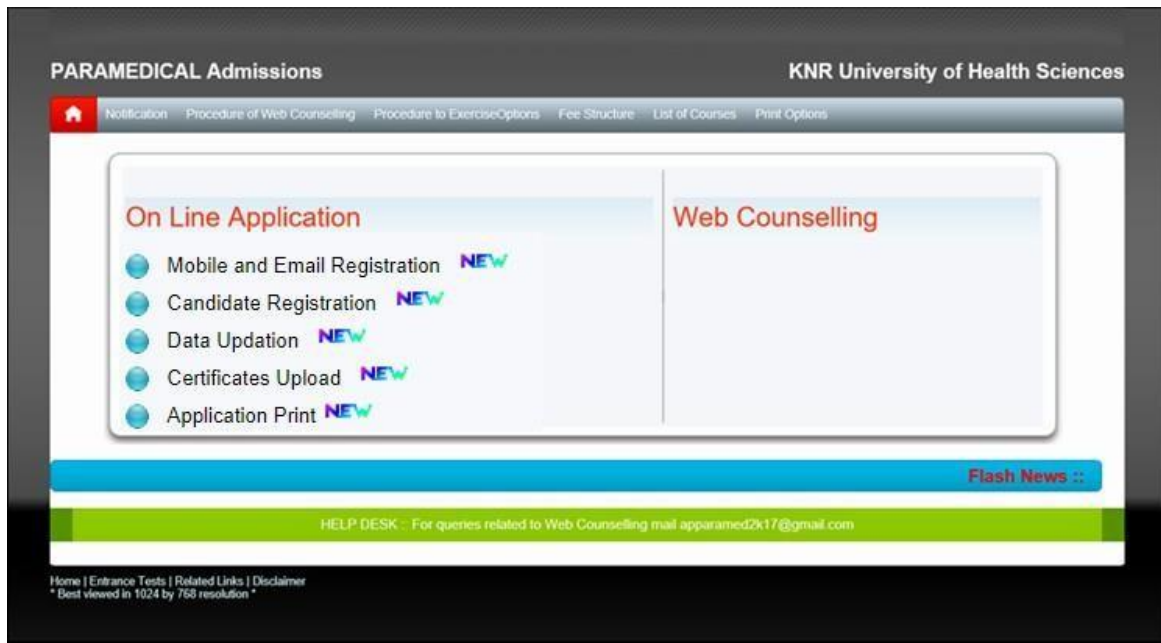

10. MERIT LIST:

The provisional final merit position of applied candidates for competent authority quota seats shall be notified after verification of uploaded certificates.

The provisional Final merit list shall be prepared by the Admission Committee appointed by University subject to these regulations.

The criteria for preparation of merit list (B.Sc. NURSING COURSE)

The Merit list will be prepared in accordance with the TG – EAPCET – 2026 Rank

11. PROCEDURE OF SELECTION:

Selection will be made by the Admission Committee appointed by Vice-Chancellor, KNR University of Health Sciences based on the web-options given by the candidates and their merit.

Selections shall be made local area wise as per the Rules of Admission as notified in G.O.MS.No. 139, HM & FW (C1) Department, Dated: 04.10.2024, G.O.MS.No. 39, HM & FW (C1) Department, Dated: 18.04.2022 G.O.MS.No. 18, HM & FW (C1) Department, Dated: 02.02.2023 and G.O.MS.No. 95, HM & FW (C1) Department, Dated:14.07.2023 and subsequent amendments.

- a. The Selection Committee will allot a candidate seat to the Nursing College based on their web-options and merit.
- b. Selected candidates will receive the allotment message on the registered mobile number after allotment of seat. Candidates are also directed to check the website for allotment list after exercising web-options.
- c. Selected candidates have to download the allotment order on payment of **University fee of Rs. 6,000/- (Rupees Six thousand only)** besides payment gateway charges through payment gateway and report to the Principal of concerned college along with all Original Certificates and pay the tuition fee as notified by Government at the college to complete the admission process.

12. ADMISSION RULES

- a. The letter of allotment for admission of selected candidate will have to be downloaded from website after payment of University fee by payment gateway.
- b. The candidate should submit the print-out of the filled-in Online application form, allotment order and original certificates along with (1) set of self-attested copies to the Principal of allotted college at the time of joining for final

verification by the Admission Committee constituted at each college. The Admission Committee is responsible for scrutiny of the original certificates submitted by the candidate. In case of any discrepancy, the provisional allotment order for admission will be cancelled.

13. Selected candidates have to join the college within the specified date by submitting all Original Certificates, and pay the tuition fee as notified by the Government to complete the process of admission. If the candidate does not report within the specified time and complete the process as described before the admission will be automatically cancelled.

Discontinuation fee: Candidates willing to discontinue the course shall have to pay discontinuation penalty of Rs. 20,000/- (Rupees Twenty Thousand Only) through Demand Drafts in favor of the Registrar, KNRUHS, Warangal, as per circular of KNRUHS No. SPL/Acad/Allied and Health Care/AC6/KNRUHS, Dated: 25-07-2025. Candidates will have to submit discontinuation bond for the same if they discontinue the course after the last date of admissions.

14. **COMMENCEMENT OF THE COURSE:** The course shall commence as per the schedule notified by Indian Nursing Council. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.

15. **College Regulations:** Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Candidates are informed that their correspondence with the University shall be forwarded by the Principal of college with his remarks (through proper channel) for consideration. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal

16. **CLOSURE OF ADMISSIONS:**

The admissions shall be closed as per the schedule notified by the University and as per INC Regulations.

Any vacancy after the date of closure of admissions shall not be filled. They shall not be carried forward to the next year.

17. POWERS OF THE PRINCIPAL OF THE INSTITUTION:

Not with standing anything contained in these Regulations, the Head of the Institution may at any time, either su-moto or on an application made by any person after due and proper enquiry, if satisfied that the candidate has furnished incorrect information or enclosed false certificates or fraudulently obtained admission may for the reasons to be recorded in writing, by order cancel her admission provided that no such admission shall be cancelled without giving a reasonable opportunity for showing cause as to why his/her admission should not be cancelled.

Against any such order of the Head of the Institution, an appeal can be made to the Registrar, KNR University of Health Sciences.

18. POWERS OF KNR UNIVERSITY OF HEALTH SCIENCES:

The University may either su-moto or on an application made to University can call for and examine the records relating to any selection or admission or cancellation thereof made by the concerned authority for the purpose of verifying the correctness, legality or propriety of such selection or admission or cancellation and pass such order in relation there to as KNRUHS deems fit, including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation.

19. UNIVERSITY IS THE FINAL AUTHORITY OF SELECTION PROCEDURE:

All selections made under these regulations shall be subject to such directions or orders as may be made by the University from time to time.

20. SANCTION OF LEAVE BEYOND (3) MONTHS AND TERMINATION OF STUDENTSHIP:

- a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals). If a student absents continuously for a period of (91) days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and be permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a

continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.

- b. If the break of study (91 days or more) is in more than one spell, the candidate's application in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.
- c. Candidates, who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission into the course and the studentship stands cancelled without any further notice.
- d. The candidate has to pass within the final examination for award of Degree for the course double the duration of study period for the course or within the maximum period permitted by the Indian Nursing Council from time to time.
- e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course".

21. TIME FOR COMPLETION OF COURSE:

Candidate should complete the course within the duration equivalent to double the period of course of study .i.e., **8 years for B.Sc 4YDC.**

22. MIGRATION/TRANSFER:

No Transfers during the course period are permitted from one college to another college under any circumstances.

23. DISCIPLINE:

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University either before the print or electronic media. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities/ INC/Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.

24. RAGGING:

Ragging is prohibited in the Educational Institutions of State of Telangana and students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per law.
